 Notice of Motion – this an amendment to the previous motion placed in the March Reel Talk by Peter Osborne – to read

Competition Rule 2.3.2 Numbers of Fish and Field Day Bag Limit

Delete the following sentences from para 3.

A maximum of one day's bag limit of a particular species as specified by Department of Fisheries WA Regulations can be weighed in for the Field Day. Members may capture any number of fish within Department of Fisheries WA Regulations for their personal use.

Replace with the following:-

A maximum of 1 (one) day's bag limit of any individual species as specified by Department of Fisheries WA Regulations may be weighed in for the Field Day.

A maximum of seven (7) fish of the Category 1, Highest Risk Species may be weighed in. This will require captures to be spread over 2 or more days where the "mixed daily bag limit" is less than seven (7).

A maximum of one (1) "mixed daily bag limit" for each of the Category 2, Medium Risk Species and the Category 3, Lowest Risk Species may be weighed in, subject to the maximum of 30 fish.

Members are responsible for complying with the maximum individual and mixed daily bag limits as listed in the Recreational Fishing Guide for the Region being fished. Members may capture any number of fish allowed by the Regulations for their personal use.

General Business

<u>Peter Pekaar</u> – 112 gram open in the April Dry Casting Day and I would like to thank everyone for scoring on the field

<u>Vix Alexander -</u> enquires about the Blankets at Wallaroo.

<u>Malcolm Harris</u> talks about the Recfishwest Website Casting around the Internet on their Website there is a link to a free magazine.

<u>lan Cook</u> - Gary Gildersleeves is our top Caster in double handed accuracy and back in 2008 Gary had a score of a 176 double handed accuracy as a Veteran and this one from 2003 is slightly out of date, had a score of 171. Certificates were handed to him. The Rods are at the depot and will leave tomorrow, they will be in SA Tuesday next week. Also, the grant money that we got bought us a new generator. Ian gave the Members a summary on the new icom hand held radios - they have a range approximately 9 km.

Terry Fuller – a summary on the Time and Tides on Field Days as follows:

Mr Chairman

I would like to raise two related topics from recent discussions.

I have chosen the words in this very carefully so they should not be misunderstood or turned into something they are not.

The first is defining the height and time of "suitable" tides for Field Days, specifically at Rottnest, but possibly other venues too.

The second is what "duty of care" does the club have to its members in <u>scheduling</u> "safe" Field Days.

Note:- there is a really big difference between **scheduling** field days, done up to a year in advance with limited information apart from predicted tides, and **running** field days on the days when the interactions of wind, swell and tides and anything else, are known for the potential fishing spots on those days.

Height and time of "suitable" tides for Field Days

Committee members will be aware of some recent emails, however I will cover some of the points in them for other members.

Firstly let me make it crystal clear – I was <u>never</u> and I am <u>not</u> trying to change the decision not to have a May 2009 Rottnest Field Day, and even though I thought that was very clear, it still seems to have been misunderstood.

I am only trying to clarify and document some points so that this sort of discussion can be done professionally and consistently in the future.

October/November 2009 tides/dates

The February Reel Talk page 19 says "The only suitable tides in October or November are on the 10–11 October"

Now those two words <u>"only"</u> and <u>"suitable"</u> really get me going. I don't like spin, I don't like potentially misleading statements, and I'm suspicious whenever statements are made without giving the facts behind the statements, when it would be so easy to give the details. And sometimes a quick check show questions, as in this case.

Anyone reading that February Reel Talk would certainly believe that the Field Day <u>HAD</u> to be shifted from the normal October weekend after the General Meeting because the tides were **"unsuitable"**.

And since that followed the sentence "The tides for the May Field Day (Rottnest) are too high to allow safe fishing both in the morning and afternoon" some people might believe that the tides on the normal weekends in **BOTH** October and November were **ALSO** "too high to allow safe fishing both in the morning and afternoon"

I asked in the emails for someone to please say what is "unsuitable" about the tides on the normal "weekend after a General Meeting" days for both October and November which were rejected, but that request was ignored, instead there were some comments completely off the topic.

Yes, I can see that the October weekend chosen has lower tides and so would/could be "better".

<u>To prevent similar problems in future</u>, I believe the Club must define the terms used "suitable" and "safe." What maximum tide height? Which times have priority, morning or afternoon? Are dawn and/or dusk included?

This is all so there will be some objective "acceptable" and "safe" tide height and times proposed or set which members can debate and discuss and agree on. If not, why not?

Club's "duty of care" when scheduling field days

I had used these words in my email: "members expect to adapt their fishing places and times to the conditions" on the normal fishing day and that includes wind and swell which are not defined/known in advance.

One of the comments in the emails was "the club has a duty of care to make sure that all field days are conducted in such a manner as not to place any member in a hazardous position"

This looks very reasonable, however the club has no <u>real</u> control over members' decisions on what is safe or unsafe for them at the time, considering the conditions and <u>their</u> abilities and <u>their</u> experience. Personal safety should always be the responsibility of the individual.

Again, note the difference between <u>scheduling</u> field days in advance and <u>running</u> (or <u>conducting</u>) field days on the day.

And yes, I DO recognise that some members expect Rottnest field days to give them good access to the reefs at Radar, etc, and so Rottnest may need special consideration.

This all raises some very fundamental questions, so I suggest that the Committee draft clear guidelines and statements, for discussion and acceptance by the members, covering:-

What "duty of care" the club has with respect to tides and any other predictable factors in *scheduling* field day dates and locations.

If tides are to be a factor, what predicted tide heights and times are acceptable or unacceptable.

What commitment the club has to <u>scheduling</u> field days on the pre-defined weekend after the General Meeting, apart from long week ends.

Bluff Creek Field Day Report

Saturday February 28 to Monday 2 March

Morris, Ian and Greg decided to get an early start as did Lea, and went down to Bluff Creek on the Thursday morning. It was a great drive with good weather and little traffic. On arriving, the seas where calm, emerald green with light winds and pleasantly warm, **Idyllic**. Camp was set up and some quick reconnoitering done.

Friday, Morris and Ian fished the reef to the west of camp in the morning with only a few fish caught. In the afternoon Lea and Ian fished the reefs around the headland at the eastern extremity of the beach. Lea used a light rod and slices and achieved a lot of hook ups but could not lift them up the rocks on the light gear. The attrition rate of the small chrome slices was rather high so he gave up after a couple hours. Most of the members turned up during the day and set up camp. The "Hansen Taj Mahal" was erected using one of Peter Stoeckel's <u>Cast Off</u> truck tarps. Big hint Peter!

lan smoked some of the skippy and herring caught during the day. They must have been rather palatable as the plate was empty very quickly.

On Saturday, members fished over a variety of locations along the beach with mixed results. We had to work hard for our catch. The weather forecast was for rain on Saturday night and it was correct. The weather came in from the south-east with wind and very heavy rain. Thunder and lightning was of Biblical proportions.

Peter and John tried to get their adrenaline and pulse rate up when they had the Nissan Patrol slew round sideways on the edge of an embankment drop off (1 metre) whilst attempting to drive up into the dunes off the beach. I heard that the only option was for Peter to drive down the embankment and then cross fingers that he could get back along the beach. I heard rumours that the extra grunt required was supplied by our South African members' rugby training. The outlook for fishing on Sunday morning was rather bleak with rain and wind. We had some particularly spectacular lightning displays over the period, including some horizontal lightning.

The area where Mal, Vix and lan's tents where set up started to become a small lake. When it reached about 40mm Mal started digging the "Panama Canal" to let the water escape onto the track running past camp which was, luckily, at a lower level. Surprising how many people came to dig and play mud pies. The weather improved during the morning and the lunch time barbecue was a great social gathering. There was some reluctance by certain people to leave the dry conditions of the "Taj Mahal" to battle the elements. Again, you had to work hard for your fish. It rained and blew again over night.

Monday morning had some intrepid members fishing prior to the weigh in. Mark caught all his fish on soft plastics over the weekend. This demonstrates the philosophy of keeping your mind open to new methods. It was then decamp and pack up. Dismantling the "Hansen Taj Mahal" in the strong winds was a combined exercise of Mal, Vix, Ian, Morris, Greg, John, Lea, Mark, Wendy. Thanks guys and girls.

The club's new Honda Eu 20 generator ran the camp with about six 12-volt fridge/freezers and light for the four days on about 30 litres of fuel. It is remarkably quiet and at one stage when it was bucketing down rain on the Sunday, we had it under the kitchen table in lan's camp area. The new Icom hand held radios will work over approx 8 km line of sight. Dave George and Terry stayed at Bluff for an extra day and came back Tuesday.

It was, overall, a good field day with reasonable bags caught.

Competition Rule 2.3.2 Numbers of Fish and Field Day Bag Limit **Delete** the following sentences from para 3.A maximum of one day's bag limit of a particular species as specified by Department of Fisheries WA Regulations can be weighed in for the Field Day. Members may capture any number of fish within Department of Fisheries WA Regulations for their personal use **Replace** with the following:- A maximum of 1 (one) day's bag limit of any individual species as specified by Department of Fisheries WA Regulations may be weighed in for the Field Day. A maximum of seven (7) fish of the Category 1, Highest Risk Species may be weighed in. This will require captures to be spread over 2 or more days where the "mixed daily bag limit" is less than seven (7).

A maximum of one (1) "mixed daily bag limit" for each of the Category 2, Medium Risk Species and the Category 3, Lowest Risk Species may be weighed in, subject to the maximum of 30 fish.

Members are responsible for complying with the maximum individual and mixed daily bag limits as listed in the Recreational Fishing Guide for the Region being fished. Members may capture any number of fish allowed by the Regulations for their personal use.

Recfishwest report for Surfcasters General Meeting 11 March 2009

1. Closure of Swan and Canning Rivers to Commercial Fishing

Fisheries Minister Norman Moore has announced he will finalise the ban on commercial fishing in the Swan and Canning rivers and will soon commence negotiations to buy out the last commercial operator. This is potentially a great outcome for recreational fishing and crabbing.

Unfortunately, because of reporting restrictions under the Fish Resources Management Act for the limited number of commercial fishers, no information is publicly available about what amount and species of fish and crabs are caught. However in the past Recfishwest has been concerned about the high percentage of crabs caught commercially and the effect of netting on other recreational fish species such as mulloway.

You may have seen some newspaper articles about this closure "stopping people's access to buying Swan River blue manna crabs." The total commercial catch of blue swimmer crabs taken in Western Australian waters during 2005/06 was 896 tonnes, including 72 tonnes from the Peel/Harvey estuary. There are some concerns the Mandurah area commercial catch has increased in recent years.

2. Big Marine Sanctuaries Urged For WA

A new collaboration of Australian and very well funded international conservation groups has urged the Federal Government to establish marine sanctuaries covering at least 20 to 30 per cent of each marine habitat in big expanses of the ocean off WA, including nominating some areas of great importance to fishing, such as the Rottnest trench game fishing area. This has been without any consultation with WA recreational or commercial fishing sectors.

The full "Big Blue Backyard report" has some enormous emotive images (some cuddly, some not cuddly at all) and is a very clever, sophisticated campaign with a model relying on the gloss and quasi-science that sounds plausible but may not all be relevant or deliverable. Be prepared for a creeping campaign designed to capture the general public, on a "that sounds fair enough" basis. TV advertisements are already running on this. Then could come the political lobbying, threats of legal action under "international covenants," "endangered species" and the like. The Commonwealth's Marine Bioregional Planning process has defined consultation processes which includes all stakeholders and recognises the importance of all ocean users and coastal communities and actively engage them in the marine bioregional planning process, but this campaign is part of the political lobbying attempting to influence the outcome outside that process.

3. Maximum Size Limit For Whaler Sharks

The West and South Coast fishing guides have not been updated yet but a new 2 page brochure is available from http://www.fish.wa.gov.au/docs/pub/WhalerSharkLimit/index.php?0102

Recfishwest has backed the new laws, but believe recreational anglers are "paying a bigger price" than commercial fishers for depleted stocks, and are not convinced the law would actually benefit shark numbers.

There are three particular species that are at risk and it's the commercial fishing sector which is responsible for the over-exploitation of those. We're not sure why the recreational sector has to be prohibited from taking 17 species when we didn't have any impact. We understand the principle but we think it would have been better done through an education process.

The Dept of Fisheries has responded saying "the few commercial fishers exempt from the bans fished from among the most sustainable shark fisheries in the world."

It is fascinating the claim we now have the best managed shark fisheries on earth only a few years after finally acknowledging sharks were being seriously overfished by commercial fishermen and being forced to drastically cut the commercial catch. If the "State of the Fisheries" report was actually released with up to date information, the public would be able to check some of these claims.

Also fascinating that they believe recreational fishermen are too stupid to tell the difference between sharks, but are smart enough to learn a completely new way to measure sharks.

4. Rous Head reclamation and the North Mole

Recfishwest has given its in principle support for Fremantle Ports proposed redevelopment works on the proviso that they considers the following aspects to provide access for recreational fishers;

- Continued access by recreational fishers to the outer wall of the harbour. This area is a highly valued shore based fishing location allowing people to fish in deeper water.
- Designated fishing platforms in several places, for disabled people, children and people who are not physically able to clamber over rocks. Adequate car parking and lighting also at fishing platforms.
- "fisherman-friendly" and safe rock walls where the rocks are carefully placed to give enough flat and accessible spots to stand and fish.

5. Cockburn Sound Crabs

Recfishwest will be involved with deciding the fishing arrangements for Cockburn Sound Crabs later in 2009. The Department of Fisheries has now acknowledged that commercial crabbing under the previous commercial management rules is unsustainable in Cockburn Sound.

6. Recfishwest Membership

Recfishwest is the peak body representing the interests of recreational fishers in Western Australia. Last year when the organization was under threat, recreational fishers supported Recfishwest, but we need you to continue that support.

Decisions to be made in 2009 will affect future fishing opportunities for your children and grandchildren. Recfishwest intends meeting these challenges and assures you that we will be the most effective vehicle for getting your views heard in this crucial year.

Recfishwest is **your** public voice whenever decisions which affect our fisheries, or access to them, are being made. We want you to become a member of Recfishwest or to renew your membership. Membership costs only \$20 a year per person, \$40 for families and \$10 for seniors.

UPDATE ON WEBSITE

Here is a report on the update of the Surf Casting and Angling Club website. New pages were uploaded to the working website from 4:15pm Thursday 12 February. Copies on CD will be provided.

- Obvious out of date information such as previous Committee member names, timetables, previous year's calendars, etc, and links within all other pages which lead to that information have been removed and replaced with a link to the page listing the latest Reel Talks.
- 2. Link to "Surfcasters Message Board" has been removed from all pages. It is not used or monitored.
- 3. Intelligent counters and usage recorders added to all the over 800 pages so that any future actions on web pages can be based on actual data and records of usage. See some preliminary info below.
- 4. Updated or removed all dead links from all active pages. At present, I have left unused/unlinked pages, images and files on the website server, because some of these are still being accessed by search engines or from forum posts. If removed, these would give people the "404 Page Not Found" search page.
- 5. Basic page layout and display configuration has been moved from the individual pages to a single common configuration file.
- 6. Added the "bordered" left menu, page heading, bottom menu, common appearance and operation to all pages including all the photo album pages, so that ALL pages are consistent in display and operation and are uniquely identifiable with the Club.
- 7. Revised the externally hosted photo albums so that access to and use of these images can be monitored and recorded in the statistics.

- 8. Restored the contents and thus the meaning and usefulness of the What's New page. The record of some changes since 2006 appear to have been discarded and not all are recoverable without some effort.
- 9. Checked the configuration and the operation of the "Search" function from each page it is shown.
- 10. Set up the Search server to regularly index and use all pages and changes made to the website.
- 11. Updated the fees in the membership fees page.
- 12. All pages have a visible comment "Display of this page was updated on 12 February 2009, contents updated as above" so all pages have a recent date on them even if the actual contents are some years old.
- 13. Changed the printing configuration so that unnecessary menus are not printed and waste space on the pages. This action is controlled by a single configuration file used by all active pages.
- 14. Started monitoring and saving copies of counter, tracker, usage and search information for possible future analysis and use.
- 15. Revised the "Site Map" page's listing of pages/main sections on the website added a description of the operation of the web pages.
