## Club Membership Fees are Overdue.

No results, so no changes to print. But it's a good bet that Tony D'Alonzo is number 1 on the list.

## Dry Casting Report, 7 July 2002.

Listening to the forecast for Sunday, we all got out our wet weather gear and waterproof boots and got ready for some "wet casting".

But whoever organised the weather did a magnificent job. Sunday dawned cool, with some clouds which looked like they held light rain, but stayed sunny and breezy for much of the morning. And the breeze was a good westerly, coming from behind us instead of all those head winds we have had for so many months. The breeze was great for the distance events, but added some challenges for the accuracy. But the grass was dry, so we didn't have to keep wringing the water out of our accuracy pom poms, like we did on the dewy morning in June.

Just check out those distances! Chas Riegert and Nick Allsworth each threw 112 grams 175 and 180 metres, which were new club records. Six casts were 169 metres or over.

Chas threw 56 gram 169 metres and five 56 gram casts were 150 metres or over.

Despite the wind, there some bursts of good results in the accuracy. Tony and Terry were marking some of the veterans double handed accuracy, and all scores for casts at one target were 17 or over. Terry immediately proposed a quick change to the rules similar to the "catch and release" fishing rules, and asked if he could be credited with the average of everyone else's cast - but no go. His first cast was a 17, helping to keep up the average, but the second cast was "only" a 14, so dragged the average down. Lots of good natured ribbing about that.

Once again we had several visitors and new members looking for dry casting tips and tuition, and thanks to George once again for all the effort in looking after them. One visitor came all the way from Three Springs after reading about dry casting in the AAA articles in the West Coast Fisherman, and others came from the AAA clinics, and have since applied for club membership.

Some of the 112 gram weights were burying themselves 150mm into the soft grass. Weights with short plastic tubing were very hard to find, since only a little bit of the tube was visible. Please make sure all of your plastic tubes are close to the maximum length of 250mm. It's also very hard to see these as they come through the air.

If you are marking for accuracy, you need to stand well clear of the target, to give people the chance to score even if their cast is right on the edge of the circle. One of TerryF's single handed casts caused Mal to raise his arms and jump out of the way, and Terry to jam on the finger brakes harder than he was already doing. Still, we are not playing for sheep stations.

Keep it straight and long.

Well, here we are again boys. I want to thank everyone who attended the last field day for putting up with (a) no fish, (b) sunburn, (c) rain, (d) the Secretary's dirty tactics in trying to win the competition and (e) Dudley Brown's swearing after he lost a large rock, which he claimed was a fish.

Well, the competition was a kicked off at 4 p.m. Saturday and although three bods did the dirty and fudged half an hour, the start was even. By the time dusk had set in the total was 1 tailor to Bill Bridger and 1 to Bill Griffiths, both were stretched and weighed 1 lb each. Ian Edwards had 1 Rocky and 1 Johney - half pound each.

That night Nelson Smith had a run, but as that worthy was in a cave eating, the Secretary did a dirty act and pulled the bait off his line and put his own in the hole where the bite occurred and was rewarded by a 2 lb Gurnard. (Something ought to be done about the Secretary).

Bill Griffiths was very unlucky in losing a fish (probably a Jewie) which was estimated at between 40 and 50 lbs, by two reliable witnesses. Bad luck Bill. Bill, Dudley and the Secretary fished all night and got no fish. Here I must protest about Dudley and warn all Club members who contemplate accompanying Dudley on an all night trip; the cow talks all night, and even digs one in the ribs with the gaff to keep his attention when you try to drift off to dreamland.

Daylight brought a very low tide and the reef resembled St. George's Terrace on a Friday.

From every car, truck and cave poured sleepy eyed pole and lead slingers, who, after putting one toe in the water and shivering for five minutes, braved the giant two inch waves on the reefs in the hope of a unwary fish.

After three hours and no fish the boys were very disappointed and although some fish were caught they are not worth mentioning. Some people have no pride, but I won't tell on you, Peter.

Since dawn, Felix of the Hollywell Tribe, had been spinning on the reef and after trying to catch a eight legged creature called on Octo Cat, (not to be confused with the Octo Puss), by using a spinner and spending half an hour looking for both afore mentioned, he gave up and returned to shore, muttering in a strange tongue, called Aus-Tralien, and going crook in general about an eight legged B that hides in holes and pinches spinners.

It was all very distressing to witness and after a lot of talking to, Felix was persuaded from blowing both Octo Cat and Point Peron off the face of W.A.

Well, up to lunch, only small rock fish were caught, and although the Secretary was ambitious in trying to get a 20 lb Buffalo Bream on a 6 lb line, the fish broke him up inside five seconds flat. There will be a good gallery; also the Press will be in attendance, so a good roll up is expected. Be in it, boys.

## **Busselton Jetty**

In early July, the State Government announced a \$500,000 grant for an access building to be built above the underwater observatory. The \$2.5 million underwater observatory for viewing is expected to be completed by March 2003.

## **Dredging in Owen Anchorage.**

The appeals against the proposals to dredge shellsand from Owen Anchorage for the next 30 plus years have been heard.

Environment Minister Dr Judy Edwards rejected Cockburn Cement's proposal to dredge 168.5 hectares of sea grass, instead limiting the company to just 53 hectares. The dredging will occur primarily along the alignment of the existing shipping channel and along the alignment of the proposed second shipping channel. The company will be required to stop dredging in the inshore areas within a maximum of 8 years, with a target of 6 years.

Government had also secured from Cockburn Cement a number of further commitments to address a range of environmental concerns in Cockburn Sound. This includes, most importantly, a commitment by the company not to dredge 2,800ha of inshore areas of Owen Anchorage, including 895ha of sea grass.

The Minister for the Environment and Heritage has supported the EPA's recommendation to place seagrass areas in marine reserves to provide more secure conservation of remnants in the Cockburn Sound and Owen Anchorage areas through the northward extension of Shoalwater Islands Marine Park. Cockburn Cement has agreed to provide funding to a total value of \$300,000 over a 3-year period to contribute to a number of programs that have been identified as integral to the development of environmental management and implementation plans for eastern Owen Anchorage.

Claimed to be the first spinning reel developed strictly for offshore fishing, the Van Staal VS400 is said to offer many value added features that are required for bringing in the big game. It has a large spool, double manual line pick up system, (that's **two** manual pick ups, rollers, etc.) and a lever drag system with precise strike setting indicators and strike stop adjustment. It's manufactured using only the best metals, titanium, stainless steel and aircraft grade aluminum.

Ratio 4.6:1, Line capacity 800 yds / 80 lb, (yes!), lever drag, weighs 48 oz, cost a mere \$1899US, that's about \$3500 Australian at the current exchange rate, spare spool a snip at \$373US or \$680 in real money. I hope your Father Christmas is well heeled.......

It looks a million dollars with it's gold colouring. I wish I could publish the photo in colour, because as in the Reel Talk article from 1952, you would be able to see that this certainly is "a reel which is fashioned of strange metal and of a great shininess". #### Wetline Commercial Fishing Management Review.

We have been waiting a long time, and on 11 July, Fisheries Minister Kim Chance announced plans to review the management of the 'wetline' or open access sector of WA's commercial fishing industry.

The Government will start by consulting with key stakeholder groups such as the West Australian Fishing Industry Council and Recfishwest on the process and timelines for developing future management arrangements.

The 'wetline' fishery is open to any holder of a fishing boat licence or commercial fishing licence and entitles them to unrestricted access to a wide range of species. Between 350 and 400 fishing boat licensees do 'wetline' fishing. Includes the use of hand lines, drop lines and hand-hauled netting.

The management of the 'wetline' fishery will mean that almost all WA's commercial fisheries will, in time, be brought under management plans. 'Wetline' management would ensure that commercial catches of fish such as dhufish and snapper on the West Coast continued to be managed sustainably.

"I am very proud of the quality of our commercial and recreational fisheries and am strongly committed not only to ensuring that stocks continue to be fished sustainably, but that a balance between community and commercial use of our fish stocks is maintained," he said. "In short, the review process will decide how the commercial 'wetline' fishery will be managed and who will be able to operate in the fishery."

Mr Chance said the process would not decide what share of the total finfish resource the commercial sector would have. This is a separate issue to that currently being examined by the Integrated Fisheries Management Review Committee headed by Justice Toohey. There had been strong support from all key stakeholders to start implementation of 'wetline' management ahead of the committee's report.

The Minister warned that should the balance of the fish catch between competing sectors shift prior to the specific allocation between the commercial, recreational and other sectors was addressed, he would not hesitate to limit catches in that particular sector in the short term.

That can only be interpreted as a warning to commercial fishers not to get in for the chop while they can. Let's hope the warning is followed up with action.

The Chairman of Recfishwest, Mr Norman Halse said that such a review was long overdue and congratulated Mr Chance for recognising and acting on the need. He explained that Recreational fishers were particularly interested in the management of the commercial 'wet fish' fishery because fish species caught by commercial fishers were generally the same key species targeted by the recreational sector.

## Why Join a Fishing Club?

Here are some selected comments from the Western Angler Fishing Forum on the benefits or otherwise of joining a club. Would like to think these apply to this club also. That's up to all of us as members – you get out what you put in. You often get some "anti" answers in such discussions, but they didn't appear in this set of messages.

"Joining a club has been best the thing I ever did. I have learnt tenfold off the members from their experience. Clubs are institutions and are wonderful for seniors and junior anglers alike."

"A very important thing to remember is that Fishing Books, videos, web sites, TV shows and the like are only a supplement for fishing. They can demonstrate, teach, and keep you going until the next trip, but when you are actually fishing is where you learn the most, and have the most amount of fun at that." (Could add dry casting to that and not get too many arguments from anyone who's actually tried it.)

"In a club the more diverse the background, the better. It might sound strange but it is important to understand yourself a little before deciding on a club. If you join the wrong club you'll hate it and think the club thing is a waste of time from then on. Be honest about your fishing activities. You may be able to walk the walk for a while, but eventually you'll lose respect and interest that's no fun."

"Our club has a wide range of anglers with extraordinary skills and talent who fish a variety of places and methods. Some things you learn with them that you may have never come across in literature. Fishing is so diverse and I wouldn't pretend for a minute to know 1/50th of it."

#### **Proposed Blowholes Fish Habitat Protection Area.**

Fisheries Minister Kim Chance was asked by the Blowholes Protection Association Inc to consider the future declaration of a Fish Habitat Protection Area (FHPA) during a visit there during June.

Mr Chance had been impressed by the Association's strong custodian role over the reef area and would ensure the request was researched and considered. "The Blowholes is a valued recreation area for the Carnarvon community and a popular destination for WA tourists and visitors from interstate and overseas," he said.

"The establishment of an FHPA will lay the framework to manage the human activities within the area, minimise their impacts, protect and rehabilitate the aquatic habitat of the Blowholes area. It also encourages community stewardship by involving the local community in its management, which is something I am keen to pursue."

The Minister said preparation of a draft management plan for an FHPA involved considerable consultation with the local community as extensive information was gathered on the specific environmental, social and cultural values of the area.

The area had been heavily targeted by coral, rock and other collectors in recent years and restrictions on these activities were announced recently. As far as I know, recreational fishing was not an issue, but may get some restrictions as a result.

## Pilchard Stocks Recovering Gradually.

In June, Fisheries Minister Kim Chance announced an increase in the quota for pilchards for the South Coast 2002/3 season.

Regular monitoring of the fishery along the south coast over the past four years had indicated good numbers of healthy fish, but it was important not to place too much pressure on the recovering pilchard fishery.

"The Advisory Committee recommended a gradual increase in total allowable catch for the next fishing season, particularly for the two Albany zones on the south coast," he said.

The total allowable catch for the Albany zones for the season will be set at 909 tonnes. Bremer Bay is allowed 1,230 tonnes and Esperance 1,500 tonnes.

However, the 720 tonne cap for the West Coast Managed Fishery will still apply for the 2002/03 season. Fisheries Department scientists are optimistic that the results from planned egg production surveys later in the year will indicate a recovery of West Coast stocks, which might lead to support for an increased catch in the 2003/4 season.

### **Cottesloe FHPA Moorings – Oops**

In May, the Fisheries Minister issued a media statement. "Fisheries Minister Kim Chance today inspected five environmentally sensitive boat moorings installed in the Cottesloe Reef Fish Habitat Protection Area (FHPA). The moorings are designed to eliminate the threat of damage caused to the reef, fragile sponge gardens and seagrass meadows through careless anchoring practices.

"The locations of the moorings were determined following widespread consultation with stakeholders, including conservation groups and recreational fishers," Mr Chance said. "Prior to their installation a comprehensive on-site underwater survey, which included the use of video, was undertaken by the Fisheries Department. "This helped to provide important information regarding the sea bed characteristics and to ensure the mooring designs were appropriate."

But following one of the strong storms in late June, it was reported that at least one of these moorings had drifted onto the onshore reefs in the area. Not lasting even the first winter would be embarrassing to say the least. It's never good to have a mooring bashing itself on a "fragile" reef in a heavy swell, but to have one which was supposed to protect the area, moving and damaging the reef......oops!

Suspect there were some red faces somewhere and strong messages "don't let this happen again" and a lot of "back to the drawing board" work. Still, it's said that the only people who never make mistakes are those who never do anything, so it's learning by mistakes, and they deserve credit for trying.

### Carnarvon Jetty Closure.

The Carnarvon jetty was closed for some time early in July, because of a public liability insurance issue.

The latest report, 14 July, is that a government bail out has allowed the One Mile Jetty to reopen for pedestrians and fishing. Negotiations are continuing for the jetty train to return to service. About a hundred and fifty people were treading the jarrah planks in the half hour the person was watching from the beach, attesting to the popularity of this local fishing icon.

Full marks to the Government for this!. But it is a warning of how easily recreational fishers could lose access rights.

#### Recfishwest Success in Recovering Funds.

May be a coincidence, but some of us don't believe in coincidences. Recently, after great difficulty in getting any answers which meant anything, Recfishwest went very public with an exposure of the diversion of over \$650,000 from the Recreational Boating Facilities Scheme to unspecified "other priorities", in probable contravention of laws and Government Policy. These funds are meant to be held in trust after being collected from recreational boating licenses fees, and used for Recreational Boating projects.

Then a short time later in late June, there was an announcement that 16 projects would share more than \$589,000 in the seventh round of funding from the Recreational Boating Facilities Scheme, and in early July, calls for submissions for funding totaling \$650,000 for recreational boating facilities to eligible Western Australian local governments through the eighth round.

Recfishwest - living up to their motto "Recfishwest - keeping them all honest for YOUR fishing future!!"

Hopefully, Departments will be a lot more careful with recreational fishing funds such as this one in future, because they know they are being watched.

## Rottnest Recreational Fishing Bans Update.

I went to the 22 July Public Meeting about the Rottnest Island Draft Management Plan.

The meeting was attended by about 20 people in the board room, which isn't big enough for many more people. It was run by Rottnest Island Board member Katherine Vance with another Board member Joe Merillo also there, and Peter Purvis from the Authority.

Leslie Smith went through and explained the plan, which covers everything which happens on the Island. Give them credit where it is due, the main driver is to make sure that everything which is done on the Island is sustainable, and that things will still be good in 50 years and 100 years or so, which no one should argue with. And so there are a lot of good things in the Plan - including their statements about what won't happen, such as there won't be a "Rottnest 5 Star Yuppie Resort" in the life of this 5 year plan.

Leslie emphasised that the plan is a draft – it is out for public comment and suggestions, and that they want these, and hopefully constructive ones. There is a strong emphasis on getting the research done and the data to point them in the right direction, and they admit there are lots of gaps in what they know.

The "precautionary principle" seems to come in strongly, eg "we don't know enough, so we should protect some areas while we get the data, in case it's going wrong."

She agrees they have no evidence of overfishing or damage caused by recreational fishing for the type of fish caught in the areas they are proposing to close, particularly for the main types type of seasonal, migratory or pelagic fish, such as herring, skippy, king george whiting, tailor, salmon, etc. caught by shore based fishing.

The main things raised by the public about the plan at this meeting were the fishing restrictions and arrangements for boat moorings.

They were asked if they had considered that shore based fishing in particular was still compatible with a high level of protection for the sort of things they wanted to protect, eg similar to the proposals for the Jurien Bay Marine Park where shore based fishing would still be allowed in some protection areas. (and in the Cottesloe FHPA, now that I think of it). They said, no they had not considered that, but took notes, and that seems to be where some changes can happen if it gets enough support, and if people look at what they are trying to do, and give constructive comments and alternatives.

They were asked why the particular areas for the fishing restrictions were chosen and not other areas which were used much less because of much more difficult access to the shoreline. Some suggestions were made for some alternative areas on the North side.

They were asked how the public submissions would be reviewed, and who would be involved, in particular groups like Recfishwest. The answer was that all submissions will be summarised and looked at by the Rottnest Island Board, by people from within the Rottnest Island Authority, they will get expert advice, and groups such as Recfishwest has been offered a meeting.

The summaries of public comment and the Final Plan will be made public at or before the time it goes to the Minister. They agreed that releasing the updated plan for another period for more public comment was a good idea, (I used the example as had been done for the West Coast Recreational Fishing Review) and the Board would consider that.

Even after they decide on the final Plan, they understand that they don't have the power to bring in some of the fishing restrictions, which would have to be done by the Fisheries Minister or Department.

They made an offer for any groups to meet with the Chief Executive Officer John Mitchell or Leslie Smith to discuss anything.

I suggest everyone interested get a copy of the Plan from the Rottnest Island Authority on 9432 9300. Just telephone and a copy will be posted to you. Don't rely on second hand reports, (even this one). The plan is open for comments until Friday 27 September 2002, so there's plenty of time.

You can also attend public meetings which will be held by the Rottnest Island Authority. Call 9432 9300. They seem to be putting on more meetings to meet the demand.

Some groups seem intent on "beating the RI Authority over the head" because of the way this plan has been handled without enough consultation before the release of the draft plan. I think the RI Authority has got this message loud and clear, and suspect that they will do it differently in future.
