Graeme Lowick put this message on the Surfcasters internet message board. Some of you don't have access to that, so here it is. Graeme has put in an application for club membership.

Kalbarri House For Rent.

The Club has a house in Kalbarri. The house is situated close to the river, beaches and town. It has two bedrooms and will sleep up to eight (max) in 1 double bed and 3 bunks, has reverse cycle air conditioning and ceiling fans to keep you cool in the summer months. Users need to bring their own linen, blankets and towels, tea towels, etc.

It has a radio and television, stove with oven, microwave oven, crockery and cutlery and all cooking utensils, fridge and freezer. Outside has a fish cleaning facility and a full width verandah. Rates are:-

Public:- Off season \$220 per week, On season \$360 per week } all Club Members:- Off season \$160 per week, On Season \$210 per week } plus \$50 Club Members:- Short term \$45 for one night, \$40 per night for two or more nights } bond.

Bookings taken for the school holidays go from Saturday to Saturday (leaving by 10am). Outside of school holidays it does not matter. Club members need to do their own cleaning on departure, or we can arrange cleaners at around \$46 per clean, extra on the rates above.

Check in time is 1pm. Check out time is 10am. Keys can be picked up from Ray White, Shop 1, Kalbarri Arcade. If people arrive after hours, they leave a note on the door of their office with a map of how to get to the house and telling them where the key will be.

As at end of December, the house is available to 28 February, 15 March to 17 April, from 25 April to 17 October, excluding a period around the September LWE, and 8 November 2003 on. John Lee's Kalbarri Story.

Hi Surfcasters. In November I made my usual annual two week trip to Kalbarri staying at the club's house.

I wasn't able to go up last year because I was too crook so it was nice to be there after a two year break. We did our usual thing on the Saturday of departure and got a very late start, leaving Perth around midday. By the time we made Lynton Station it was 1830 hours and although not super bright, the light wasn't that bad. I never speed on country trips, usually just touching 90ks and 100 down hills. I was negotiating a very gentle up slope not far north of the Garnet mine when a roo hopped out of nowhere and zigzagged in front of us.

I was probably only doing about 80 but barely missed hitting the dopey thing twice as it jumped to one side then back again. I always tell Angela (notwithstanding that I have a roo bar and that I was actually talking about birds and rabbits) "whatever appears in front of you - just hit it". The theory was sound but since the last time I clouted a roo was about 25 years ago, I'd become a bit complacent. Not helped of course by the fact that I was towing a trailer, tried to swerve and almost lost control of the 4WD. By the time we reached the National Park we were both decidedly jumpy and seeing hoppers behind every shrub.

Once at the house we spent the first day or two just relaxing, observing any changes made to the townsite and marveling at how inexorable housing development is - even at a place as sleepy as Kalbarri. At times like this, I do the usual babyboomer thing and think to myself "I remember the days when!"

Anyway, according to 'the Bureau', the weather for the better part of the first week was promising to be fairly unrelenting - 25 to 30 knot southerlies and big swells. And so it proved. On my first excursion to Wittecarra (club members used to call this "the cutting") I tried in vain to get a bait into viable water but didn't come near to clearing the dirty, weedy, soupy white water. Well they do call us "Surfcasters" - surf being the operative word.

By the second week, the swell had abated somewhat even if the tree bending southerlies continued and anyway the tailor had started to co-operate so I was reasonably happy. The bite rate was fairly slow so bag limits would have been hard work to achieve but, my intention was just to enjoy myself and not to fish flat out in any case.

While on the subject, (sorry I can't help myself) I've got to climb on my favourite hobby horse for a minute - each time I've been to Kalbarri between October and Christmas I've made a mental note of the number of female tailor I've caught that are fully roed in comparison to the total number of males.

The percentage is very close to 75% female, 25% male. I therefore do not attempt a bag limit during the spawning period but put most females back in the water. If you're wondering how it's possible to know which ones are females, it's very simple - just look at the condition of the fish in the region of the lower body near the anal canal and you will know. Although not ideal, if you need proof, just cut a couple open and I guarantee their egg sacks are bloated.

I've sent many letters and emails to Fisheries urging that a closed period be declared in the northern part of the mid west (Kalbarri) during the spawning season just as they do with Snapper in Cockburn Sound. However my plea seems to fall on deaf ears - no one wants to bite the bullet and make a tough decision. Anyway, that's another story.

One afternoon about 1700 hours or so, the wash was again extensive and as I was sick of having the left side of my face sand blasted, I walked further south at 'the creek' to within 200 metres of Red Bluff. My mind went back to 12 years ago when big bombers were also breaking and I fished the same spot for many bust ups and two nice Mulloway.

Well lightning sometimes does strike the same place twice and yes you guessed it - by 1730 I had a nice Mulloway flapping on the beach. I'd left my own little spring balance home, but I found one in a kitchen drawer - a little worse for wear perhaps but good enough as a guide and when weighed, the fish went 7 and a bit kgs.

I tried twice at Lucky Bay for zilch. The first time in a southerly sand blizzard at the only bay that didn't have a metre of weed piled up on the beach for a complete white out. The second time was amazing. It was only blowing about 20 knots (calm by local standards) and I was fishing, as I nearly always do, at the northern end of the bay immediately in front of the settlement. By 1730, all I had to show for my troubles were two tailor. Then I got a big strike and as I was very close to a reef I thought "I'd better hit this fella pretty hard or I'm going to lose it."

So I gave it everything at the same moment in which a surging wave broke in the same spot. As a result, my roughhouse tactics stung a very green Mulloway into making like a Marlin and leaping clear of the water with a rolling motion which thereby caused the line to wrap around its body. It broke off of course and I just stood there with my mouth open, completely stunned. It was worth it though just to see a species that most would term bullocking but sluggish in its efforts to escape, resort to gamefish tactics in order to gain its freedom. Actually, many years ago, I had the same thing happen at a place some of you may remember on the south coast at what we used to call Flinder's Bay or Emu Springs.

To have it happen twice in a lifetime is incredible. Anyway, after recovering from the shock, I rigged up again and cast into the same spot. Again I got a big hit but this time it was uncontrollable. Obviously a good shark but using only 9kg line in the vicinity of reef soon saw another bust off. So, with hands on hips "I shouted I'd like to see you do that again", rerigged with heavy trace and cast in.

I don't have to tell you what happened next - oh I managed to hang on for a bit longer due to the heavy trace but the mongrel cheated and swam out through the gap in the reef and turned north with the inevitable result. After that anything that occurred was going to be anti climactic. Of course, everything went quiet. So with tail between our collective legs, Angela and I retired to Kalbarri to lick our wounds.

It certainly wasn't the most productive trip (fishwise) we've ever made to Kalbarri but it was relaxing and I had a lot of fun when I managed to get a line in the water. After all, that's what life is all about isn't it - having fun.

PS. Next year I hope to take my boat up so hopefully I'll have a few more tales to tell

Notice of Motion - Membership Year Change.

At the January General Meeting, Terry Fuller gave notice of motion:-

To amend Constitution Sections 16, (a) and (b) to read:-

- 16. Membership Fees.
- a) Membership fees for the ensuing year shall become due and payable on the 1st of July in each year, and must be paid by 31 July.
- b) Any member whose membership fee is not paid by 31 July shall be deemed to be unfinancial and the Committee without further notice may terminate the membership of such person. Such person will not be eligible for any club competition, nor be eligible to vote or stand for Committee selection until membership fee is paid or an alternative arrangement is approved by the Committee.

To amend Constitution Section 16 c), d) and e), Section 3 c), Section 4 c), Section 15, replace the word "subscription" with "membership fee" for wording consistency.

Explanation:- (not part of the motion). This motion will be moved and debated at the February General Meeting.

Currently, membership fees fall due on 1 May and must be paid by 31 July. A significant number of members need to be followed up to make payment, or for the club to be told that they have decided not to renew their membership. This follow up takes up the time of committee members and has some costs for postage, phone calls and letters. This leads to a three month period when we do not know how much income we will get from membership fees, which is a significant part of club's income.

Accounts for the financial year 1 July to 30 June do not show what they should show, because a significant proportion of membership fees are usually collected in a different financial year in which they are spent on club expenses and services for the members. In 2002, members paid around 40% of fees before 30 June, and about 60% of fees after 30 June.

Fees need to be paid before the Annual General Meeting, usually in August, so that we know who is eligible to vote for Committee. The changed wording in (b) allows a member to make arrangements to pay in installments if approved by the Committee.

The Club's competition year runs from the beginning of May to the end of April. At present, this competition year lines up with the membership year, but there is no real reason why it needs to. It is still important for the competition year to end at the end of April so that all competition winners can be decided in time for the Annual Presentation of Trophies in mid June, but there is no compelling financial reason for the membership year to line up with the competition year, since the club does not usually pay any significant amount for the prizes presented. No change is proposed for the competition year start and end.

From Reel Talk September 1953.

Many thanks to past members Ted Horsley and Vern Pocklington for donating copies of early Reel Talks from 1952 to 1954, and a copy of the Constitution of the Surfcasting and Angling Association of WA from that time. This gives us some wonderful views of the early days of the club, and will fill many pages of future Reel Talks.

Here's the September 1953 issue, when the Club was called "The Surf Casting and Angling Association of WA."

News in Brief (September 1953)

Vic Davis and John McNerney have recently spent some tine at Rottnest, Vic using the excuse that he was putting some kind of wire into the new hotel, and Mac not requiring one. They tell us that the fishing there is marvelous. There are, as usual, plenty of "Buff Bream", and they're biting well, but there are good fish as well, Vic caught two jewies (6lb. and 12lb.) and a pike while both caught plenty of skippies and other good eating fish.

Nelson Smith would like members to ask him when he caught his last Kingie. He'd promptly tell you last week - a seven pounder at Cottesloe. Ask him when he got his last Tailor and you'll probably be told - "Last Saturday week. Vern gave me one."

Noel Knight wishes to have it put on record that at the time Nelson caught his kingie he landed a blue shark (weight not specified) all by himself.

Vern, the spinner, tells us he's got among the tailor at Triggs on several evenings lately. They've been jumping out of the water after his lures.

Last Sunday week, long before the sun was up, about 20 members headed for Yanchep, a favourite spot several seasons ago, and got lines into the water by first light. It was only a matter of minutes before Felix Holywell landed a 1½ lb. tailor. That looked good, but it was the one and only, so Felix scooped the pool again.

Mr. Christopher Harrigan, 75, of Hill Grove, Preston, who joined Carter Paterson and Co. Pty. Ltd., Slivers Lane, City, back in 1892, retired today.

His secret is: If you want to be contented - and stay with the one company for 61 years - go fishing.

Mr. Harrigan, who started work sweeping the floors at 6/- a week, and is now a leather goods maker, says he grew up with the company. He was 5ft. 2in. then. Today he is 5ft. 1in.

Mr. Harrigan claims he has fished in every spot in Victoria. "There's nothing like it," he said today. "You come back to work feeling fine after a week-end with the line.

"And you're happy towards the end of the week again - you know you're going fishing.

"Fishing is like stalking game. The quieter you are the better you do" .

Mr. Harrigan was a founder of the Preston and Northcote Fishing Clubs. As a delegate of the Piscatorial Council, he put perch into the Yarra 35 years ago. He claims he still holds the fishing record for Yarra fishing - five fish weighing 15¾ lb in one afternoon.

He was presented by the staff with, among other things, a fishing line - made with a cotton reel, a small piece of cane, a piece of string and a bent pin.

What's he going to do now he's retired? Go fishing, of course.

At long last the secret why so many of us go fishing is out. Of course, some of us go just to get away from the wife and kids, but there's another type who goes fishing to keep his job. Which type are you?

What's It To Be- Single or Double Handed Rods?

Form Reel Talk September 1953. From the spinning point of view single handed rods are like "Jets"; they're here to stay - in fact you can ask anyone who has used and caught fish spinning with a single handed rod and you'll get the same answer.

I have always looked to America as the leaders in fishing gear, and if you cast the old memory back as far as 1938 to the "Outdoor Life" magazine, or any of the other popular American fishing books, you'll remember seeing rods with the reel on top. It's only the last few years that this idea was adopted on our local beaches. We all agree that it's a big improvement on the old style.

Now look at any of those journals today and what do you see? Just about everyone using single handed rods. In one section it stated that nine out of ten rods sold in the U.S.A. were single handed rods, so there is proof that it must have something. I am tipping that within a very short time we will be seeing a great many of these little champs being used around our beaches.

To mention only a few of the big advantage is the ease of handling and the lightness which is a big feature when fishing off reefs against a heavy surf. Then there's the small amount of room required for casting as this is done in an underarm action. Last, but not least, is the thrill you got landing, say, a 3 lb fish on this light but excellent spinning gear.

On the tenth of August a chap named Martin, the keenest of single handed spinner fishermen landed seven tailor, ranging from 3 - 5 lbs in seven casts off North Beach, using 6 lb. nylon, Record rod and reel.

On Sunday, 16th August he hooked a 30 lb. yellowtail kingfish on the same gear, but after playing it for some time his line gave away on a knot. In July this year he landed a 10¾ lb "Kingey".

These catches were all made with the gear stated above so you see the single handed rods are really worthwhile considering.

West Coast and Gascoyne Changes.

The State Government has announced new recreational fishing rules. A general possession limit will apply across the entire State from July 1, 2003.

Revised bag limits for many popular species will also apply from July 1 in the West Coast and Gascoyne regions. Examples of new limits for popular species include dhufish two (currently four), spanish mackerel two (currently four) and cobbler four (currently eight). Some current limits, such as tailor (eight), herring (40) and mullet (40), will not change.

Fisheries Minister Kim Chance said the changes followed an extensive community consultation and planning process that attracted more than 4,000 written submissions.

Mr Chance said the new three category system of regulations, based on an assessment of the risk of over-exploitation, was a significant advance on the traditional approach used throughout Australia, which tended to favour bag limits and other controls set around social and angling values, rather than critical research information.

While the number of commercial fishing licenses had declined, due to Government funded buy-back schemes, there were also signs that increased consumer demand and higher prices were driving an increase in the targeting of finfish commercially.

The Minister said sustainable management must include both the commercial and recreational sectors and the new recreational rules would complement ongoing plans for greater management of commercial fisheries. These ongoing plans included a major review of the commercial wetline fishery, which also targeted finfish, a recently introduced management plan for the spanish mackerel fishery and existing management plans for commercial finfish fishing in the Gascoyne, Pilbara and Kimberley regions.

Mr Chance will consider changes to minimum legal sizes later this year after further consultation by the Department of Fisheries with the commercial sector.

Individual species within these categories may have differing bag limits and other controls in each region, depending on biological vulnerability, abundance and fishing pressure, and may appear in separate categories.

Current bag limits will continue to apply in the Pilbara/Kimberley region and the South Coast region until reviews scheduled to start this year are completed for these areas.

Under the new State wide possession limit each fisher will be entitled to no more than 20 kilograms of filleted fish at any time, except in their place of permanent residence. Fish divided into cutlets or other forms will be treated as if they were filleted. Anglers will have the alternative of retaining their possession limit as 10kg of filleted fish plus one day's bag limit of whole fish, or as two days bag limit of whole fish.

It will be illegal to land filleted fish on boating trips of less than 48 hours. For longer trips, only fillets at least 30 centimetres long with the skin and scales attached may be landed. Two fillets will be counted as one fish for bag and possession limit purposes.

Effect on the Club's Field Days.

Under the Club's Competition Rules, a maximum of thirty fish and a maximum of one day's bag limit of a particular species as specified by Fisheries WA Regulations can be weighed in for any Field Day (including Long Weekends) for competition purposes. Only one(1) wrasse may be weighed-in.

The new Category 1 limit of 7 fish would not have much effect on what can be weighed in on typical field days, eg salmon, mulloway, sharks, snapper, mackeral, if you think how rarely these are all caught together.

Under the new Category 2 limits, only a total of 16 of tailor, skippy, flathead, King George and yellowfin whiting, snook, pike, etc. can be weighed in. Note:- Category 2 seems to include all species not listed elsewhere.

The new category 3 limit number is much more than our club limit, so no effect. And from July 1, you will be able to keep one of those sometimes pesky under 23 cm Tarwhine if you need it for a species.

The new rules come into effect from 1 July. That's only two months after the start of the new competition year. What about using these new limits from the start of the 2003/4 competition year?

When is a Fillet Not a Fillet.

The proposed possession limits to come in from 1 July includes options which include combinations of one or two day's bag limit of whole fish and/or fillets. They allow the option of "whole" fish, but if in practise, these cannot be used because of the definitions they want to apply, then that's not reasonable.

The rules consider any fish which is not "whole" to be "fillets". A lot depends on the definition of the term "whole fish". The dictionary says "whole" is "complete or not divided" and that's very obvious, but leads to some problems for people who want to look after their fish.

A fish which has been gilled and gutted is clearly not "whole" under this definition, but no one should argue that it is not still a whole fish under the spirit of the possession limits. Let's hope they don't insist on calling them "fillets", because that could cause problems to some people on some field days.

If reason prevails for the previous case, then if a fish has been gilled and gutted and the head and/or tail cut off, (because they're going to be thrown away anyway), is it still a whole fish for possession limit purposes?

If a fish has been cut in half to fit into the angler's esky, with or without it's head still on, is it still (and should it be) a whole fish for possession limit purposes?

The dictionary says a fillet is "a strip or compact piece of boneless meat or fish", so a fish cut in half doesn't meet that definition of a "fillet".

Consider:- On a fishing trip away from his home, one guy catches under or up to his two days' bag limit of fish, including mackeral, cobia etc which are long fish. He has a large esky or freezer, so keeps them whole. All legal and within both the spirit and the letter of the law - and nobody can object.

Another guy catches the same number of fish (or even fewer). He does NOT have a large esky or freezer, so cuts the head and tails off, and/or cuts them in half. Suddenly they are now defined as "fillets" and if more than 20 kg he is now outside the letter of the possession limit. His possession is not legal, even though he's fished within the spirit and letter of the law up to the point when he cut his fish in half, and even though any idiot could take the fish halves, count them up, (and match them up if they really wanted to go to the trouble) and see that the guy had ONLY two days' bag limit.

Why the difference? That's hardly equitable just because one guy has the large esky or freezer, and the other doesn't.

We put in our club submission that an angler should be allowed to cut long fish in half for storage and that these should still be classed as "whole fish" if that's the term they want to use. But that wasn't included in the recent release. Let's hope that common sense will apply.

Toohey Report - Integrated Fisheries Management.

The following is a draft of comments on recommendations contained in the Integrated Fisheries Management Review Committee Report, and on the additional comments added by the Fisheries Minister. See Page 12 of the January Reel Talk for the list of recommendations and Minister's comments. This list is as drafted for the AAA.

SCAC is particularly interested in the application of the principle added by the Minister about "incorporating net economic worth calculations with supporting socio-economic data" to recreational fishing for species such as tailor and salmon. The tourism and associated spending of recreational anglers has an enormous actual and potential benefit to the economy, which far outweighs the limited benefits and returns of commercial fishing for these species.
- 9. SCAC does not have enough information to comment on the makeup of the Integrated Fisheries Allocation Council. SCAC believes that recommendation 4, "The integrated management system

must be open and transparent, accessible and inclusive, flexible, effective and efficient" must apply to the activities of the Council, so that it can be seen that the appointees are impartial and the decisions are soundly based on agreed data.

- 10. SCAC supports the intention of the recommendation, and also agrees with the Minister's comments against the recommendation, provided interested parties have an opportunity to have their views considered before a decision is made on important issues, and the Minister gives adequate details and the reasons for his decisions, as has occurred for this report and for the West Coast and Gascoyne Reviews.
- 11. States "The Integrated Fisheries Allocation Council be responsible for determining the process and timeframes for resolving allocation issues in each fishery". SCAC believes this should be reworded to "IFAC recommends the process ...etc"
- 12. SCAC notes the Minister's disagreement with the recommendation that "IFAC's recommendations or advice to the Minister for Fisheries should become public at the time it is submitted to the Minister". SCAC also notes the Minister's agreement with the general thrust of recommendation 4, "...the integrated management system must be open and transparent, accessible and inclusive....."

The Gallop Labor Government was elected on a platform of Open Government, and SCAC believes this requires that interested parties have an opportunity to have their views considered before a decision is made on important issues, and the Minister should give adequate details and the reasons for his decisions.

- 16. (i) Recreational plans for West Coast and Gascoyne have been released recently as recommended. SCAC notes that they do not come into effect until 1 July, and urges that early action be taken on other recommendations, particularly 16 (ii), as soon as possible, so that fish saved through restraint by recreational anglers are not lost because of uncontrolled commercial catches.
- 16 (ii) Agree most strongly. This is one of the most important recommendations, in SCAC's view. If it is important to introduce changes to Recreational catches, then it is just as important to review and manage commercial catches as soon as possible.

Any delay or failure to implement this effectively will confirm a view held by some that restrictions on recreational catches are a soft option which are not equitable and which will be ineffective because of uncontrolled commercial catches.

17. SCAC agrees with the Minister's comments about the need to be more timely in dealing with allocation issues. Unless allocation issues are resolved in a very short time (and SCAC understands this is unlikely for many fisheries) then allowing commercial fishing to maintain their existing catches is unacceptable as detailed above.

SCAC believes a precedent for early action has been set with the Mackerel Management Plan, although the one year notice should be reduced.

- 19. Agree most strongly that additional funding must be made available for the stated reasons, particularly education and compliance.
- 20. SCAC notes the recent Government statements of policy about Recreational Fishing Licenses. SCAC believes the Government now has an obligation to provide all the funds necessary for implementation of the recommendations as quickly as possible, considering how long they have been in development and the pressure claimed to be on fish stocks.

In particular, SCAC endorses the Committee's views on the significant social and economic values associated with sustainable fisheries.

An additional source of funds which should be included is from developments which impact on the environment and affect fish or their habitats, or which lead to increased pressure on fish stocks through improved access or increased population.

21. SCAC notes the recent Government statements of policy that general Recreational Fishing Licenses will not be introduced by a Gallop Labor Government.


AAA Publicity.

Club Web Site Update.

The club website now has over 500 odd pages which includes 400 odd photos. I had a counter on the home page for quite some time which had got up to 9000 since the website was started in July 2001, but that service stopped. So I had to go looking for a new counter, and I found one which gives a lot of information about where people are finding out about our website.



Graph of hits on the Home page for the month up to 23 January 2003.

In the last six weeks up to 23 January, we have averaged around 23 separate people accessing the home page every day, peaking at 42 on a couple of days. 170 of these come from direct hits which mean that these people know the web address, and 70 which have come from other pages on our site which have been found because people searched for some words that were on one of those pages, like "Steep Point Tailor", "Exmouth photos", etc.

Others come from links from all over the place, such as Beachfishing.com 34, Recfishwest 10, Western Angler 7, Breakaway Tackle 11, ABC 13, Seabreeze 13, AAA 10, and from search engines from places including Japan, Italy, France, Greece as well as the United States, New Zealand and Australian ones.

About 115 people came from searches on google.com, 60 odd from msn and ninemsn, 45 from yahoo. Checking on some of those searches, I have found that the club's home page is listed in Google as number 2 of about 8,800 entries for "Surf Casting", Number 10 of about 296,000 entries for "fishing in Western Australia", and that one competes with the commercial Fishing WA site and the Fisheries Department site, number 7 of about 1,500 entries for "surf casting tips", number 3 of about 7,520 entries for "surf casting techniques", and so on.

Many users look at only the first few pages of search results, and if they find interesting things there, will follow those links and never get to later pages. Many are not patient with pages which take too long to display. All that research I did on how to set up the pages so that search engines like what they find, and list them high up in their list, seems to have paid off in getting people to look at the web site.

I have also added a list of pages on the site and a way of searching the site so you can find what pages are there or particular pages you're looking for just by putting in a few words or a phrase.

Look at the website http://www.surfcasters.iinet.net.au or if you have a computer but don't have Internet access, I can supply you with a CD of all the files and photos so that you can look at everything whenever you like. I'll even throw in everything from the AAA web site. I made this offer several months ago but had slightly less than one person show any interest. RTFRT? I wonder.

Fix Your "Live to Fish" Hat

The "Live to Fish" hats are great with their broad brim and neck cover. But they don't work in the wind - they will blow off backwards in any decent headwind, and they hurt your ears because the chin strap pulls the hat down too far onto your ears, glasses or sunnies.

The fix is simple. Move the chin strap 30 to 40 mm towards the front of the hat, and add a 20-25mm band inside the hat, which goes over your head so that you can tighten the chin strap and it pulls this band down onto the top of your head and not onto your ears. Takes 5 - 10 minutes with a needle and thread.

PS. In case of foul weather, we decide and shift elsewhere at 5:30pm

Skipjack Trevally from the Shore.

Where Sand bottom near reefs, reef holes, beaches with rocky bottoms, rock walls, jetties - deeper water is often better.

When Best chances early or late in the day, or night time.

Baits Whitebait, bluebait, pieces of mulie or other fish, squid, octopus, prawn, shellfish, try a "cocktail".

Berley Pollard, fish oil, tinned sardines in oil, mashed up mulies or fish scraps, boiled potato, crab scraps.

Hooks For whitebait or bluebait:- a gang of three Limerick or Tarpon size 6 to 2 depending on the size of bait.

Make sure they are sharp. For cut baits size 4 to 1 Beak, Suicide or similar hook type.

Bite Skippy often "inhale" the bait and spit it out when they feel the hooks. Bite is a tap/tap or a pull. Just

tighten the line without jerking and you'll feel the weight. If not, leave it out there for a short time, if no


more bites, wind in and rebait and cast back into the same spot.

Secrets The "secrets" of using whitebait and bluebait are:- make sure they are fresh, and add a handful of dry

pollard after they have thawed, dip in fish oil for extra smell.

Sinkers Use the smallest / lightest you can cast or will take the bait down to the fish.

Rigs "Double whitebait" rig, adapt them for the bait you're using and pick a sinker to suit the place. Have several of these ready made, and pick the sinker and hooks to suit the bait and where you are fishing.
