Garden Island Field Day February 2000 - Update.

The club has the OK in principle to fish at Garden Island on Saturday 16 February 2002, and will be making the final arrangements in early January.

Details of all members who want to go need to be supplied to the Navy well before the Field Day, and they may do a security check of the names. There won't be any chance to jump into a vacant spot after the list is sent or at the last minute.

Your name will go onto a list for the Security people at the mainland end of the Causeway and you will need to carry identification, and if you're not on the list or can't be identified then you won't get onto the Island. We need to limit the number of vehicles used, and would organise for people to go 3 or 4 to a vehicle. Members will have to assemble and go over in a group, and you won't be able to just front up and go over at any time. You are able to leave the Island any time you like.

The list will be finalised at the January General Meeting on Wednesday 9 January 2002, and sent to the Navy soon after.

At the November Committee meeting, it was decided that we would fish up to around 9:00pm Saturday night, and be off the Island by around 10:00pm. We don't want to ask for too much on our first field day there.

Fishing may be in two main areas on the western side, and you will have to walk to your fishing spots from parking areas near the beach. There are no vehicle tracks or vehicle access to the beach in those areas, so you don't need a 4WD.

If you haven't registered already, please register your interest in going by filling in the form on page 24 with your FULL name, address, phone number and your vehicle registration number (in case your vehicle is one used) and send to the Secretary.

There will be a weigh in Saturday night for fish caught from Garden Island. After that, members who wish to may fish on the mainland and go to the Local Field Day weigh in with any fish caught from the mainland.

Previous Garden Island Field Days.

It's been a long time since the club fished at Garden Island. Here are a few details from the Reel Talk write ups for past Field Days for the month of February at Garden Island.

Feb 1960. Gale force southerly winds, 26 attended, 78kg of fish, tailor averaging about 0.5kg, 4 sharks 4 to 9kg, herring and King George whiting.

Feb 1962. Gale force southerly winds, with huge seas right up to the sandhills, 44 attended, 35kg of fish, mainly tailor to 1.5kg.

Feb 1965. "Howling southerly gale" 41 attended, 47kg of fish, tailor up to 4kg, averaging about 0.75kg, and an unstoppable monster. Reports of netting and boats catching lots of tailor before the Field Day.

Feb 1967 Hot weather, no sea breeze, 35 attended, 83kg of fish, tailor to 2kg, sharks to 12kg and herring,

Feb 1968. Blustery south west wind, 48 attended, 115kg of fish, tailor to 3.5kg, averaging nearly 1kg, trevally and herring.

After that year, the club fished other places in February, and the results were a mixed bag, with some good days and some where the fish were scarce. Just goes to show, even in the "good old days", luck played a big part.



Some Shark Facts.

Sharks have eight unique senses. These are hearing, smell, lateral line, pit organs, vision, Lorenzini, touch, and taste. The shark shares many senses that humans have such as taste and smell, but it has three senses that we do not have. The lateral line, pit organs and Lorenzini are senses that have been discovered over the past ten to twenty years, and play an important role in how the shark functions when swimming around.

"Ampullae of Lorenzini" are small pits that cover large areas of skin near the mouth and nose on the shark's snout. They are natural electrical sensors which, at close range, can detect the weak electrical fields generated by all animals.

Surfcasters Local Metro Area Field Day - 15/16 December 2001.

Firstly, please note the change to the January Field Day, now to be run with the Mandurah 500 on 26/27 January 2002.

After spending a few frantic days fishing Kalbarri in early December it was with a little subdued trepidation that we started our preparations for the Local Field Day. I must admit my enthusiasm was not high and I had to rally around to get the motivation going. The chance to try for a flathead and flounder in the Swan as well as the possibility of a bonito or two on lures did help. The New Moon and the favourable tides also added to the mood and pretty soon the eagerness returned and I was raring to go.

It must be said that I don't fish a lot on the metro coast these days apart from the occasional sojourn to Trigg with my spinning gear, so I was a little lost for options. Damian was keen to fish the river for a chance at a mulloway but I have never enjoyed estuarine fishing and opted for the beach. I persuaded my neighbour's teenage son to accompany me on this trip and we decided that the Swanbourne drain was the best option. This is only a few minutes from home and I had never seen the spot, so this was a great opportunity to visit one of the legendary beach fishing spots in Perth.

We arrived in the late afternoon and cast out mulies and blue sardines into the brisk sea breeze. The going was slow with lots of small silver bream in evidence that were laying waste to the baits likes packs of ravenous piranhas. We hoped the situation would change with sunset and the rising tide but this was not the case. One in 5 fish landed was a keeper but it was tedious going. A larger fillet bait was kept fresh and regularly checked and changed but remained unmolested for the duration. Later on 2 small chopper tailor were landed but that action was slow though we fished through the high tide until late. There have been some small pods of salmon around on these beaches as well as occasional mulloway but these passed us by.

We got home nice and late and I was up again at 3.30 am to fish the North Mole of the harbour. There was quite a throng already on the rocks following reports of bonito being captured there. As usual the water looked fantastic in the dim pre-dawn light with the smooth swells rising gently and the surface dimpled by small fish. First cast yielded a size blue mackerel. Within minutes this fish was joined by another. Then a skippy of embarrassingly small (but legal) size hit the inji rig and was deeply hooked and killed. This action all occurred before the sun rose. By the time the light improved enough we could see that the shoals of rising fish were actually blowfish swarms that decimated any bait entering the water, even way out on the longest cast that I could muster. After Damian had hooked at least a dozen blowies on a metal spinner we decided a sleep was a better idea. So that was the fishing for me as family duties kept me engaged for the rest of the day. After my somewhat pitiful showing however perhaps I was saved from further ignominy.

The late afternoon weigh—in was sparsely attended by anglers although the casting fraternity had turned out prior to the night cast to witness our "spectacular catches". George Holman caught a nice bag of herring on lure, Tony D'Alonzo a mixed bag including herring and a few nice tailor, Spencer King had 2 flathead from the lower reaches of the Swan and I had a handful of small fish. Rob Mitchell was participating in his first field day in years and despite commendable effort did not have a fish to enter. So a little disheartened we left to ponder our performances and perhaps plan a new strategy or two for the New Year.

Enjoy the festive season and I hope you have a robust and fruitful (and fish full) New Year. I hope to see you at the next Field Day. Field Day Officer, John Jardine.

Recfishwest - What is it and what does it do for us?

For those of you who've wondered what Recfishwest is, and what it does for us, here's some information from their Constitution, their web site www.recfishwest.org.au, and their 2000/2001 Annual Report.

Recfishwest is the trading name for the Western Australian Recreational and Sportsfishing Council. Members of Recfishwest are:-

- 1. General members, being organisations with National Affiliation. There are five of these, the Australian Angler's Association, (WA Div); Australian National Sportsfishing Association (WA Branch); Australian Underwater Federation, (WA Branch); Western Australian Game Fishing Association; and the Western Australian Trout and Freshwater Angling Association.
- 2. Public Members, persons who are interested in recreational fishing. Membership fee is \$22 per year.
- 3. Associate members, being companies, organisations or persons carrying on a business principally relating to recreational fishing.

The Board of Recfishwest has a Chairperson and one representative from each of the five General Member organisations, and six Public Members, who, interestingly, may not be a member of a fishing club or association or an employee of the WA Fisheries Department.

The "public face" of Recfishwest, the person most often seen or heard, is it's Executive Director, Frank Prokop. Frank's profile on the web site describes him:- "Frank brings to the organisation a high level of expertise having graduated with a Bachelor of Science Degree from Maquarie University with majors in Zoology and ecology and a Master of Business Administration from the University of Western Australia in 1996. Before moving to Perth in late 1992, Frank was involved in implementing numerous policy initiatives covering areas of commercial and recreational fisheries and environmental and endangered species protection. Frank is also a fisher in his own right, preferring the alluring ways of stream and river fishes, but occasionally breaks out for a bit of real fishing in the ocean.

The principal objects of Recfishwest are:-

- (a) to promote and participate in fisheries management so as to ensure the sustainability and conservation of fish species and their habitat:
- (b) to promote and advocate responsible recreational and sports fishing and assist with the education of fishers to increase recognition for limiting fish catches by persons involved in recreational and sports fishing;
- (c) to communicate with the commercial fishing community and any other group to improve co-operation and reach consensus in relation to the sustainability and conservation of fish species and their habitat;
- (d) to represent and advocate the interests of the Western Australian recreational and sports fishing community at State and Federal levels of Government and within the fishing industry on any issues which effect the development and sustainability of recreational and sports fishing; and
- (e) to take such steps and engage in such activities which will assist recreational and sports fishing with the attainment of these objects.

The secondary objects of Recfishwest are:-

- (a) to promote, represent and advocate fishing for recreation and sport as a source of food in accordance with the Western Australian legislation and regulations pertaining to recreational fishing and the requirements of the National Code of Practice for Recreational Fishing;
- (b) to promote the benefits of participation in recreational fishing through organised competitions and other similar promotions;
- (c) to communicate with recreational fishing groups within Western Australia; and
- (d) to provide effective representation for the recreational fishing community on relevant management and planning groups and committees.

Some of the accomplishments during 2000/2001 as listed in the Annual Report include:-

- 1. "Recfishwest has continued to have a high profile on Jurien Bay Marine Park planning and Dampier and Montebello planning. Although we have been disappointed with the values placed on recreation fishing in the Jurien process, we will continue to ensure that the needs of recreational fishers are accommodated."
- 2. "Recfishwest has worked closely with Fisheries WA to ensure the highest possible priority is given to the integrated management of the fish resources of this state. We have spent a huge amount of our resources in the planning and release of the Recfishwest Integrated Fisheries Management Policy, liaison with the Toohey Committee and the expert based reference group. This process represents the future management directions for Western Australia and also represents cutting edge management on a world scale. Recfishwest has prepared two submissions of exceptional quality on this important matter."
- 3. "Recfishwest has reviewed and provided advice on the West Coast Recreational Regional Review. We have not agreed with all proposals. We have also had some difficulty with some of the public consultative processes.

We are somewhat saddened not to see any real progress on the implementation of the West Coast regional reviews, especially the Gascoyne regional review which closed for comment on 27 August 1999 but has not been implemented."

- 4. "Recfishwest and WATFAA were able to achieve significant input into the planning for the Harvey Weir and Stirling Dam development and we supported the introduction of the closed season for the major trout dams. We have since commenced negotiation on access to Samson Dam and the procedures to be used with the draining of Waroona Dam."
- 5. "Recfishwest had significant input into the resolution of the Geographe Bay crab resource sharing issue and progress of the shark resource sharing process. While taking considerable time, the Geographe Bay process in particular shows the benefits of adopting a cooperative approach and empowering the commercial and recreational fishing industries to reach agreed outcomes as a consequence of the negotiations."
- 6. "Recfishwest increased its presence on the Hook. Line and Sinker radio show on ABC radio 720 6WF, (Saturday mornings, 8:30am) with Jodie Hoffman and Marshall Martin co-hosting with Frank Prokop. This show is rating highly and is proving an extremely effective forum to reach the wider fishing community."
- 7. "The Recfishwest column in Western Angler magazine continues to provide an important platform to reach the large number of subscribers. The column is popular, helps to attract members and allows recreational issues to be publicly aired."
- 8."It is with great pride that Recfishwest was able to coordinate the recognition of recreational fishing through the Australian Sports Medal to a number of special representatives. Western Australia and Queensland were the only states to award the sports medal to recreational fishers."

Since then, Recfishwest has been involved in several major activities, and many others, I am sure, that I don't know about. These include:-

- 1. West Coast and Gascoyne Recreational Fishing Reviews. As reported in earlier Reel Talks, these have been released for comments, and Recfishwest has consulted it's members through a mail out, and consulted some people with access to the Internet through the Western Angler Website's "Fishing Forum" and has put in a comprehensive submission which runs to eleven A4 pages. Contact T Fuller if you'd like a copy.
- 2. Owen Anchorage shell sand dredging proposals by Cockburn Cement see the article about this. Recfishwest prepared a twelve page submission on this, and has lodged a formal appeal on this. Contact T Fuller if you'd like a copy of the submission.
- 3. Proposed Interim Mackerel Fishery Management Plan has been released in mid December for comment. Frank's initial comments included:- "Recfishwest provided two comprehensive submissions for a net recognition of zero. This is arguably the worst draft management plan that I have ever seen in my time in fisheries management. It proposes the most expensive management regime possible for a fishery that is worth not very much. The summary of the position:- Research advice ignored. Compliance advice ignored. Recreational views repeatedly and comprehensively ignored. Departmental budget considerations ignored. Commercial participants with real catch history ignored. Optimising economic and social benefit from the fishery ignored. At least they were consistent. I am shocked and am currently on the eighth draft of a letter on the subject and it is still too hot to send. Maybe by the tenth draft it will still get the message across not happy Jan!!! "
- 4. Nearly every year the natural sand bars at Wilson Inlet and several other south coast estuaries are cut to allow built up water to escape to prevent flooding of properties. When the bars break naturally, fish and crabs seem to know it will happen and are waiting to come in and out of the estuaries. There's some thoughts that if the bar is broken artificially, the timing of the break can dramatically affect the fish population that go out, or more importantly, come in to the estuaries to breed or use them as nursery areas. Recfishwest sees this as a big issue for fishing in these estuaries, tourism and the environment, and must be worked through so that it is done at the right time, not when it suits a few property owners.

To summarise this, Recfishwest has the contacts, and it is recognised as the "Peak Body" for Recreational Fishing issues, representing the 600 odd thousand recreational fishers in Western Australia, and as such, it's comments carry much more weight than any other body's or individual's comments.

One of Recfishwest's problems is how to communicate with all the people they are supposed to represent. The "Hook, Line and Sinker" program on ABC Radio is heard by a lot of people, and the Western Angler gets to many WA anglers. Currently, they are working to update their website, which is really out of date.

They recently added a "Corresponding Member" category, which is free, receives correspondence from Recfishwest and these members can give their comments on issues being handled by Recfishwest, but do not have a vote to elect Board members, etc.

If you want to Recfishwest to represent your views, and to have more clout with their comments, all you have to do is become a "Corresponding member" and you will get consulted, and can give comments and raise the issues which you think are important. Owen Anchorage Shell sand Dredging – What are the issues?

You may have seen the articles in the news or papers about this and wondered. This is just a summary of an 80 page EPA report Bulletin 1033, and cannot cover all the details, but the following are some of the statements which have caused the furore. The report has maps, but the quality isn't good enough to copy here.

"Cockburn Cement Limited (CCL) has been dredging shell sand from Owen Anchorage since 1972. CCL now proposes to dredge shell sand in the long-term (to 2034) from additional specific locations on Success Bank, Parmelia Bank and West Success Bank, Owen Anchorage. The proposal is for Stage 1 (2002-2014) on Success and Parmelia Bank to create a 1.5km wide by 15m deep seaway through these banks by 2014. This would remove 168.5ha of seagrass and 264.5ha of shallow bare sand, which can be potential seagrass habitat, to recover 30 million tonnes of shell sand. Stage 2 (2015-2034) on West Success Bank would dredge about 350ha of shallow bare sand on West Success Bank, east and north of the Mewstone area, over an additional 20 years to recover 60 million tonnes of shell sand. A total area of 783ha." This area is equivalent to a square 2.8km by 2.8km.

"The EPA acknowledges that the long-term proposal has been developed from a very substantial base of new knowledge and that although some direct loss of biodiversity will occur in the vicinity of dredging in terms of seagrass, dependent fish, epiphytes and invertebrates, no species will be lost as habitat types exist elsewhere."

"In terms of cover, seagrass in Owen Anchorage was more extensive in 1999, even accounting for previous dredging losses, than at any earlier mapping period."

"The EPA recognises the important role that seagrass plays as a primary producer and a habitat and considers it is an important principle to retain seagrass in Owen Anchorage wherever possible. The EPA also recognises that Parmelia Bank borders Cockburn Sound, which has already lost 80% of its seagrass."

"The EPA notes that whilst seagrass rehabilitation is possible, it is not currently practicable at a scale comparable to the rate of loss proposed through dredging, but that the necessary technology may be developed in the future. It is also noted that seagrass distribution in Owen Anchorage is dynamic and seagrasses can establish naturally on shallow bare sand habitat."

"The EPA notes CCL has now identified additional resources of shell sand on West Success Bank with no seagrass cover. The EPA considers that dredging of unvegetated shell sand can be carried out in an environmentally acceptable manner."

"The EPA is of the view that CCL has provided sufficient new information to enable the EPA to conclude that further limited removal of some seagrass from Owen Anchorage can now be considered environmentally reasonable."

"Whilst the EPA considers that a limited loss of additional seagrass in Owen Anchorage could occur without inducing a significant impact, it wishes to ensure that any additional loss is strictly constrained. Accordingly, the relocation of CCL's dredging operations to unvegetated areas on West Success Bank should occur as quickly as practicable and in considerably less time than the 12 years as originally proposed by CCL for Stage 1 of the proposal. CCL should thus prepare for Government consideration a timetable for moving from Success Bank and Parmelia Bank to West Success Bank as quickly as practicable."

"CCL manufactures quicklime and cement and operates under the Cement Works (Cockburn Cement Limited) Agreement Act 1971. This Act was substantially amended in 1986 to require, among other matters, that the Company comply with the State's environmental laws, and to submit a "dredging management programme" (DMP) every two years for approval."

"The Act, effective to 2011 with provision for extension to 2021, entitles CCL to access shell sand sediment within a five mile (8km) radius of a point on Coogee Beach, north of Woodman Point. It also obliges the State to 'use every endeavour to find other shell sand within a reasonably economic distance from the jetty, and if other shell sand is not available, then other equivalent material.'"

"In conclusion the EPA:

- (f) considers that, on balance, commercial and recreational fisheries are unlikely to be significantly compromised by the proposal; and
- (g) supports the protection of seagrass on the balance of East Success Bank and Parmelia Banks, an extension to the Shoalwater Islands Marine Park......"

On the regeneration of seagrasses, the EPA noted:- "Field trials have been underway since February 1996 and seagrasses for transplantation have been taken from areas in the short and medium-terms areas prior to dredging. Transplantation has occurred into recipient sites located on eastern Success Bank. When survival over the past five years is factored (to February 2001), the area of actual rehabilitated seagrass meadow was calculated to be 2,794m² (approx 0.28ha) comprising:

1,815m² for Recipient site 2 (the major transplant site for the rehabilitation programme), based on 60% sod survival; and

979m² for Recipient site 4, based on 89% sod survival (CCL, 2001a).

Based on the performance criteria, it can be concluded that CCL has demonstrated:

that it has rehabilitated 0.1ha of seagrass for at least 3 years;

that it has not met the second performance criterion – i.e. rehabilitated 1-3ha of seagrass with evidence of survival for at least 12 months; and that

direct transplantation is slow (less than 1ha/year), is not yet feasible at a rate required by the proposed long-term dredging programme, and is costly."

The EPA identified alternative sources of lime "· other than in Cockburn Sound (including Owen Anchorage) there are no identified resources of high quality carbonates in or near Perth. There are deposits of shell sand on Garden Island, but it is unlikely that these resources will be exploited;

along the west coast, lime sands at Dongara provide one identified source of suitable quality resource for lime production. Cockburn currently operated a lime kiln in the area using this resource. In 1997, Westlime (WA) Limited also commissioned a lime kiln using this resource;

some high quality limestone deposits have been found in the Dampier Archipelago. Conservation issues will strongly influence exploitation;

the Cape Range has substantial deposits of high grade limestone. Exploitation will be heavily influenced by conservation issues and transport costs; and

lime is produced in the Goldfields area using limestone quarried 400km east of Kalgoorlie at Loongana. Further development of this resource is limited to industrial expansion in the Goldfields area; transportation costs limiting use further afield."

"...the EPA notes the different views held by CCL, the Department of Fisheries and Recfishwest but considers that, on balance, commercial and recreational fisheries are unlikely to be significantly compromised by the long-term dredging proposal given the limited reduction in seagrass in Owen Anchorage."

"The EPA considers that all reasonable alternatives to a proposal should be considered within social and environmental constraints. EPA notes:

there is lime sand of suitable quality at Dongara, where CCL already operates kilns.

the draft State Lime Supply Strategy confirms that alternative sources of lime are available from Dongara.

no alternative proposals to the current proposal were put forward by CCL, therefore no comprehensive environmental information has been provided on which a comparative environmental assessment can be considered. It is likely, however, that an alternative based on the Dongara resource could be made to be environmentally acceptable as the existing Westlime and CCL operations at Dongara were referred to the EPA and neither required formal assessment.

The EPA considers that unvegetated deposits on West Success Bank are a real alternative source of lime sand"

Recfishwest has challenged many of these statements and the conclusions drawn from them, in a twelve page submission. Here are just some of their comments:-

"The impact of dredging and seagrass removal upon fish stocks, recreational fishing quality and the prospect of successfully colonising seagrass by transplantation or other artificial means to offset seagrass loss are the key concerns of Recfishwest."

"Recfishwest has importantly identified two principal and overriding objections to the proposal. The objections are that the proposal, as identified in the ERMP itself, fails to meet both the requirements of the Ministerial Condition 6-2, August 1994 "that seagrass can be successfully rehabilitated", and the requirement (reinterpreted in 1995), "that due to Cockburn's shell sand dredging operations on Success Bank in Owen Anchorage, there be no net loss of present ecological and cultural function in the Cockburn Sound/Owen Anchorage area." (Supplement to EMP, and referenced in EPA Bulletin 901, August 1998)."

"The expected impacts on water clarity are negative. These include some impact from the increased winter wave activity in Cockburn Sound and an increase in turbidity plumes. The ERMP says the plumes from the dredge and the onshore washing plant are not expected to change from existing levels; but as production is anticipated to increase by more than 50% over the next 20 years this seems unlikely. Water quality, particularly clarity, is one of the main problems in Cockburn Sound and therefore this is a critical issue. When the dredging is occurring on Parmelia Bank any southward drift of a turbidity plume directly affects Cockburn Sound and could significantly reduce the photosynthetic zone which could further impact on seagrasses.

"Extending the rights of Cockburn Cement to dredge shell sand from the Owen Anchorage area for another 23 years beyond 2011 is a very big commitment for any government to make on behalf of the community it represents and not one Recfishwest believes should be made. If such extension is not given, presumably on EPA advice, then all the State has to do under the Agreement Act is to use every endeavour to find other resources. The State may adopt the position that in the better interests of Western Australia, a less convenient and more costly alternative may have to be adopted."

"There is now less than two more year's lead time to the end of the medium term proposal in which to find a solution to this problem. If a solution is not found and the current ERMP is approved then Cockburn Cement and the State will encounter the same problem in 2034. Recfishwest is very disappointed that little headway has been made in developing alternatives to shell sand mining in Owen Anchorage. We believe that this slow progress has largely resulted from CCL not being committed to the development of such alternatives, as Owen Anchorage has provided a very cheap source of high quality lime with the promise of further to come."

"Recfishwest understands that there is a benefit to State/society in having convenient access, as has been the situation in the manufacturing of lime/cement for many years. We further understand that developing alternative resources may well come with an additional economic cost, as is indicated in the ERMP. However we believe that this cost will be significantly outweighed by the greater benefit of reserving the remainder of the shallow waters for future generations as an excision from the State Agreement Act and gazetted as an "A" class reserve."

"Recfishwest believes that the time has now come to draw the line. The environmental values cannot continue to be compromised in favour of economic values to the point that irrecoverable damage and impacts have been produced."

Recfishwest challenged the EPA statements that "the seagrasses of Owen Anchorage do not support any commercial or recreational fishery" and "the view that there is a close, direct link between seagrasses and fisheries is a generalisation only and that the views of scientists are changing" with several paragraphs, including:-

"We contend that the type of fishing gear used in the ERMP sampling program was inappropriate, or at the least not optimal, for sampling fish species, particularly those species found in a seagrass or demersal habitat. As a consequence Recfishwest rejects the findings of the ERMP in respect to the fish populations present in Owen Anchorage area."

"... a direct quote from the CSIRO Division of Fisheries brochure 'Seagrasses': is "Seagrasses play a vital role in the marine food web....." and "In recognition of the importance of seagrass in respect to fish and fisheries, NSW Fisheries has published Habitat Protection Plan No 2, Seagrasses which was gazetted in September 1997. This plan aims to ensure that there is no net loss of seagrasses within the coastal and estuarine waters of New South Wales, and it prohibits or limits a wide range of damaging activities (such as dredging, reclamation, aquaculture and the construction of wharves and breakwaters) to help protect seagrass habitat."

"Conclusions.

- 1. It is the position of Recfishwest that the Cockburn Cement Long-Term Dredging proposal be rejected.
- 2. That Shellsand dredging in Owen Anchorage be phased out within a reasonable timeframe with CCL having to provide a statement of support as to which areas it wishes to access for this period. This statement must be available for community consultation and, at minimum, by way of a Public Environmental Review.
- 3. That the remaining areas of Parmelia and Success Banks must be given formal reserve status, preferably A class."

Grey Nurse Shark Status.

The grey nurse shark is at imminent risk of extinction, and the Federal Government has upgraded its status from endangered to critical. The new emergency listing of the species applies to the East Coast grey nurse population, which some estimates have now at fewer than 500 (on the East Coast of Australia).

The majority of the sites where the shark is recorded are in NSW waters. Environment Minister Robert Hill changed the status of the shark in October 2001 after submissions from the Humane Society International. Senator Hill upgraded the status from "vulnerable to extinction" to "critically endangered" which means that unless dramatic changes, occur the shark will become extinct.

From a Media Release noted by Andy Woodford.

A check of the recreational fishing page of the WA Fisheries Department web site shows that the Grey Nurse shark (*Carcharias taurus*) is listed as "totally protected and may not be taken" in WA.

West Coast and Gascoyne Recreational Fishing Reviews.

The club has sent it's comments on these Reviews to the Minister for Fisheries.

A ministerial media statement issued on 27 December said, in part:- "Western Australia' s recreational fishing community has provided a strong response to Fisheries Minister Kim Chance on a proposed blueprint for the future management of the State' s recreational fisheries.

The Minister received more than 1,000 public submissions to the proposed package of strategies for managing the recreational catch in the West Coast and Gascoyne regions.

A bulk of the submissions focussed on the need to have an integrated management approach for the State's marine finfish fishery.

Resource sharing between the commercial and recreational fishing sectors was also one of the main concerns expressed to the working groups during 15 public meetings.

"Recreational fishers have made it clear they want a fair and equitable share of the inshore finfish resource," Mr Chance said.

"I acknowledge their concerns and recognise that sustainable management of our fish resources must include both the recreational and commercial sectors."

The Minister said he would proceed with a process to review management of the wetline (commercial fishing) sector in this term of government.

"Effective sector management is essential if we are to move towards a more integrated management framework where allocation decisions can be made." he said.

"I will carefully consider all issues and comments raised in the submissions and take into consideration any community concerns before making a final decision on future recreational fishing management arrangements," he said.

Commercial Mackerel Fishery Interim Management Plan.

The draft report on management of the commercial mackerel fishery has been released for comments, and I obtained a copy from Recfishwest after seeing messages on the Western Angler Internet bulletin board. At the time of writing this, I don't know who has been given a copy, but comments from three different people have been very negative – see Recfishwest's comments on page 18. Some points from the plan are:-

The recommendation is for the plan to commence on 1 January 2003 or as near to that date as is administratively possible, and last for five years. The reason for the delay in the proposed start until 2003 is because it requires ministerial approval and possibly more public consultation, legislation, publication in the Government Gazette, tabling in parliament, ratification of existing catch histories, applications for and granting of permits to those who meet the requirements, and setting of Total Allowable Catches and allocations. It is called an Interim plan, because it is expected to be replaced by WA's proposed Integrated Fisheries Management, but was started earlier because of concerns over mackerel catches.

The zone south of 26 degrees 30 minutes south (between Kalbarri and Shark Bay) remains in the fishery, but that there be no requirement to apply for a permit to fish for Mackerel. If the commercial catches rise above 25 tonnes for two consecutive calendar years in that area, then management of the fishery in the area take place. The average catch has been 13.4 tonnes over the last ten years, with the highest 18 tonnes. Other Zones are Gascovne, Pilbara and Kimberley.

That the Total Allowable Catch be set by the Fisheries Department after taking the best available scientific and operational information to ensure the sustainability of the mackerel fishery. Fish can be unloaded at a limited number of ports.

Pilbara and Gascoyne zones be managed under a quota management system with an option of a six month season possibly before 2003 to preserve stocks in the short term. Kimberley zone interfaces with the Northern Territory and has some specific recommendations to cover boats operating out of Darwin, including a vessel monitoring system.

Only permit holders can land mackerel. Permits require a commercial fisher to have a history of fishing for mackerel, with a minimum of 1000kg (Kimberley) or 750kg (Pilbara) or 500kg (Gascoyne) of mackerel for four out of the seven years, or an average of at least that amount over all seven years from 1990 to 1997. This fits with an announcement some years ago that a fishing history up to 1997 would be required and recent entrants were not guaranteed continued access. Fisheries can issue a permit in case of hardship or extenuating circumstances, which includes people who have fished for some years before 1997, but don't meet the criteria.

Permit holders would be given a quota allocation out of the Total Allowable Commercial Catch in proportion to their history of catches from 1990 to 1997.

All these recommendations are explained in a lot more detail in the report.
