

Field Day Boundaries

Club Competition Rules 2.1.6 says "The boundaries for the Field Day will be published in Reel Talk. Boundaries may be changed at the sign on at the discretion of the Field Day Officer and by consensus of the majority of the participating members. Any competitor fishing outside the boundaries during the fishing times shall be disqualified."

This has generally been accepted to mean that the boundaries may be changed if weather or weed or beach or water conditions mean that it would be difficult to find enough fishing spots within the chosen boundaries, and an extension would allow fishing in some places with better conditions. It does **NOT** mean

that the boundaries can be extended because someone has a favourite spot outside the boundaries, or has heard of fish being caught outside the boundaries.

In future, the boundaries will be discussed and set at or before the April General Meeting when the venues are being chosen, and everyone will have a chance to say what they want.

Kalbarri House For Rent.

The Club has a house in Kalbarri. The house is situated close to the river, beaches and town. It has two bedrooms and will sleep up to eight (max) in 1 double bed and 3 bunks, has reverse cycle air conditioning and ceiling fans to keep you cool in the summer months. Users need to bring their own linen, blankets and towels, tea towels, etc.

Estuaries Die While Marine Parks Fly

Recfishwest Media Release Thursday 12 May.

There is increased community concern about the lack of action by the government on estuarine health throughout the South-west.

"Recreational fishers, together with all Western Australians, demand effective action to save the environment of our estuaries," Recfishwest's executive director Frank Prokop said today.

"We are absolutely disgusted by the different treatment of marine conservation and what happens in our rivers and estuaries," said Frank Prokop. "Western Australia's coastal marine waters are in good condition. The recently released Government discussion paper on biodiversity conservation confirmed that with the exception of enclosed areas like Cockburn Sound or Peel-Harvey estuary, the marine environment is in particularly good health."

Similarly the report 'Status of Coral Reefs of the World 2004' says that Western Australian coral reefs are in good condition and are exposed to fewer local impacts than other reefs around the world. However, where does our government put almost all its efforts? Spurred on by the propaganda of some environmental lobbyists, most of the effort has gone into the easy fix of establishing marine parks and marine sanctuary areas!"

Mr Prokop says that the government as well as the Departments of Environment and Conservation and Land Management are letting down present and future West Australians. "We are all aware of the sorry story of pollution and algal blooms in the Swan-Canning in recent years but tragically the same thing is happening in other estuaries and rivers between Geraldton and Albany."

Recfishwest believes that the new Swan and Canning River protection legislation will not adequately address the catastrophic declines by requiring long periods for consultation and other delaying procedures rather than reflecting the community's clear desire to improve the rivers and estuaries.

Mr Prokop believes that anti-fishing sentiment in some parts of the community plus a desire to capitalise on association with Western Australia's iconic marine attractions is distorting government conservation priorities.

"While CALM are concentrating on locking people out of environmentally healthy areas like the Rowley Shoals and Ningaloo, our estuaries are being overwhelmed with excessive nutrient inflows and the destruction of wetlands and fringing vegetation which is needed to buffer such damaging influences."

Recfishwest believes rivers and estuaries are seriously threatened compared to a generally healthy coastal marine environment and asks the government to seriously re-examine its environmental priorities, not just in the Swan-Canning system, but throughout the south-west. Recfishwest would be pleased to be involved in any constructive way.

Reel Talk June 2005

WARCO Letter to Members of Parliament

WARCO is the Western Australian Recreational Campers Organisation (inc)

Their Mission Statement:- To re-establish and maintain the traditional rights of the Western Australian public to enjoy free recreational camping in an environment of their choice.

What We Value:

- Environmental care and preservation
- The right to camp responsibly in areas of choice without fear of prosecution
- Cooperative and meaningful dialogue with all authorities
- An ethical and professional approach to all that we do

I am writing to you to express the concerns of all the people of Western Australia who are represented by the Western Australian Recreational Campers Organisation (WARCO).

WARCO is an organisation which represents eight State Associations. WARCO therefore represents directly an estimated over 50,000 people who use motor homes, motorised caravans, towed caravans, camper vans, tents and recreational vehicles as their accommodation units when they pursue their recreational activities throughout the whole of the State of Western Australia.

These people are concerned that while the use of these mobile accommodation units is increasing throughout the State the facilities to service this use are in fact decreasing. Caravan Parks are closing down and being subdivided into residential estates and other uses, or being redeveloped as "Chalet Estates". Also within Caravan Parks the number of sites is being reduced to make way for the building of "Chalets". It would appear that none of these losses is being replaced by the development of new parks or the expansion of existing parks.

For the most part these changes are a natural result of decisions made over the last few years by both State and Local Governments. Recent changes to Government Land Taxing and Rating formula have brought about great increases in Land Tax and Rating charges, in some cases in excess of 300%. This has caused some Caravan Park operations to become unviable financially and many more to become quite marginal. This has forced many owners and operators to choose to either:

- a) Close the facility and realise on its land value by selling or redeveloping. The result is a loss of that facility to the people represented by WARCO; or
- b) To reduce the number of caravan and camping sites in the facility and replace them with "Chalet" type units from which they can demand a much higher fee.

Both these alternatives are detrimental to the people that WARCO represents and caravanners and campers in general.

Another cause of discontent is the introduction and in many cases the unsympathetic use and interpretations by the various authorities of the Caravan Parks and Camping Grounds Regulations 1997. This has had a detrimental affect on the recreational vehicle user and campers. Application of some of these regulations has:

- a) Caused a reduction in the number of caravan parks and caravan sites throughout the State;
- b) Caused steep increases in the costs of operating caravan parks and in the costs of establishing new parks in recent years;
- c) Caused the closure of, and denial of access to many traditional rest areas and informal camping areas in popular recreational areas throughout the State.
- d) Caused a reduction of the number of rest areas along the roadside along our major roads and travel routes although our Department of Main Roads WA is doing some work to redress this problem within its area of responsibility.
- e) Denied Recreational Fishermen from camping out over night on most West Australian beaches whilst pursuing their recreational activity.

All this has happened in spite of the increasing number of recreational vehicles of all types being registered in this State.

The users and owners of motor homes, motorised, caravans, towed caravans, camper vans, camper trailers, camping tents and other recreational vehicles annually make a considerable contribution to the Government's income in the form of taxes on Sales and Registrations of Recreational vehicles, fuel and equipment, Rates and Taxes on accommodation businesses and properties, power, water and health charges on Caravan and Camping Park operators who also contribute by their presence to the economy and employment in country towns.

Extensive enquiries suggest that while Government Rules, Regulation and Valuations are causing a reduction in the Services and Facilities for the Recreational Camper state wide, there are no plans to replace the services lost so far. No State or Local Government Authority in their various planning schemes

appear to be making any provision for the expansion of existing services facilities or the creation of new services and facilities to meet the growing demands of the Recreational Accommodation Industry.

A further concern we have is contained in Part 5, Section 32 of The Caravan Parks and Camping Act 1995 consolidated to 1st January 2005. It appears to us that a review of the Act should have commenced after 1st January 2000.

In order to inform all our members, could you please advise us of the following:-

- 1 a) When did a review of the Act commence?
- 1 b) If the review now after 5 years has not commenced when will it be undertaken?
- 1 c) If a review has been commenced how far has it progressed?
- 1 d) When was the Report as required under Part 5 Section 32, Paragraph 2 placed on the table of the House?
- 2. Why is one section of the Government spending large sums of money to encourage Tourism within the State while other sections of Government are pursuing policies which are causing operators of Recreational Touring Accommodation facilities to close down and leave the industry as well as the closing of many traditional camping and rest areas?
- 3 a) What is your Government's policy toward the Recreational Camping and Touring industry in both the short and long term?
- 3 b) What are your Government's plans for the Recreational Camping and Touring industry in both the long and short term?

We hope to have your reply soon.

About 3.30 pm we drove into Kalbarri and stopped quickly at the Blue Holes. The tide was ebbing away, dragging the Murchison brown water out to sea. Some little birdie had whispered in Chas' ear about mulloway at Chinaman's rocks so that was the next stop. The car park was almost full and about 16 people were fishing already. Chas had a quick word with a couple of them and then we loaded up our tackle and slotted in on the rocks. 'Apparently it's getting busier' Chas said.

So, the fishing had started. During the set up time two small mulloway were caught and thrown back, then one about 3 kilos was landed and kept. Chas was eager, still licking his lips from the taste of lamb shanks. Being a lure fisherman, I was torn. Water too dirty for tailor – no poppers or slices, blue holes too shallow – no poppers or slices. I tried my flick rod for whiting, no luck, just small blowies, so I rigged up my lure rod and cast out a mulie with a lead weight and a well hidden gang.

Now, I am not the one who would normally cast out and stand waiting for a bite, but if 16 other people thought it was worth a go, then so would I. Chas and I were talking about everything and anything and he was getting something hitting his well tenderised squid. He was also moving a lot along the bottom, further out than all of us put together.

By this time another four fishermen had appeared and slotted themselves in between. Lines were crossing and moving so tangles were becoming the order of the afternoon. Each time I returned my rig the mulie was gone, but no bites were registered, so about on my 5th cast I was standing, waiting as you do. I felt a movement on the rod tip, not the usual tailor hit on a slice or popper. Then again, another small pull and then a pause. Now I was concentrating. Pausing again the rod tip moved as though I was being pulled out to sea, I struck and the weight on the end did nothing. Then it was off, following the flow of the river out to sea. 'Chas, I'm on.' All I could do was hold on and adjust the drag on the reel.

By this time the sun was setting, the colours in the sky were drawing people to Chinaman's rocks for an evening's photographic event. So, with about 22 fishermen and locals and tourists alike all staring at me, the pressure was on. Externally I was the 3rd fisherman from the point so the fish did not have to swim far with the current to reach the sea (one problem), plus the reef ledge and a port marker buoy. I had to turn his head so I applied more pressure on the drag and leaned back on the rod, slowly trying to ease the fish back

and slowly I gained some line. Now swimming up river, another run to the other side of the river mouth, again turning the head after losing more line to the fish. Now I definitely had everyone's attention.

Someone close by said it could be ray, then the rod tip started showing some signs of head shakes. No, that was a mulloway. The rocks I was standing on were exposed, black and sharp and the other fisherman had pulled in their lines so I started walking up to the small beach with the fish in tow. Chas was laughing and giving good advice. He offered to lift it onto the beach, so very carefully we made it to the sand. By now the fish had risen sufficiently to see the paddle tail. Just before the beach it rolled on its back showing the flank and belly. Still one rock to avoid and Chas had him.

25 minutes to land and I could hear someone clapping, or was it the fish croaking? After two or three photos the fish was dispatched and cleaned. Lucky for me Chas had a large blue esky with ice, no need to cut up the fish to fit. I was gob-smacked. Really, really surprised. I had just fought a great fish, what an experience. All I could do was sit down while Chas tried to find another in the fading light.

By 6.30 pm we were knocking on Keith and Lee-anne's door as nothing more was happening at the river mouth. After a great shower we were sitting down to fresh fish from the boat Keith works on. Dhufish, sweetlip, snapper, coral trout. I walked with Marlin and his sister to the chip shop and bought some chicken salted chips, they went down a treat. Sadly Lee-anne had to go to work at the local tavern, singing and playing the electric guitar for 3 hours, so we talked some more, Keith, Marlin, Chas and myself and then hit the sack.

Early start on Wednesday, on the road by 8.00 and flying home. Chas had organised a fish filleting display at the club meeting that night, so we had to return.

Night fishing in Kakadu.

"Wanna go night fishing?" said my son Jamie. "It is a bit different up here coz there is a few rules to go by"

After 20 to 30 daytime fishing trips on the South and East Alligator Rivers, I gathered there would not be much of a difference until the rules were put to me. These are the rules.

- 1. All car keys and valuables are to be placed in a secure location in the dinghy. (At least others can get home and maybe have a drink on the way at your expense.)
- 2. You must wear long trousers and longsleeved shirts plus a head net and cutaway gloves. Soak yourself in mosquito repellent because they are bad.
- 3. Avoid all fishing tackle noises, no slapping of body, no loud exaltations.(Keep your mouth shut so as not to frighten the fish.)
- 4. No light to be displayed above the gunnell, flash photos of fish only when the fish is on the dinghy floor, (Light scares the fish and shows up crocodiles eyes.)
- 5. Nuffin, we mean NUFFIN!!! hangs over the side of the boat except your rod tip or landing net. (Refer to following article from local newspaper)
- 6. No consumption of alcohol while fishing as spillage is deemed wasteful. (Knocked over in the dark it may not be your drink.)
- 7. The middle man is deemed to be the "net man" and must give up any fishing to render assistance to others. (The most useless fishermen is always given this job.)
- 8. Rotation of the fishing platforms on the dinghy will take place only when volunteered, (or exhausted or reached their catch limit.)
- 9. In the event of obtaining a lure attached to one's person, threatening behaviour, loud abuse and ungainly movements must be avoided. (Sit down, shut up and wait till fellow fishermen are ready to give assistance. Any screams of pain while help is given is deemed to be wimpish behaviour.)
- 10. Any event of a crocodile attack, consideration must be given to others so please refrain from screaming out, leave the dinghy in an orderly manner, enter the water with dexterity, if resurfacing only wave. (We know you are gone so cut out the bloody noise, stop splashing and do not rock the boat.)

It is by mutual agreement of any remaining fishermen that the authorities will be notified of your demise when they return from the completed fishing trip. Your catch will be divided equally although any credits will

be allotted to you. Your fishing tackle will be equally distributed. For the next three fishing trips a memorial service of two minutes will be held on the completion of such trip at the boat ramp. (Subject to your leaving enough finances to provide refreshments.)

The crocodile in the story below also harassed us a couple of times and we moved away quickly. It is quite common for this to happen so you have to keep your wits about you. I would be a lousy feed anyway.

Newspaper Article:- Croc bites man, gets eaten!

A crocodile which attacked a local fishermen last week was destroyed and the carcass was distributed to aboriginal people in Kakadu for tucker. Ranger employee Geoff Bolitho was attacked by the 4 metre crocodile while sitting in a boat on the East Alligator River on Tuesday. He and two companions had been fishing earlier but were just sitting in the 5.3 metre boat preparing to go to sleep when the attack occurred.

The boat was anchored when the estuarine crocodile (saltie) lunged up over the side of the boat at Mr Bolitho who were sitting near the front. He was fortunate to sustain only grazes and puncture wounds to his head and arm.

Park staff were notified of the attack the next morning and a search was undertaken in the same location for the crocodile that night. A search party located a crocodile matching the description of the offending animal and displaying aggressive behaviour. This crocodile was subsequently destroyed and its carcass was divided up among local aboriginal people.
