For weeks, beaches have been calm with gin clear water. On Thursday, when the wind came up and blew strongly all day, I thought - mmmm - it's stirring up the water and getting a good load of weed to spread along the beaches to give us something to play with while we catch the fish. And it was so.

Arrived at the Guilderton Caravan Park to sign on to find the boys all set up in a cosy camp with visitors Barry Tomlinson, his dad, and his son busy making rigs under the

able direction of Peter Stoeckel, Bob Henderson and Derry Barber, with new member Terry Ring looking on and getting a repeat of the rig making session. Bob's sons Matt and Jamie were also there, but didn't enter the field day.

George Holman was heading off to have a look at the area around Seabird, so I followed him there and down the tracks heading back towards Moore River. Lots of reef to fish from, with a few nice holes, but the water was stirred up with guite a lot of weed in some of the best holes.

Some parts were fishable, but looked like it could be hard work bait casting or lure fishing to miss the weed - George said that most of it wasn't the sort of country to use sinkers and get many of them back again. George

went further south looking for somewhere to fish, and I decided to go back to Moore River to fish with the rest of the boys – after all fishing together was one of the reasons for having the Field Day there.

There were a couple of successful fishers at Seabird who were skiting about the fish they had caught. They had it on display and kept coming near to show us – or so it seemed. The leading one had the back part of what looked like a dart in his claws.

Back at the river mouth, the boys were on the beach hoping for an early run of tailor. For most of the afternoon, the weed was more of a nuisance than a real problem. The drift wasn't very strong, and the weed came past slowly and in patches, and you just needed to watch where you were casting. If you waited for the patches to drift past, and cast into a relatively clear stretch of beach, there was no problem with the rig staying

in the water. The weed you would get could be handled easily with the beach rods and Alvey reels. Some of the guys with lighter rods and threadline reels were finding the going a lot tougher.

The real problem were the hordes of small fish. I reckon the mulies were lasting about five seconds. There was rarely any bait left when you wound in, and if there was, it was just a skeleton. The fish were too small even for a whitebait – and they could get the bait off in a flash. So if there were tailor out there, it was hard to keep a bait out long enough for them to find it. Lures were the go, but didn't produce much.

We were treated to the sight of schools of mullet surfing towards the beach. Schools of 50 to 100 fish kept coming through all afternoon.

We were hoping for some tailor at dusk, but towards evening, the weed thickened and by dark it was getting hard to avoid. The wind swung around towards the south east, and for a while was blowing straight up the beach and that caused the weed to really get a move on. Spencer said he thought his luck had changed when he had a good powerful run that took him nearly 100 metres up the beach – until the lack of action told him it was just a lively lump of weed. Spencer and Nick caught some tailor up past the groyne, and Tony got a good

catch further up the beach. George caught nice tailor near Seabird. But everyone had to work hard for their fish, and Bob Henderson paid the price with a sore back from hauling in all the weed.

In the morning, the wind was down and the weed had settled so it was easy fishing. Unfortunately, the hordes of small fish had increased and were nearly impossible to get past, and only a few tailor and herring were caught near the river mouth.

Once again, I was impressed by the club spirit shown. George had parked outside the caravan park because of the hassles in getting past the boom gate, and had walked in with his catch to weigh on Saturday night. He was heading back to Perth and was going to have a quick meal before setting off. # Deep South Black Bream Survey Trip.

Black Bream Considerations. (Recommendations from Gary Shugg)

Use whole river prawns or ½ whitebait or bluebait, or live worms.

Place barb of hook in under belly of prawn, threading through body towards, head exposing business end of hook. Twitch (loop) line around tail of prawn which stretches prawn and gives impression of a live bait.

Throw tail of whitebait or bluebait in water as burley.

Use burley (old prawns mixed with pellets, but not in the Swan River due to blowies).

Leave burley overnight in preferred spots.

Best time is dawn, preferably with cloudy conditions.

Shut off motor and glide to spot for anchoring.

Allow 10 minutes, if no bites, move.

Bream in rivers like Kent & Bow don't like noise.

Can tie off to reeds or trees or bank and fish from there.

Always fish in shaded areas and look for branches in water, snag areas, etc.

Take Chumline to spray on bait, plus apply after applying sunscreen lotion (after cleaning hands).

Try prawnstar lures (trawl).

# Mackerel Threat - Media Release by Recfishwest

Following is a media release which was sent out by Frank Prokop from Recfishwest on 7 February. He asks people who are concerned about this to write to the Minister. The club will send a letter, but you should write too.

The January Reel Talk has some information about the proposal. What really alarms me is the increase in the commercial catch to around 43 tonnes in the Southern zone – the area south of Shark Bay. Frank has access to the latest catch figures.

As I understand, one characteristic of mackeral is that they are a mobile fish, most of which move in the same regular path. So if you have a high catch effort in any particular area they pass through, the catches will continue and can be quite high, and it seems that there are still plenty of fish. But you are, in effect catching most of the fish, and at some time, they will simply stop coming, because there aren't many to come. Already, it seems, the average size of fish has dropped dramatically, - meaning many of the big fish have already been caught, and the smaller ones are now being caught and don't have a chance to grow bigger.

## All in all - not a happy situation if you want to continue to catch mackeral !!

#### **Media Release**

Recfishwest, the peak body representing recreational fishers has called on all anglers to write to the Minister for Fisheries objecting to a draft plan for commercial Spanish mackerel fishing which threatens recreational fishing interests.

Executive Director Frank Prokop said "This plan was supposedly developed due to concerns about fishing pressure on mackerel stocks, yet the proposals which have not been released for public comment, would grant long term access to an inappropriate number of commercial fishers and gives no consideration whatsoever to recreational fishing interests."

Western Australia has commenced an integrated commercial and recreational fishery management process to bring in rational and coordinated management yet this plan appears to be designed to pre-empt the review by Justice Toohey and discriminate against recreational fishers and the general community.

The committee slashed the proposed entry criteria for commercial fishers by up to 90% in various zones of the fishery. They even abolished any entry criteria in the area south of Shark Bay allowing open slather of the stocks by commercial fishers. Indeed since management was mooted, commercial fishing of mackerel in this vital southern zone has increased from around 8 tonnes to around 43 tonnes.

"The recreational sector proposed that this southern zone become a recreational fishing zone with only a small commercial by-catch permitted. Our views have been totally ignored and if the commercial fishing effort continues to grow, mackerel could be seriously threatened in this area." Mr Prokop said.

These changes were developed by a committee that excluded recreational fishing interests.

"Recfishwest asked that recreational fishing be represented but was told it wasn't to be part of the process. Recfishwest has made three separate submissions to this group but not one of our recommendations have been given even a token consideration." Mr Prokop said.

The committee is also proposing to implement a quota management system. This quota management system is conservatively estimated to cost around \$200,000 a year to manage. There is not a strong scientific basis on which to base the catch level and the remote nature of the north makes effective compliance almost impossible.

"The value of the mackerel fishery in the year of highest exploitation was around \$2 million. Given that this fishery does not have to recover the costs of management, this fishery's costs will be almost totally subsidised by the tax payers of this state and if a buy back is required, the community will no doubt have to fund this as well."

"If the government spent the same proportion of the value of the industry on management, around \$65 million should be made available for recreational fisheries management." Mr Prokop commented.

The views of fisheries researchers, compliance officers, recreational fishers and a number of full time commercial fishers have been ignored in these proposals. They have only released the draft plan to a few people and we are concerned that without a wider community debate the draft plan could be accepted as the final plan.

Recfishwest is calling on recreational fishers to write to the Minister to express their concerns that this proposal should be scrapped and recreational interests must be properly represented.

"We owe it to our children to ensure that mackerel are available for them to catch. If this management is implemented we do not believe that we can look our children in the eye when they ask where all the mackerel have gone." Mr Prokop concluded.

# Jurien Bay Marine Park - Reply from Ministers.

The Club has received the following letters from the Environment Minister and Fisheries Minister in response to the club's letters.

Reading these replies does not offer much hope for any significant changes to the proposals, because the words "some amendments" could mean anything.

It's particularly disappointing that the Environment Minister has rejected any release of the amended proposals, or the details of the comments received, for public information and comment before the Marine Park is created.

What do you think about these replies?

## Reply from Minister for the Environment:-

Thank you for your letter of 30 September 2001 regarding the Indicative Management Plan for the Proposed Jurien Bay Marine Park.

I have noted your concerns in relation to both the planning process and the contents of the Plan and make the following comments.

The Marine Parks and Reserves Authority (MPRA) has considered the 81 public submissions and has recommended some amendments to the Indicative Management Plan in light of the submissions. The amended Plan is due to be forwarded to me shortly for consideration, and I will then seek the concurrence of both the Minister for State Development and the Minister for Fisheries for the creation of the marine park and the release of the Management Plan. A summary of public submissions will also be available when the Management Plan is finalised.

I do not believe it is necessary to undertake another public submission process. There has already been an extensive planning and consultation process and further consultation is unlikely to raise new issues that have not already been discussed extensively. The creation of marine reserves is always a complex task as it involves so many competing interests and it is difficult to achieve an outcome that fully satisfies all parties.

While I agree with you that fishing for rock lobster has a potential impact on the environment, it is a relatively low impact industry in terms of by-catch (ie. species other than rock lobster) and habitat damage and has recently been certified (in March 2000) as a "healthy and well-managed" fishery by the Marine Stewardship Council. The Council is an independent non-government organisation established in 1996 by the World Wide Fund for Nature and Unilever. Fin fishing, particularly recreational fin fishing, is quite a different management proposition and so can not be easily compared with rock lobster fishing.

With the planned construction of a coastal road and the general increase in fishing pressure throughout the central west coast, there is currently a window of opportunity to establish management strategies for recreational fishing and other pressures, to ensure the marine environment will be protected in the long term. The proposed marine park will provide opportunities to increase protection for fish stocks, maintain the balance of marine organisms on which these fish feed, and study the effectiveness of zoning and other management strategies.

While I appreciate your organisation's views regarding the proposal, I am sure you do not dispute the need for increased protection and management of the marine environment. The management objectives and strategies for the proposed Jurien Bay Marine Park may not be ideal from all points of view, however, the marine scientist Dr Graham Edgar who has extensive experience in other Australian marine protected areas and has been studying the proposed Jurien Bay reserve for the last three years states that "...the proposal as presently described will create the best marine protected area in southern Australia - with a long gap to second place".

I hope that this letter helps to explain some of the strategies within the Indicative Management Plan for the proposed Jurien Bay Marine Park and I look forward to your future support for this proposal.

#### Earlier reply from Minister for Fisheries.

Thank you for your letter of 30 September expressing concern about the public consultation and planning process associated with the proposed Jurien Bay Marine Park.

As you may know, the previous Minister for the Environment established a Community Consultative Committee which undertook an extensive consultation process and developed a Draft Management Plan for the proposal. This draft plan was considered by the Marine Parks and Reserves Authority who provided advice about some amendments before it was released. The draft was released for a period of three months for public comment and during that time, a range of interest groups including Recfishwest and your organisation provided an input. In addition, the Department of Fisheries made a submission outlining the matters of importance to the recreational fishing, commercial fishing and aquaculture industries.

The Department of Fisheries has advised me that the Department of Conservation and Land Management (CALM) is currently considering the public submissions and will make a recommendation to the Minister for the Environment about the final plan in the near future. I understand that CALM will produce a summary of submissions detailing how each submission has been considered during the preparation of the final plan. I also understand that the summary will be made available to the public.

The proposed establishment of the Jurien Bay Marine Park is part of the Government's policy to establish a system of representative marine reserves in Western Australia. The establishment of marine parks occurs for biodiversity conservation purposes and does not necessarily contribute to the management of fish stocks. Planning for and gazettal of marine parks usually results in some reallocation of marine resources between user groups.

This process can produce outcomes that do not benefit all users. I understand that the draft plan is likely to place some form of limitation on all user groups including recreational fishers.

May I take this opportunity to thank your organisation for its interest in the management of the marine environment.

# <u>Update on Proposals for Sanctuary Area at Cottesloe FHPA</u>

The club sent a letter to the Fisheries Minister objecting to proposals for a Sanctuary Zone at the Cottesloe Fish Habitat Protection Area – see the article in the February Reel Talk.

We've had a reply to that letter – and for once the news is good – at this stage.

But don't think this proposal is the last there'll ever be for these restrictions. The Sanctuary Committee has gone to the media again and got a colour photo and write up in the West Australian on Wed 20 Feb, so they won't give up and are continuing with their lobbying because they haven't yet got what they want. The spokesperson, Rowley Goonan, rang in to the ABC's Hook Line and Sinker program on Sat 23 Feb, and got a fairly strong response from Frank Prokop.

All that's needed is someone to do the wrong thing and the publicity machine and lobby group will use that incident to the maximum, and will then say more restrictions are "a necessary step in order to preserve fish stocks and the marine ecosystem of the area" as in the Minister's letter.

The Club also had comments from Frank Prokop, Recfishwest. "Thanks very much for that Terry. I can assure you that your efforts made a big difference up at the Minister's office to counter a letter writing campaign by the anti-fishing group at Cottesloe."

#### Reply from Fisheries Minister.

Thank you for your letter of 20 January expressing concern about the Cottesloe Marine Sanctuary Committee's support for a total ban on recreational line fishing between the Cottesloe growne and the Mosman Cable station.

The original proposal put forward by the Cottesloe Marine Protection Group (CMPG) included a proposed ban on all fishing from boats south of the groyne. After considering all of the submissions on the CMPG proposal, I determined that some limited recreational fishing activity should continue.

In allowing recreational line fishing to continue, it was recognised that recreational fishers generally target open water shoal fish such as herring, tailor and whiting which swim into and out. of the Cottesloe Fish Habitat Protection Area (FHPA) continuously. I do not believe that the banning of recreational fishing for these species would have been acceptable to the entire community and would not have provided any significant increase in the protection of fish habitat.

It should be noted that the vast majority of resident reef fish and other organisms such as coral, sponges, sea anemones and sea dragons are totally protected within the FHPA. I believe that this level of protection is adequate and that we can expect to see an increase in the biodiversity of the Cottesloe Reef System in future years.

The Department of Fisheries received almost 1,000 submissions on the draft Plan of Management and the overwhelming majority were supportive. I understand that the Cottesloe Marine Sanctuary Committee wish to

have all fishing banned in the area, but I do not believe this would be acceptable to the wider community at this stage. I am not prepared to consider a ban on recreational fishing within the FHPA unless on-going monitoring, instigated as a result of management strategies contained within the Plan of Management for the FHPA, clearly indicates that this is a necessary step in order to preserve fish stocks and the marine ecosystem of the area.

# Replacement Rock Lobster Bait from Fish Waste.

A \$75,000 Waste Management and Recycling Fund grant from the landfill levy, will see the recycling of fish waste into a replacement bait for Western Australian long line tuna and rock lobster fishermen, Environment and Heritage Minister Judy Edwards said in a Ministerial Statement on 25 January.

The Katanning-based company, Aqua Feeds, would collect offal from fish processing factories between Esperance and Geraldton, and would process the waste into lobster bait and marron feed as an alternative to imported fish meal.

The proposals are based on previously researched and developed dry lobster bait and marron feed, and wet soft pliable feed, which has been assessed by the South Australian Research Development Institute as the best artificial feed product they have tested.

The fish offal to be recycled by Aqua Feeds was currently being disposed of at a cost to producers, with some 1,500 tonnes of offal being sent to landfill each year. The market for the proposed replacement bait is estimated to be some 16,000 tonnes each year. The bait could also be used as an alternative to the fish bait being imported by the rock lobster industry. Bait such as mulies are being imported due to a current shortage in Western Australia.

# New Rules for Barramundi in the Kimberleys.

On 20 February, Fisheries Minister Kim Chance announced a new plan for the management of the State's barramundi fishery. To improve the quality of recreational fishing in the region and resolve resource sharing conflict, commercial barramundi fishing will be closed or restricted in the the Fitzroy River; around the townsite of Derby; in key recreational fishing areas around Broome; and on the Ord River.

To manage for growing recreational fishing pressure and to ensure the sustainability of barramundi stocks, the recreational fishing possession limit for barramundi is being reduced from five to two. In addition there will be three special barramundi conservation areas, the Ord and Fitzroy Rivers, and the Broome area, where different rules apply.

A minimum legal size for barramundi of 55cm applies across the State. In addition, a maximum size limit of 80cm applies in both the Fitzroy and Ord Rivers. Having a maximum size limit will help protect large spawning females and benefit the angler by promoting the opportunity for the capture and release of 'trophy' barramundi.

From March 1, all recreational set and haul netting will be prohibited from Beadon Creek (near Onslow) to the Western Australian/Northern Territory border. However, throw netting will still be permitted in open waters if the fisher holds a recreational netting licence.

"The new changes obviously raise issues of enforcement and the Government is actively working on ways to further improve compliance measures in the region," the Minister said.
