

Field Day Boundaries

Club Competition Rules 2.1.6 says "The boundaries for the Field Day will be published in Reel Talk. Boundaries may be changed at the sign on at the discretion of the Field Day Officer and by consensus of the majority of the participating members. Any competitor fishing outside the boundaries during the fishing times shall be disqualified."

This has generally been accepted to mean that the boundaries may be changed if weather or weed or beach or water conditions mean that it would be difficult to find enough fishing spots within the advertised boundaries, and an extension would allow fishing in some places with better conditions. It does NOT mean that the boundaries can be extended because someone has a favourite spot outside the boundaries, or has heard of fish being caught outside the boundaries.

In future, the boundaries will be discussed and set at or before the April General Meeting when the venues are being chosen, and everyone will have a chance to say what they want. Boundaries have been set for the remainder of the venues for 2003/4 as below. These can be still be discussed and altered at the General Meeting.

Consultation About Changes to Recreational Fishing Rules.

As reported in the last couple of issues of Reel Talk, one of quite a few "stings in the tail" of the new recreational fishing regulations is the limits the "filleting at sea" and "boating possession limits" place on people who fish from the shore at Rottnest island after going there by ferry.

The Australian Anglers Association wants to be assured that the revised regulations don't introduce other problems and any other "unintended consequences", so has written to the Minister and Department of Fisheries.

At the time of writing this article (24 February) there has <u>STILL</u> not been any publicity about the changes from the Department of Fisheries, but we have received a reply from the Minister, as follows:-

Thank you for your letter of 3 January to the Minister for Agriculture, Forestry and Fisheries regarding changes to the management arrangements for recreational fishing.

I have been advised that recreational fishing regulations currently being drafted by Parliamentary Council will be discussed with Recfishwest and the Australian Anglers Association (AAA), prior to the regulations being finalised.

If you have any questions on the draft regulations please contact Mr Nathan Harrison at the Department of Fisheries on 9482 7368.

Thank you for raising your concerns with me and I look forward to your ongoing participation in the management of recreational fishing.

Fishing at a Young Age.

Our Reel Talk editor's request for some fishing stories from one's past disturbed a small working part of my brain & quite a few memories emerged from hidden depths like a celestial gathering.

How can one express in writing locations that no longer exist, actual events with no factual evidence, mates, pals & buddies that have moved on, could be dead, dormant or avoiding me? How can I describe a childhood that

bordered on vagrancy, truancy, sheer devilment, delinquency, but freedom & loads of fun. Adventures that kids of today could never experience or believe when I try to explain yesterdays society, values, standards & ethics.

Anyway, I'm gunna start trying to recall my illspent youth & put pen to paper & give you some insight to the fun I've had as I've tried to grow up. Stories will cover the Freo area from the Power station south of Robb's jetty to the South Mole, the North & South Wharves (on top & below), the old wooden train bridge, the Freo traffic bridge, the foreshore of east freo, blackwall reach area. Then there's the North Mole thru to the Cable station.

Give a kid a handline or an old cane pole to use as a fishing rod, supply him with a treadley & instruct him to go forth & hunt for his supper.

My First Mulloway.

The following tale is a vague recall of an incident many years ago BUT has been verified by my cousin Bill Monger & on reminiscence a few more could be told.

As a young lad (say about 10 years old) I was introduced to serous fishing by my Uncle Bill, who lived next door to a renown fisho called George Brown. George had a bicycle & tackle shop over on Canning Highway in Bicton. Many a Saturday morning was spent loitering around in George's shop rummaging thru his tackle, sponging old bait or hooks, & perving on the sheilas in the deli next door.

George & big Bill would allow us to join them on some evening fishing trips down on the rivers edge in Bicton. Perched on a limestone rock or a rickety old jetty we were in awe as these blokes pulled in tailor & mulloway on handlines or George's cane rod.

With our kero lamps us lads scoured the foreshore for small crabs, cobbler, prawns & blue manna crabs. Many a night I came home with more skin missing that what was in my catch bag.

There's one special night that has stuck in my memory all this time & that was the night Uncle Bill landed a whopper of a mulloway but failed to acknowledge my participation.

Big Bill had taken his Little Bill & I down early to catch some live bait for him & soon we had yellowtail & trumpeter in the bait trap. Big Bill ran his line up & down the rickety jetty, baited with one of the livies, tossed it out under a cork float, shoved the wooden spool in a crack, looped a beer bottle around the line then sat back & had a fag or two. Meanwhile little Bill & I mucked around in the shallows pretending to be Zane Grey.

It must have been two hours later when the line took off, the beer bottle rattling along the jetty, Big Bill manhandling the line & putting on some drag. We clambered onto the jetty tripping around his legs squealing in delight for a monster was on the line & a huge battle was about to begin. Now here's where the fishing lesson begins.

The night was as black as a draught horses bum, not a breath of wind, no stars no nuffin. Suddenly Big Bill yelled out that he had no line left & a snap off was imminent for the spool was in his hand & the end of the jetty was close.

"NO WAIT" he had a bright idea. Grabbing ME by the scruff of the neck he shoved that spool into my hands & in a VERY SERIOUS TONE OF VOICE" told me not to let go "OR ELSE NO MATTER WHAT". Being 3 foot 6 inches tall & weighing in about 4 stone ringing wet wiff a bloody great fish heading gawd knows where the results were obvious.

Straight off the jetty I went down into the briney did I go, visions of a death so orrible & being nibbled on by all the gobbleyguts, blowies & crabs in the river. Surfacing a million miles away from the jetty all I could hear was Big Bills voice bellowing into the night "DON'T YOU LOSE MY BLOODY LINE.....DON'T LET GO....ORRRR ELSE

I must have been dragged up river a bit before my legs touched bottom & I scrambled for shore where Big Bill wrenched HIS LINE out my hands & proceeded to grapple with HIS FISH. Coughing & spluttering I was in no position to argue & the fear factor had not rescinded yet.

Up & down did Big Bill stagger with that fish till eventually a humungous shiny monster was belly up on the foreshore. Gawd it was big...I could have saddled it & gone to Rotto & back on it.

Big Bill heaved this monster onto his shoulders & staggered back to the jetty to collect our gear. Xmas in Kakadu

The following tale is an account of a visit to Jabiru NT to visit my son Jamie & spend Xmas fishing & sight seeing the area.

A four and a half hour flight was anticipated from Perth to Darwin direct, and was guite smooth flying conditions.

The pilot assured us of a safe flight to Darwin but due to cyclone Debbie hovering over the area it was changing into a rain depression and there was a possibility of heavy rain & strong winds. Dropping down to land in Darwin I reckon he underestimated his statement. Torrential rain, strong blustery winds had the aircraft rocking & rolling which had quite a few hitting the panic button.

I really became concerned when the pilot in command walked down the isle wearing a bloody parachute, stating that we was having problems with the landing gear, and was going ahead to get help. With the seat belt warning light flashing, my heart thumping (& a quick glance whose bum I would kiss if we crashed), the hostess came on the airwaves & mentioned that we had a cloud ceiling of 180 metres so could all passengers please raise our window shades & the first person that sights land is to yell out "We're getting close".

Hitting the runway 3 of us ran forward & assisted the copilot pull on the hand brake as we aquaplaned down the runway. Boy was it hissing down, we could not see the terminal until we nosed up to the aerobridge.

Torrential rain & blustery winds joined me as I picked up the hire vehicle & headed south down the Stuart Highway for 60kms before I turned onto the Arnhem Highway & headed for the Kakadu National Park & Jabiru. Didn't get far before I was stopped by the "LAW" & informed that there was numerous floodways under water but was open to 4x4's & trucks only.

I took it easy & encountered 5 flood sections that ran about 4 to 500 centimetres deep & were hassle free. The side plains were flooded, the bush lush & thick, the road a dream & the CD player & aircon a pleasure.

160km on, I paid my entry fee (\$16-50) to the Park, stopped at a bridge crossing & chatted to some locals then continued into Jabiru where Jamie met me at the crossroad. The humidity was running around 85%.

The temp about 35c, and my shirt stuck to me quickly & a drink was needed. Unpacking & yapping, and quenching my thirst, I was then given a tour of the town site, then a quick shower and on to the mine mess for dinner.

Sumptuous food was consumed (hey, I have to rough it you know) & we were back at the unit to some more catching up & planning for the many fishing excursions.

Tues morning, Jamie had to work the morning so the dingy hire from Jabiru dingy hire was organised (highly recommend as the service was first class). I had a walk around the small shopping centre, visited the local pool & did some laps then wandered back to the unit. Rain & drizzle followed me everywhere I went but it only took 5 minutes & you were dry again. After lunch we headed out of town approx 45kms to a bridge crossing.

An hour of lure tossing produced a couple of undersized barra (about 45cm) and with a quick release had my appetite wetted. Attacked by swarms of mozzies and march flies we called it quits.

Wednesday morning and a walk to the pool then a visit to the local library for some info on Jabiru. A snooze during the arvo then we headed for the golf clubhouse to spend xmas eve with Jamie's mates, playing pool, give the jukebox a workout (crappy music), and indulge in a drinking contest (silly young bugger thought I was passed it and lost big time). Staggered back to the unit in happy mood.

Wednesday morning saw us up early, load the dingy and head west for the South Alligator river boat ramp where on arrival we were confronted by the local Handbag (4 metre) as we put the boat in the water. It was here that the law was laid down regarding having any part of ones body protruding over any part of the boat. Throwing stones or telling handbags to nick off just doesn't work anymore as they just don't listen. The locals have grown accustomed to us humans, have got bigger and have a communication problem.

It seemed to take half the morning to travel right up to the top of the river where the small runoffs were. Jamie said we had traveled about 26km and had never been this far upriver but the heavy rain had given us rarely fished areas. Sighting so many "Handbags" on the way that would not move as we got close to them had me on tenterhooks.

Pounding the area with shallow diving lures produced quite a few barras but no legal sized ones. The acrobatics of the fish was sluggish the fight quite timid and I was left disappointed. Using the landing net it was catch and release and by the time we had drifted back about 10km, caught and released quite a few undersized barra, the score was nearly equal except for the croc which took Jamie's fish, did the roll and wound about 30 metres of 30lb fireline around his snout before we cut off. 1 "handbag" that will keep his trap shut for a while. The run back to the boat ramp was very quick as the river was running about 8/10 knots. Being instructed to load the dingy onto the trailer whilst having my tootsies in the water started an argument that I think I won. I'm not stupid!!!!!

Gawd I had an uneasy night, dreams of a croc wearing a napkin, holdin a knife/n/fork and me being the main course, of barra that both of us could not lift into the boat, catfish with whiskers 1 metre long, an empty esky and outa fuel.

Thursday morning and Jamie had to work so it was pool time and walking that kept me active. Lunchtime saw us heading for Yellow waters and lines in the water by 1pm. Because of the flooding and humungous amounts of water around we were able to motor along the walkways and cross to other billabongs and a place called "Threeways" on Home billabong. The local "handbags" greeted us at every opportunity.

Non stop casting using shallow and deep divers had us once again connecting up with barra, saratoga and tarpon. Only a couple were legal size but I thoroughly enjoyed the antics of the tarpon who jumped higher, twisted and contorted, and threw lures right back at you if you didn't keep the pressure on. Weed was a problem but I'm used to that. As the area was flooded to the max we were able to stretch our boundaries and enjoy the magnificent habitat, the birdlife, mozzies and flies.

The local handbags were up close and getting personal and when they use the landing net as dental floss it's time to move. More trolling, more casting, more tarpon, bugger all sized barra and I was exhausted, sunburnt, bitten and looking forward to a cold drink OFF the water.

Saturday morning allowed us a sleep in, view the cricket, walk to the pool and do some laps. Around noon we headed out to Muirella Park (nutha billabong), put the boat in and trolled, cast and mucked around for 3 hours WITHOUT a single capture. A few bumps and follows and snags but that's it. The sun had come out with a vengeance, backed up by hordes of mozzies and flies, the humidity climbed a notch or two and life started to look bleak. As we cruised back we disturbed the fruit bats that filled the air with flapping and screeching, and flew over us and dropped their greetings onto us in a hail. Not the first time for me!!!!!

Sunday morning saw us heading out to the East Alligator River and Cahill's crossing. The normal water level is 100/300cm but at 1:8 metres is a tad difficult to cross. The resident "handbag"...Mr BIG ERIC (all 5 metres of it) was in residence and caution was required. Water flow was extreme as we motored upstream for approx 15km to the floodplains then tried every rockbar, rockface, sandbar, snag and runoff. NOT A TOUCH... even though we changed lures to rubbertails. We were getting close to the boat ramp when the action picked up and the tarpon put on their displays that had us giggling like yobbo's for the next hour or so. Once again the barra were undersize (45 to 53cm) and were lethargic.

After numerous snags, lure retrieves, lure losses, bloody tired arms, the sweat streaming off us, biting flies and exhaustion got the better of us so we headed back. We ran the dingy right up onto the boat ramp and trailer, gave "BIG ERIC" the finger and traveled home with the knowledge that we had well and truly satisfied our appetite for fishing.

I've just had 7 days of fabulous company, delicious food, exciting fishing, truly magnificent country, abundance of wildlife and whetted the tonsils. Met some great people, been given every assistance and co operation and can honestly say I've had a ball. A xmas experience that will live in my heart and memories for a long time into the future. Recommend you try it someday.

Fishing for Stamps?

Chances are if you asked anyone who was born in the late 1930's or 1940's if they had ever fished the answer would be in the affirmative. Better still if you asked them, especially if they were male, did they collect stamps at one time or another the answer again would be in the affirmative.

Fishing is the largest sport or recreational leisure hobby in the world with stamp collecting or philately the largest indulged hobby in the world. So how do these two vastly different pastimes co-join?

As a youngster I fished enthusiastically up to the age of 12 years and would also, when pocket money allow it, buy and later swap stamps. It was not uncommon in those days to collect, cigarette packet labels, cricket cards, cards out of cereal packets, playing cards, you name it, and chances were that it was a collectable. Even today kids, and many adults, still collect items of interest and to support this "need" there are numerous stamp shops, hobby shops, Hobby Fairs devoted to this "industry". I have seen grandchildren con their parents into buying various cereals to get the cards inside.

As the hobby of philately grew postal authorities were quick to realize that here was a growth industry and fostered it by producing stamps of interest to many collectors and I might add investors. And so was born here in Australia many Philately outlets. If you visit www.auspost.com.au/philately/stamps/stampshops you will have your eyes opened up to a Home Page, Entry to stamp shop, and 9 other sub headings.

It is amazing to think that when you post a letter that all you have to do is buy a stamp, lick it (sometimes as we now have self adhesive stamps!) seal the envelope and away it goes but that it item in the top RH corner will be a collectable to someone and amongst other things a revenue raiser for many institutions who buy bulk used stamps and sell them overseas to stamp dealers for packets.

Because of the expense involved in collecting a total collection of a particular country many collectors collect themes and this type of person is a Thematic Collector. Themes vary widely and include ships, flags, cars, film stars, inventors and such but another extremely popular theme is fish and fishing. Realising this Australia Post decided to "cash in" on this theme and on February 17th 2003 released a set of 5 stamps that depicted five of the nations most sought after recreational fish being - the snapper, barramundi, Murray cod, brown trout and yellowfin tuna. The set was known as the Fishing Australia series.

Such was the advertising hype behind the pre release of this series that Rex Hunt was recruited to do the launch in Melbourne. I now unashamedly quote from fishvictoria website. "Rex Hunt enlisted the help of a somewhat slippery friend on 17 Feb 2003 to launch a series of stamps dedicated to fishing. Rex was in Melbourne to launch "Fishing in Australia" which is now available in Post Shops.

Recreational fishing is a national obsession in this country so it's great to see it represented on stamps. Anglers love to collect all-things-fishing and will be a hit amongst the fishing community, said Rex.

Australia Post's Gary Highland said the release of the stamps was in response to strong public demand. We have had numerous requests for fishing to be given its own set of stamps - which is not surprising since most year. Fishing is one of our nation's best loved pastimes. It is enjoyed by people of all ages, from all walks of life in all states of Australia. Mr Highland said that the stamp series highlighted the great diversity of Australian fishing. We wanted to ensure that both freshwater and saltwater as well as northern and southern fish were represented. He further added that the fish chosen by Australia Post are in many respects the icons of recreational fishing in Australia.

The snapper must be one of the most eagerly anticipated fish in Australia each year - particularly when it makes its run into Port Phillip Bay. The barramundi, outside of the closed season, is a fulltime obsession for northern anglers just as the yellowfin tuna is eagerly pursued by game fishers all round Australia. The introduced brown trout and native Murray Cod would rank as among our most elusive and sought after fish.

The stamps were illustrated by Sydney artist Ego Guiotto and the stamps also feature lures and flies associated with each fish."

There are fish depicted on Australian Territories stamps of Christmas Island and I would suggest that there is not a country that has not issued a stamp that depicts a fish, fishing or something that accords our hobby the recognition it richly deserves.

Comments on Draft Extensions to Ningaloo Marine Park.

The Australian Anglers Association has put in the following comments on draft plans to extend the sanctuary and no take zones at the Ningaloo Marine Park.

Comments on draft revised zoning scheme for Ningaloo Marine Park and proposed additions.

The following comments on the draft document have been prepared on behalf of the Australian Anglers Association by Secretary Terry Fuller.

General.

The Association places great importance on the future of recreational fishing, the habitats and the fish resource it depends on, and equitable access to areas for fishing. These are all very high priority in the Association's objectives.

The Association fully supports and actively promotes conservation and responsible fishing, and will not argue with any changes which are proven to be really necessary and will be effective for the preservation of the environment and/or conservation of fish stocks.

We ask that the process of deciding those changes be supported by data which shows that these are needed and will be effective, equitable and will share the effort and impact among all parties which are involved in affecting the abundance of fish or the environment.

We recognise the unique values of the Ningaloo Reef and agree that Marine Park status is appropriate.

Fisheries Management and Marine Parks.

A principal issue is the failure of the Western Australian government system to integrate the responsibilities and contributions of the two departments involved in Marine Parks, CALM and the Department of Fisheries.

The Fisheries Department manages fish stocks and fish captures State and region wide, with additional special controls in some particular regions or areas. CALM appears to wish to overlay no take zones and area controls and use "the need to manage the take of fish" as a justification for these zones, when fish are already managed on a wider scale. We also object to proposals to close areas to fishing if fishing has nothing to do with other things which might really need to be protected or managed in those areas.

The current lack of interaction with the Department of Fisheries is exemplified by the way that the Proposed Zoning Scheme appears to have ignored the recent changes to fishing regulations in the Gascoyne region which have reduced the daily bag limits for many targeted species.

Far larger impacts occurs from large scale extraction of finfish species in the region or nearby areas or during their migration to or around the area, and proper fisheries management everywhere has greater potential for improvement in fish abundance than banning fishing for them in some areas.

If CALM has reservations about the effectiveness of fisheries management by the Department of Fisheries, those issues need to be resolved but not by duplication or additional closed area restrictions introduced by CALM.

Control for increased pressure along the coast must be for the whole of the park and region and if that needs tighter region wide restrictions, that's the right way to go. Sanctuary areas must not be used in an attempt to compensate for any failure in any other fisheries or environmental management.

It appears to the Association that the opinions of a limited group, including the CCPAC, have been used in lieu of good scientific information. This is particularly apparent in Section 3.9 of the Framework for the Review where it says "Whether this regional (recreational fishing rules) approach is, in itself, adequate to manage the greater pressure on targeted fish stocks in the Park, compared to other parts of the region, requires careful consideration."

We note the MPRA position in the Framework for the Review of Ningaloo Marine Park Management Plan was that "current management arrangements for recreational fishing in NMP be reviewed, including the option of seasonal closures during spawning periods for selected species". Despite this statement, there is no indication that this has occurred other than to push for increases in no-take areas.

If one part of the problem is simply that too many fish are being caught, and if that is supported by real research data, then that should be handled by catch limits, and not by closing areas.

We believe that targeted seasonal closures with the specific purpose of handling any seasonal issues such as protecting fish spawning aggregations would receive significant public support from recreational anglers. These need to be supported by the data which shows they are necessary, and targeted seasonal closures will be much more acceptable than complete spatial closures.

The Association accepts the possibility that the current Gascoyne recreational Fishing rules may not all be suitable for the Ningaloo Marine Park, and believes that there should be a separate Marine Park Fisheries Management group to examine and assess fishery management issues for the marine park.

Marine Conservation by No Take Closures based on Area.

The Association believes there is an over concentration on No Take Zones as the principal method of marine conservation effort by CALM in Marine Parks.

The draft document seems to rely on a general area based objective for No Take Zones to justify the increase in the no take sanctuary zones in the Ningaloo Marine Park.

The scientific criteria developed for the Representative Areas Program (RAP) for the Great Barrier Reef World Heritage Area of 30-50% of the total area of a bioregion as recommended by the Townsville Declaration on Coral Reef Research and Management has been used without any attempt to justify or explain if or how this translates to the Ningaloo Marine Park.

The Great Barrier Reef is subject to different pressures from the level of exploitation and use and heavy run off of silt, fertilisers, herbicides and pesticides from very large areas of intensive farming in an area of high rainfall. Some tropical reefs in other parts of the world are subjected to massive overfishing with inappropriate and damaging fishing methods which do not occur in Western Australia, yet the needs and experience in these parts of the world are used as "justification" for large closures in the Ningaloo Marine Park.

CALM uses reports of the success of some closed no take areas in some other parts of the world to justify the need for closed areas in WA. But some of those areas were VERY heavily fished and fish stocks were in VERY serious decline and thus closing areas DID have a big effect. That experience does not necessarily translate to WA where fish stocks are generally not under such pressure.

One potential danger of closing extra areas where existing fishing is claimed to be detrimental, is that it will simply transfer and put more fishing pressure on the adjacent areas and other areas which remain open. That will cause those areas to be affected even more, (assuming local fishing is actually the major impact), which will lead for pressure to close those, as has already been used as justification for the proposed extra closures in Ningaloo.

CALM are required to manage the WHOLE park, not just the closed sanctuary areas, and simply transferring the fishing effort is not a responsible action nor an effective response to a perceived problem.

Problems come when CALM tries to use or justify area closures to manage fish stocks, or close areas to fishing when fishing has nothing to do with other things which might really need to be protected or managed in those areas.

Impact of Recreational Catches.

Justification for extra closed areas includes an assumption explained in "Recent research in NMP by Westera (2003) showed evidence of trophic cascades in the recreation zone adjacent to the Mandu sanctuary zone that are likely to have resulted from the removal of 'top-end' predators targeted by recreational fishermen".

The study does not provide any evidence of "overfishing" in terms of recruitment overfishing. There is no evidence to suggest that current levels of fishing are causing adult stocks to be reduced to the extent that recruits produced are insufficient to maintain the current populations.

We note that there is no evidence offered that the catch by recreational anglers is solely responsible for this effect. We question what impact professional fishing activities including the finfish bycatch and mortality due to Prawn trawling in Exmouth Gulf has on the stocks of mature fish in the northern part of the Marine Park.

The assumption implies that recreational catches are solely responsible, since the "cure" includes increased no take zones which (we understand) only or mainly affect recreational anglers. This reinforces the view that recreational fishermen are the "soft target" where "something" can be done, but not necessarily what really needs to be done to solve the problems.

Where is the action on total catches in the region including those by professional fishermen? We submit that an alternative "cure" for the impacts seen could well be different management of fishing activities in other parts of the region including outside of the Marine Park boundaries.

Recreational anglers have had tighter catch limits imposed on them, but there have not yet been corresponding changes to the management of professional fishing. Recreational anglers want Department of Fisheries to move forward with outcomes from the wetline review and integrated management. CALM and the Committee should use its influence to push for the Department of Fisheries to implement an Integrated Fishery management that ensures an Ecologically Sustainable Managed Fishery, because we believe this has the potential for much greater improvement in fish stocks than sanctuary zones.

Choice and Justification of Areas for No Take Zones.

A limitation in the review process which resulted in these proposals is the notable absence of scientific data as a base for any alterations to current zoning and management. The changes proposed in the draft zoning plan are certainly not supported by scientific information. The Ningaloo Marine Park Management Plan 1989-1999 emphasised the need for research and monitoring as a basis for proper management of the Park.

The document does not contain enough information about why the particular areas shown on the map have been chosen for us to give many detailed comments about their suitability for achieving some objectives or otherwise. In our opinion, the document does not have give an adequate explanation of the objectives or why these particular areas were chosen.

The documentation needs to establish what is to be protected from what threat from what activities. The actual zones recommended need to be justified to make sure that any sanctuary/no take zones are the only way of achieving the protection, and are no larger than they need to be to protect whatever is decided needs to be protected in that area.

Allowed Activities.

It is completely unacceptable that activities such as trolling for pelagic fish outside the reef should be banned in the sanctuary areas. There is no justification for preventing trolling because it could not possibly have any impact on anything that might need to be protected in sanctuary zones.

We submit that all activities should be allowed in all zones unless those activities are proven to be incompatible with the declared purpose for the existence of the zone.

It is believed CALM has concerns about compliance, and has concerns about the difficulties of checking activities if some things are allowed in the sanctuary zones. We do not accept complete closures simply to make it easy for someone to check compliance, particularly in the current environment of little effective compliance checking anyway.

Shore based fishing zones should allow recreational line fishing for finfish from the shore or by wading, standing on rocks, reefs, etc. in at least a 200m strip from the shore line.

Marine Conservation in Western Australia.

The Association is dissatisfied with the current process for planning marine conservation reserves in Western Australia.

A particular concern is a later step of "a 3 month public submission period". We are concerned at what is missing in this process, based on the experience with the equivalent part of the consultation process over the Jurien Bay Marine Park which was misrepresented to many people.

The review of the public submissions is closed and within CALM / MPRA and therefore liable to claims of bias and selective interpretation of the submissions. We do not believe this process delivers what it appears to promise. Without the process being open, it is not acceptable to many people.

The Indicative management plan can be changed considerably and offered to the Ministers without any opportunity for the public to know if or how their submissions were used. It is claimed that a summary of submissions is also made available to the public. We agree this should happen, but it has still not been completed for Jurien Bay even though the Park was dedicated over 5 months ago.

The process needs to be changed to require the release of the final proposed version for public information before any version is locked in by gazettal.

We expect that the residents of W.A. will know what is proposed before it is submitted to Parliament and applied. That is real transparency, and it is as expressed in CALM's Public Participation Policy http://www.calm.wa.gov.au/calm_public_participation.html , which says:-

- 4. The participatory process will be objective, open, fair and carried out in a responsible and accountable manner.
- 5. Public participation processes will emphasise the sharing of information, joint learning and understanding.
- 6. Data and information used in the decision making process will be available to stakeholders, and
- 10. Participants will be informed as to how their involvement affected the Department's or Government's decisions.

Composition of Coral Coast Parks Advisory Committee (CCPAC).

The MPRA and CALM appear to have opted for a process in which they use local supporters of a proposed park, with strong philosophical support for the CALM process, and do not engage in general consultation on the wider issues which arise when there is formal stakeholder representation. The recreational fishing sector will be impacted upon by these proposals to the greatest extent, yet the peak recreational fishing body has been excluded from the formal process.

As previously elsewhere, it appears to the Association that the opinions of a limited group, including the CCPAC, have been used in lieu of good scientific information.

While the Association recognises the need for significant local community involvement, the Marine Park is a resource for the entire community and the importance of a strategic, State-wide outlook must not be overlooked especially when visitor interests are extremely important as at Ningaloo.

Public Consultation.

The Association strongly supports the decision to release this proposed zoning scheme for public comment prior to preparation of the formal draft plan for formal public consultation. We understand the multi step process and the early stages of the Ningaloo proposals.

However, the Association believes this places an unnecessary onus on recreational anglers to argue against proposals which appear to have already been decided and which have a significant impact on their access to areas in the Marine Park.

If necessary, anglers have to try to convince a committee that the areas should be changed, instead of having a say in the choice of the areas in the first place.

Impact of Removal of Pelagic Species.

The Association questions the impact of catching the common pelagic species in the numbers taken from some of these areas, compared to the total number taken in the region.

We understand that MPRA / CALM want to be able to adjust management to suit the circumstances, but these only ever seem to result in increased restrictions. We submit that flexibility needs to be a two-way process, and must include restrictions being removed or relaxed if they are later found not to be necessary.

Would we be given a guarantee in the management plan that if no research is done, or if the research can't address that issue, or if the research shows that any change in the ecosystem from removal of the pelagic species is ecologically sustainable and insufficient to justify the ban on recreational line fishing from the shore, that areas will be reopened to that sort of fishing in the next review in 10 years time?.

Proper management of fish can include timed closures, area closures, species bans, limits on the gear used, or combinations of these for spawning or nursery areas, areas/species under too much pressure, areas set aside for special purposes, etc. but these must all be justified by research and data which shows that these are right and necessary and will actually be effective.

Specific responses to proposed zoning changes and additions

The only information available about the proposed areas is as shown on the A3 sized maps with very little details of the exact locations of the boundaries or the size of the zones. Any comments on this draft are subject to additional comments when the exact details are provided.

Point Murat. The Association has no strong objection to this proposed extension. The objectives for having a closed area around the jetty itself should be explained and listed, and the maximum possible length of beach should remain open for fishing from the shore. The distance from the jetty where fishing is not allowed should only be the minimum necessary to achieve the stated objectives.

Bundegi. The Association supports a small extension but without adequate explanation of the reasons for or size of the proposed extension, we are unable to comment further.

Lighthouse Bay. The proposal to establish a sanctuary zone of the size proposed closed to fishing in Lighthouse Bay is strongly opposed. This would have a high social cost as there are a variety of users of this area. It is popular for shore-based fishing due to the proximity to a major caravan park patronised by many Western Australian, interstate and overseas visitors.

Jurabi. This proposal is opposed. It is an area of the park which is close to visitor accommodation and a boat ramp and has high amenity value for recreational fishers. We wonder why the area proposed is taken only from the existing recreational area and does not include any of the deeper water in the General use zone, yet the Management Plan seeks to address "poorly represented in the northern section of the Park and in the deeper waters" (page 8).

Tantabiddi. The Association is opposed to this proposal. It is extremely close to the boat ramp at which quite small boats are launched to fish in the safe area near the boat ramp. There does not seem to be any logic in proposing this area as a sanctuary zone, particularly in the absence of any scientific justification. A more specific explanation is required.

New Zones. The Association is opposed to restrictions on shore based fishing in almost all of the new zones proposed, including all zones in the proposed extension. The Association sees no reason why the low impact

activity of shore fishing with a rod and line should be excluded from all these areas without explanation and justification.

Other proposals. The Association has no detailed comments on other proposals at this stage as outlined earlier, other than to object to the seaward extension of zones beyond the outer reef without further justification.

There is little justification for the expansion of current sanctuary zones seaward. Using the paper by Westera & Hyndes (2001) as one of the reasons for the extensions is ludicrous. To suggest that areas would provide the "potential" to protect a single genus of demersal fish by closing an area that may represent habitats "often" associated with spawning sites does little to justify the extension.

Overview of response to proposed zoning scheme.

- The CALM planning process continues to ignore fisheries management as a tool to maintain ecological sustainability of fish catches.
- There is a critical need to establish an understanding between the Department of Fisheries and CALM regarding marine parks in general and Ningaloo in particular.
- It is imperative that fisheries management be involved as an important component in the planning and management process for Marine Parks.
- The Townsville Declaration on Coral Reef Research and Management must be put into context as being largely concerned with addressing problems associated with subsistence fishing in underdeveloped islands of the Indo/Pacific region that are predominantly void of any realistic recreational and/or commercial fishery management, and may not apply to Ningaloo Marine Park.
- Zoning by itself is not the solution. There is a need to recognise that zoning is only one of the management tools available for natural resource management and that other fisheries management tools have been successful and strongly supported by recreational anglers where there has been meaningful input into their development.
- Zone changes have been proposed in the absence of scientific data to support those extensions. Information from the few scientific papers referred to have largely been taken out of context and in particular do not justify the seaward extensions of sanctuary zones into deeper waters.
- Even fourteen years after the establishment of the Park, a precautionary approach has been adopted without any significant use of the experience gained over that period.
- There is urgent need for strategically planned and ongoing scientific evaluation to become part of the process.
- Boundaries need to be clearly marked and readily identifiable for understanding of their extent.
- The Committee must understand the importance of developing a zoning scheme that is appropriate, practically
 feasible and socially acceptable to users of area and supported by the wider community. This follows one of the
 Strategic Objectives as set out in the framework Paper namely "To facilitate and manage recreational activities
 in the Park within an equitable and ecologically sustainable framework."

Conclusion.

The Association is not satisfied with this review process which has excluded adequate recreational fishing representation, and has not justified or explained the proposals.

This review of Ningaloo Marine Park appears to have ignored the proper role of fisheries management to the objectives of the Park. Although current fisheries management is not all it should be, closing more areas is not the solution.

It is suggested that the consultation and coordination with the Department of Fisheries would lead to a better outcome. The Association believes the government should ensure that such an integrated approach is used.

The Association requests that a different committee which properly represents the range of stakeholders be asked to consider the submissions on the Proposed Zoning Scheme and to assist in completing the Draft Management Plan for formal public consultation.

Hardy Inlet Estuarine Fishery Options.

Department of Fisheries has released a paper titles "Hardy Inlet Estuarine Fishery Management Issues and Options" as Fisheries Management Paper Number 169. It is available from their web site at http://www.fish.wa.gov.au/comm/broc/mp/mp169/index.html or a paper copy can be obtained from the Department of Fisheries. Public comment and submissions on this paper close on 3 May 2004.

The saummary says "In November 1999, Fisheries Management Paper No. 131: Management Directions for Western Australia's Estuarine and Marine Embayment Fisheries - A Strategic Approach to Management was

released for public comment. Submissions made to that paper highlighted a number of matters specific to the Hardy Inlet Estuarine Fishery.

To further ascertain the key issues facing the future management of the Hardy Inlet Estuarine Fishery a number of key stakeholder group meetings were held in December 2002. Present at these meetings were members of the South West Recreational Fishing Advisory Committee, the Molloy Island Home Owners' Association, Recfishwest, the Western Australian Fishing Industry Council (WAFIC), the commercial fisherman, fishing tour operators, local fish retailers, Augusta Margaret River Shire Councillors, the Editor of Fishing Western Australia (WA), the Editor of Western Angler, a Murdoch University scientist involved in the black bream re-stocking program and Department of Fisheries researchers and compliance officers.

The purpose of the stakeholder meetings was to present the most recent information regarding the fishery, and determine which matters needed to be addressed to facilitate acceptable management arrangements. A summary of the matters raised is provided in Appendix 1.

The two key fisheries matters arising from the meetings that became the focus of this paper are:

- The sustainability of black bream stocks; and
- Sharing the black bream resource between the recreational and commercial sectors, specifically in the Blackwood River.

These discussions have highlighted the relatively recent emergence of black bream as an "icon" recreational species. Two fishing tour operators ("fishing guides") have commenced operations in this area in the past few years; more recently, bream fishing competitions, predominantly catch and release, are attracting a small band of dedicated competitors. Black bream have also been historically targeted by commercial fishermen during the winter months and provide the sole remaining fisherman with his primary source of income in those months.

This paper presents information available on fish resources in the Hardy Inlet/Blackwood River system, and discusses the key management matters and likely impacts of a number of possible management measures.'
