

Kalbarri House For Rent.

February Dry Casting Report.

First day in the saddle after Hendo's departure and it looked like a typical summer pattern dry casting day, but where was the wind? On my arrival at Yokine the sky was blue, the temperature mild, and everything looked great.

Got started putting gear together and Nic turned up, and so did the damn wind. SO, if anyone wants to blame someone for the wind, this month it is Nic's fault.

A south easter pushing into our faces initially caused a little consternation, as the nine casting seniors were first up on distance. With the format now following the State and National AAA sequence for casting, the 56 grams looked like they wouldn't be going too far. Most casts in the 120-130 metre mark with the exception of one at 153 metres. 54 casts between these guys in that wind and only two casts were out of court and one break off. I think that is a pretty good result.

The most pleasing aspect of the day in my mind was the distance casting of TT1. A slight modification to his technique and his distances not only improved, but he got ALL six scoring casts down the centre of the court. WELL DONE Buddy.

Not being in the company of the veterans I can't comment too much on their day. However I can say a very BIG welcome to Peter Osborne. Peter has not been casting for a period of years now, but on his return, it was like he has never been away. Longest distances in the 112 gram and Artificial Bait, along with highest points in the single handed accuracy are a fair indication of his capabilities and the competition he brings into the ranks of the veterans. Tony was his usual impeccably accurate self, top scoring the D/H accuracy with 154 points.

I think we might have to get Gilder's to step out of the seniors into the veteran's area and give Tony some competition. He has been a veteran now for some 3 or 4 years.

Geoff Raftis' shoulder started giving him some trouble and he was not able to complete all the casts. All in all a good day was had by everyone except for one silly bugger. Me. I didn't put any sun screen on and wore shorts. Now as I sit typing this report, the sunburn on the back of the legs is excruciating.

A little note. After everyone had gone home, George and I stayed around a bit and had a few extra throws. George was putting the 112 gram well out over the 190 metre mark. For an old cripple with only one good leg, this was impressive to say the least. Mind you, by this time the wind had turned and was in our favor somewhat. Still a great effort.

February 2005 Recfishwest Board Meeting.

Here are some of the main points from the RFW Board meeting on 9 February.

Recfishwest has not received any response from the Greens to RFW's Election Policy questions. The Coalition's Environment Policy is still awaited. Labor's Environment Policy and Fisheries Policy are still awaited.

WAFIC have objected to some of the fish size limit changes as proposed in the South Coast and Pilbara/Kimberley recreational fishing reviews.

RFW has been advised that the Hillarys Yacht Club will take up the issue of congestion and changes to parking arrangements at the Hillarys boat launching ramps. Jim Penn from Department of Fisheries has written a letter about the problems.

Department of Fisheries has written to Recfishwest agreeing with most of the points made by AAA in the review of the filleting at sea regulations.

Terry Fuller will provide a summary of the Recfishwest board meeting similar to these notes for publication on the Recfishwest website for a trial period of three months.

Recfishwest is to write a letter to all radio stations offering Frank Prokop to be involved in a recreational fishing show. Frank Prokop to offer to write a column in the Western Fisheries magazine produced by the Department of Fisheries.

Some Recfishwest policies have been reviewed and will be considered for adoption at the next board meeting.

No RFAC meetings have been held because their term has expired and no new appointments have been made by the Minister and cannot now been made because of the election. RFAC unlikely to be able to make submissions to the Integrated Fisheries Management process because the legislation does not allow the chairman to continue until he is replaced or reappointed.

The Rottnest Island Marine Management Working Group is continuing with problems. Two members with recreational fishing experience did raise the possibility of special reduced bag limits at Rottnest Island for scale fish, but there is a question whether this will appear in the draft strategy, or indeed if the draft strategy will collapse.

The State of Environment Marine Committee has been dealing with water quality so far. Have not yet dealt with biodiversity. There are several specific committees, and Dr. Howard Gill has been recommended as Recfishwest representative on the fish committee.

The aims and objectives of the Recreational Fishing Alliance were outlined, and the differences between what that group could do and what Recfishwest would be prepared to do were discussed.

Changes have been made to the intake and outlet pipes for the Desalination Plant, moving them 500 metres towards the shipping channel. Fremantle Ports are not happy, and the design is being reconsidered.

The Fremantle Ports representative offered to discuss the impact of the proposed Outer Harbour on recreational fishing use of Cockburn Sound. There was discussion on having fishing platforms under the bridge to the reclaimed areas and they wish to have Recfishwest input on these.

The proposed boat launching ramp at Rous Head was discussed but there is some confusion about the proposed location, following on from some comments from the Fremantle Ports representative about their concerns.

John Baas reported on Integrated Fisheries Management and Native Title issues for Western rock lobster allocations, based on the difficulty of getting any catch data.

The issue of commercial rock lobster boats operating in surf break zones on the southwest coast has heated up, with the commercials trying to include recreational anglers in the restrictions, and turn this into a resource sharing issue. Recfishwest has not made any public comments on this issue. An independent mediator is required.

Frank Prokop reported that it has been very busy and successful few months for Recfishwest and the impact in the lead up to the State election is good for recreational anglers. Colin Barnett specifically mentioned recreational fishing in his speech, and Dr Geoff Gallop made a categorical statement about no take zones at Rottnest. The Fisheries Minister and Tourism Minister are both very happy.

Other examples of where Recfishwest and recreational anglers are well recognised was at the launch of the Tsunami appeal, where the introduction was "everyone knows Frank Prokop without whom no fisheries management changes would be possible" and "Recfishwest, without whom this appeal would not be possible"

Commercial fishermen have been warned to be aware of the recreational fishing position or risk being irrelevant in management changes.

A meeting was held with the Marine Conservation Committee of the Conservation Council, where the standing of recreational anglers was acknowledged, unwittingly. There is some recognition that they need

the support of recreational anglers to achieve their aims, and that the radical statements of some hard liners are driving middle Australia away from the conservation agenda.

Recfishwest has the go-ahead to move to the Waterman's research building when it is vacated by the Department of Fisheries midyear.

The Recfishwest Board has approved in principle subject to some funding being received, staff changes and increases to handle Integrated Fisheries Management, Natural Resource Management, increases in the Fishing Clinics, and administrative workloads.

Recfishwest will prepare a major submission on the Fisheries Management Papers 189 to 191 dealing with the Wetline Review and allocation.

A Recfish Australia meeting was to be held on 10 February to discuss the recreational only status for Northern bluefin tuna as promised in the Federal election. There are some problems with one Recfish Australia person contacting commercial fishermen and affecting the negotiating position.

Recfishwest will raise the issue of the Recfish Australia representative on the National Oceans Office marine strategic planning and policy committee.

Recfishwest will raise the issue of the recreational fishing representative on the Marine Parks Reserves Authority after the election of the new government. The current appointment expires December 2005.

There is some concern that the investigation into the Coral Bay boat ramp between Monks Head or North Bills Bay will not be thorough and unbiased.

Samson fish tagging off Fremantle has concluded with 2700 caught, tagged and released, and will now move into the recapture phase. The weather has been unkind and windy. There has been a lot of support and a lot of publicity for this work, which is seen as a lead for getting the techniques for research into spawning aggregations of other species.

Garden Island Field Day 16/17 June 1962

Weather conditions:- North - Westerly, backing Northerly by the morning. The beaches were in reasonable state, though several of the bays on the northern side were heavily weeded and for a change, the spotlight centred on the northern beaches down from the guns.

Twenty seven members, five juniors and four visitors, plus four junior visitors made a total of thirty nine, which was quite a good attendance considering the inclement weather.

Eight members journeyed over in the early boat and the remainder of the lads packed the late boat. No doubt they had been watching and hoping that the weather would hold out, which fortunately it did, though of course we did have a few heavy showers during the afternoon and evening.

"Snow" Tate and Allan Livesey decided on a change of venue and settled in near the rifle range, where they had heard the skippy were plentiful the week before, and they sure hit the jackpot, for the bag of skips they weighed-in certainly caused gasps and praise from all members present. After the weigh-in we took a photo of the catch. Allan just missed the heaviest bag of scale fish by four pound.

Mick Doscas and Bob Tichbon decided on the south end when our runner, Ron Shirley, reported in with the news that several of the northern bays were filled with. Weed. Allan and "Snow" did the right thing by giving the south away for most of those who fished the rocks fished for nought. For all that area showed in the fish bags of those who were there were a few herring etc.

Bob Lilly and myself decided on a tour of the northern beaches and reckoned that we may be there at just the right time. So off we went at a brisk pace. Soon the gun appeared in view and we were soon on the beach which looked excellent, good deep water and the complete absence of weed, which certainly gladdened our hearts.

Having set up camp we rigged up, though several heavy showers sent us running for shelter. After ducking and dodging several showers and with the approach of field day time, we thought "to hell with it, lots get fishing'. About three forty five Bob went into action and in a few minutes had a good sized Mulloway up on the beach. From then on the game was on with a vengeance. Almost as fast as we could feed them mulies, the Kingies were taking the hook.

The Tailor came on the bite just after six o'clock, rather small, though some were up to two pound. Bob did land one Tailor four pound. As Bob was working his fish in through the surf, I was busy with a six pound Kingie. I was using only fifteen pound line - I had meant to change spools but with the fish coming on to bite I just didn't seem to find time.

The sort of thing was happening that you always hoped for and I wondered how we would be able to lift them, let alone carry them back to base, and it came to pass that when I cast my rig away, I welcomed the

break as the means of having a rest while I put on a new one. As we would cast a Mulie, with a savage grab they would pick up the bait and swim parallel to the shore which meant that we had to bring them in across the surge - which took no little effort.

Bob was in his element and did not give them an inch, and holding the rod upright, reeled for all his worth. My arms were aching with the unaccustomed effort, though I really did not mind. It did not seem to worry Bob. It really was something.

Shortly after nine o'clock we started to gather up the fish and what a shock we received, for the bags were packed tight and at our first attempt we failed to lift them off the ground. Using our rods and taking a chance we eventually managed to get mobile. I don't know how we really managed to carry our fish, plus gear along the beach and up the hill to the gun site. Under summer conditions I'm sure we would never have made it. At arrival at the gun our bags packed up and we were forced to leave our gear and try to carry our catch back the best we could. What a journey - we made many a stop along the road back, at times I thought that that ribbon of road was elastic and was stretching and we would never make it at all. But with perseverance we eventually made it back to the hut. At one stage we had to retrace our steps for we overshot the track in - as if the walk wasn't far enough.

Entering the hut via the kitchen it only took a matter of a few seconds for the news of the catch to bring quite a few of the lads out of their warm beds to see the two strange characters who had just shattered the silence and who looked and smelt like the Mulloway they were carrying, and to have a "bo-peep" at the catch. Several of the boys, after many questions of where they were caught etc. quickly got "fish fever " and with a scramble of gathering gear together, Norrie Cross, Doug Savage and his mate, Nick Crouch, Hal Neil, Charlie Crouch, and there might have been several others were off on the run. This was at about 12:00 a.m., to try their luck at the area we had just vacated, for we had told them that the fish were still biting when we left, and as we had jettisoned the Mulies we had left into the water, when we started back, the area should be pretty well berleyed, and there should be no reason to believe that the fish would not be still there.

These lads are certainly keen types - getting dressed and going off to try their luck after already putting in about eight or more hours fishing, and I am pleased to say that their effort wasn't for nought, for several of them caught fish in the "hot spot". Norrie Cross was all smiles when he weighed-in his three Mulloway, and he remarked that at long last he has caught a reasonable sized fish at Garden Island. Doug Savage's 61/41b mulloway just pipped the 61b one I had caught earlier, which just goes to show that there is always a bigger fish in the sea.

Down south at the Ledge, John Griffith, Doug Newton and the other lads fishing there had a lean time of it as the Tailor -and Mulloway were conspicuous by their absence by way of a change, for they have in the past caught good fish in that area. Also the "rifle range" produced very few fish, though of course the hole just north of the "rifle range" where .Allan and "Snow" fished, paid off very handsomely. Further north again where Bob Jensen and his party usually fish was also practically non-productive, except for one Salmon and an odd Tailor or Herring.

There was much activity at the weigh in as many of the boys waited to see just what fish would come in from the various centres. Ron Shirley was in a state of shock when he observed all the Mulloway and the heaps of Skips. It has been reported that he was last seen and heard talking golf.

The trip buck top Palm Beach had many thrills, and the lads down the back of the boat who were nice and dry, got nice and wet when the skipper nearly got into trouble trying to tie-up at Palm Beach, and had to back the boat into the sea to make another approach. For a while there it appeared as if we were going under the jetty as the strong sea and gusty north wind made its presence felt, but after other like incidents we eventually made it and finally disembarked, and with sighs of relief headed for our various vehicles with our rods and gear.

(To those of us who missed out on fish I would like to offer my thanks for a hand-out from those who were more fortunate and did catch some, because it is certainly nice to arrive home with a fish even if you didn't catch it yourself. Such gestures go a long way to cement an already solid friendship with one member to another, even if he isn't a constant fishing mate, and helps to make this Club of ours stronger than it already is - Editor).

So closed another field day. To the award winners I would like to offer my congratulations and many thanks for the help I received at the venue.

It was pleasing to see the juniors appearing in larger numbers. One lad remarked to me that he had had the time of his life and that the fish he saw at the weigh-in certainly amazed him and that next time just can't come quick enough. So look out you Dads.

The next field day is to be held at Garden Island also, on the 14th and I5th July. Boat timetable is 9.30 a.m. and 2 p.m. from Palm Beach, Saturday. Departure time from the Island Sunday 10 a.m. If possible endeavour to have correct change - 5/- hut, 2/- sweep, juniors 2/6 hut.

Weigh-in to be at 8 a.m. to 9 a.m. only, Norm Clark or myself to attend to this matter. Field day time starts for fish captures at 4 p.m. Saturday to 8 a.m. Sunday. Jim Strong F.D.O. 1962

Garden Island Field Day 14/15 July 1962

Weather conditions:- North to North-West winds, heavy rain during the night and early morning. Northern beaches heavily weeded - though further North (gun position) the beach was in a really excellent condition with a low tide, and once again the interest centred around this area, which appears to be getting very popular with the lads.

Twenty eight seniors and nine juniors made the crossing to the Island which was quite a fair attendance considering the inclement weather. During the week many lads phoned me and advised that owing to flu and colds etc. they would not be able to attend the venue and I thank them for letting me know and sincerely hope that they will soon be up and fishing again in the near future.

This was quite an amazing venue - for a number of the South-end stickers changed coats and visited the Northern waters in an endeavour to knock off a few Mulloway, and it is good to see the boys moving around, though evidently a few of the lads, Lofty Griffiths, Doug Newton and his boys and Joe Kuba decided that a little bit of the North goes a long way for they later returned to the South end, evidently looking for the elusive Tailor and Salmon.

There was quite a constant procession up and down the beaches, as the lads visited the various bays etc. Phil Neri, Gary Davidson and myself started the ball rolling for after looking over the gun position we strolled back down South as far as the first bay, however, all these bays were heavily weeded so we returned to the North, and on the second time round Doug Newton remarked that if we passed him again he would go crazy and follow us. Little did he realize that we were only the forerunners of many groups of the boys who got walkabout fever.

I noticed a new member, Joe Kuba in action who is a very keen angler and it was pleasing to see him on the venue, and he landed several good sized King George whiting from a hole alongside the reef from which he caught quite a few Mulloway several weeks ago.

We also met "Tiger" Lilly, Ron Kildahl, Hugh Gregory, Ted Savage, Bob Tichbon and George Greenham who were preparing for the night's fray with the fish. Though at this time they were sitting around a fire having a brew and a chat about recent fish captures and other lies. Also with them was another new member in Jerry Windus.

Having said our Hullos, Good Luck and Goodbyes we returned to meet the second boat boys as they came over the hill. Norm Giles, Bob Tucker (flu and all - can't keep a good man down said our President Bob), Norm Clark, Tom Backhouse and Tom Smith and it wasn't long before we were one happy gang of merry anglers all ready to tangle with the big ones.

Tom Smith, then Gary Davidson showed the way with nice sized Mulloway, and then Tom Backhouse landed a nice 5½ lb Mulloway. Norm Clark followed suit and soon had a Mulloway flapping on the beach, then not to be outdone I landed a Tailor, but suddenly the fish went off the bite, just when things were starting to get interesting.

In the meantime Alf Rutland's party joined Doug Newton just around the corner of the reef. Further south Bob Jensen got on the move north and had his party coming our way looking for likely spots. These boys started from the rifle range and walked right around the beach to join up with us. Doug Newton gave up fishing and became guide and social organiser, and he remarked that he has never met as many anglers on the beach before.

There was new interest as Ron McQueen landed a fine Mulloway and Alf landed several Tailor. While this activity was taking place, Charlie and Nick Crouch fished on in the second bay. Weed or seaweed they are stop-put boys. It takes more than weed to deter them - with the result that Nick landed a Tailor at 4³/₄ lb out of all the rubbish that was in the water there which was no mean effort on Nick's part so off goes another section to a new holder. Don't Blame the Blade - Reel Talk July 1962

How often have you heard a mate complaining or saying "This darn thing wouldn't cut butter" or some such like remark, which in most cases it isn't the knife itself that is at fault, but the task of sharpening same was not done properly, or not done at all. For although most of us use a knife every day of the week, and more often on fishing trips, rare indeed is the bod that knows how to sharpen his knife properly, which can effect a saving in time, effort and most important of all - temper, and it is invariably the blunt knife which cuts its owner. This is mainly due to the fact of the knife not cutting in to the material, .but because of its lack of ability to cut, it slips - and out comes the band aid.

There are only two basic rules for proper blade sharpening. First, bevel the cutting edge down to a gradual taper and secondly, make the finish of the edge agree with the type of cutting you expect to do. The first rule is merely an application of an ancient physics principle, but has caused more or a greater loss of temper and wholesale discarding of knifes than all the faulty metal produced by knife manufacturers.

This principal is aptly illustrated when you stick an ice pick and a wedge in the ground. The pick slips in effortlessly, because it offers less resistance to the ground, while the bulk of the wedge forces you to exert a great deal more pressure to push it into the ground. Now picture the same effect in the cross section of a knife blade, but magnify it and you will see why you had so much trouble trying to fillet that fish, and why a razor blade could cut so readily.

Most knifes are machine sharpened before they are packed for sale and the resulting edge is a perfect illustration of how "not" to sharpen a knife. The blade tapers down only slightly towards the cutting edge and then goes into an accentuated "V" edge that can hardly be forced into the material to be cut.

Then, to further aggravate the conditions, when you do sharpen the knife, since it is easier to simply sharpen the actual cutting edge, we grind it into an even wider "V" and the knife gets progressively and more rapidly dull.

If, when you sharpen a blade, you take that little bit of extra time and energy required to grind the "bilge curve" just above the cutting edge and so make a blade edge that gradually tapers into the cutting edge - you will be repaid your energy and effort many times when the time comes to use the blade.

The second sharpening rule is to keep the degree of the cutting edge to the type of work you require it to do, and as most of us require a very fine and sharp edge, the degree of taper to the edge must as a consequence be fine. A knife cuts because of the multitude of minute saw-tooth serrations that make up its cutting edge. Magnified, your blade looks like a saw, and the size that these teeth should be is determined by the taper you require or work you are going to do with the blade.

This degree of edge finish will be determined by the coarseness of the sharpening stone used. The most desirable sharpening stone is the two texture type oilstone with a rough and fine side. The coarse is used only for rough grinding and for beginning the proper taper. The fine side of the stone is for finishing after the proper taper has been obtained. A light machine oil should always be used on the stone since it fuses the abrasive around the face being sharpened and gives the blade a smoother, finish.

After your knife blade is sharpened to your satisfaction, it should be finished off on a piece of leather. An old belt or leather strap will do once it has been smoothed down by a few strokes of the knife. Strop the blade in one direction for each side only. The degree of sharpness of your blade can be tested quite easily by holding a strip of newspaper in one hand arid dragging the knife lightly across it. If the blade catches and, rips the paper, the finish is too coarse and should be stropped or sharpened to a finer degree. If it makes a clean slicing cut through the paper the blade is ready for any cutting job including shaving. (Though I wouldn't really recommend it).

Both the coarse sharpening and the preliminary fine sharpening should be done with a rotary motion of the blade and with the blade slanted away from the stone enough to give a long tapering cross section to the blade. Begin at the blade tip and work slowly back towards the handle, always keeping the same constant circular grinding motion.

Each time you sharpen your knife maintain the same taper by grinding off metal towards the back of the blade. If you get lazy and cut down the taper angle, you will only pay for it later when you cut with the knife - by finding that the edge quickly loses its cutting ability, and you have all the work before you again by bringing your blade up to how you really want it.

The final fine sharpening strokes should be in one direction, towards the cutting edge - in order to avoid a fuzzy edge which comes when your cutting edge is coming to its sharpest point. You can feel its fuzzy edge by running your finger or thumbnail towards the edge of the blade. The two essentials to keeping your knife sharp are to keep the bevel angle small and to finish the sharpening on a very fine oil stone or leather. To verify these two simple rules, the next time you are at your hairdresser, ask him and I am sure he will demonstrate to you quite readily what the rules of taper and leather stropping do to a blade edge, for if anyone has to have a sharp cutting instrument it is the hairdresser.

I would suggest to all members that when they go angling they carry two knifes. I have done so for quite a while, and I find it most useful. One I carry in a sheath which is razor sharp and never used, unless I really need it - which invariably happens because I always seem to be losing or misplacing in the dark the other. The second knife is a small, flat bladed knife, which is just as sharp at the beginning of an angling jaunt as the other but by constant use, cutting bait on sand covered boards or stone etc. etc., at the end of a fishing trip usually finishes up with the edge taken off it. But by sharpening as had been mentioned in this article, neither of these knifes take much of an effort to bring back to good order.

<u> The Trip - Part 1.</u>

A farewell cooked breakfast with my son Matt, his partner Fiona and my old mate Terry Willison gave us the time for those last few words before we hit Highway 1 on our trip around Australia. As we left the Metro area there were signs of a hot day ahead with a strong southwesterly breeze.

By the time we got to Regans Ford and caught up with my brother Ron and his wife Nisi in their old khombi, the temperature was rising. We headed for Jurien via the Cervantes Road but turned off at the Hill River development Road and headed for the beach parking area. The temperature gauge read 44 degrees C.

Straight into a cool ocean did we go for a swim, no breeze but the sun sure had a bite to it. As we set up an overnight camp (what sign?) a few locals turned up and spent an hour or so chucking in a line with only a couple of rays as the result. The only female decided to have a go and on her first cast caught a 38

centimetre yellowfin whiting which was as thick as my wrist. Hooping and hollering and parading around that fish shrank five centimetres and lost half a kilo due to the heat. Why it even was partially cooked. Mumbles of frustration from her male friends and the next thing they packed up and were off as the sun went down. To hell with fishing said I and downed another coldie.

Around 7:30 pm the southwest wind picked up and we had a blustery night. An early morning swim and we packed up and headed into Jurien to refuel and ice up. Moving on we had a stop at Green Head and Leeman. (So bloody hot again.) Checked out a couple of roadside camp spots near the squatters shacks and decided to continue on into Port Dennison. Somehow we lost contact with the khombi and after a lot of back searching got an SMS message that they were in Greenough. Caught up with them and booked into the caravan park.

Thought we might try to put a line in, but was very disappointed as the water was very murky and full of seaweed and a 25 knot southwest wind. Oh well, we did the touristy bit in Geraldton, agreed that my brother would join us for a few more days - I was his backup if anything went wrong with the khombi - and it went well with a tailwind.

So on to the 440 to refuel then into Coronation Beach for a looksee. Bloody wind, blasted weed and 20 odd parasailors and sailborders of all nationalities. The smell of rotting seaweed had us moving on towards Port Gregory. Stopped at the Hutt River mouth and decided to inspect the area.

"What no camping sign, we were only parking to have a look around" I said to the ranting and raving local land owner as he insisted we nick off. "Bloody mongrels rubbished the area, light fires and ruined the place" he said. "None of the above" said I, Mr Nice Guy here and the more I grovelled and that third can smoothed things over.

The ocean was a mess so the beach umbrella went up and we had a fishing competition for bream in the River. A few undersized fish were landed and released, a camp was set up and another windy night had us up early for a walk to the beach to toss in a line. Two hours and not a bite so a pack up was made, we ventured into Port Gregory, spoke to some other holidaymakers, got stories of woe, lots of wind, no fish and lots of heat. So decided to try Lucky Bay - big mistake.

Amid the sand hills there was no breeze and the temperature soared. On the beach it was howling and sandblasted your tan off. More tales of woe and we were out of there and into Kalbarri. A bit of shopping, we refuelled then had lunch and a swim in the River. The conditions were the same all over the place, a discussion took place on what, when, where, and why and we headed out to Highway 1 and onto the campsite at Galena Bridge at the Murchison River crossing for the night.

The first five days on our trip have seen us put up with temperatures around the 40 degrees C mark, continuous gusty southwesterly winds, and no let up in sight. Still I am not complaining because the car and caravan's air conditioners are working a treat. My brother's Aussie Air was not up to scratch when his water got warm.

On to the Overlander for fuel then in towards Denham but a stopover at Whalebone Bay was agreed. A reasonably sheltered bay with skinny water but a good place for a dip. The tide was out so a walk around the rocky headland and I noticed some dark shapes about one metre long in ones and twos cruising close to shore. A race back for rod and assorted lures had my heart thumping. No matter what lure, how I approached them or whatever, every time that lure came close they would streak for deeper water. I would have disturbed at least a dozen of the sods with not an ounce of luck, but I did not recognise the buggers, they were cobia and my gear came very, very close to following them into deeper water.

Reasonably sheltered did I say?. Pigs b.., that southwesterly came in with the blast around 7 p.m. and blew all night. Oh well, into Denham in the morning, into the caravan park, a walk around the foreshore, and a visit to the jetty. Weed, weed and more weed. Tried to have a fish that night but not a bite. Still we did end up six good sized squid.

So we played the tourist and went to Monkey Mia for the morning, toured a bit around Denham and sat back and a relaxed. Tales of woe because of the heat and the wind and I consoled myself with the coldie or seven.

Carnarvon was the next stop but we headed for a spot called "New Beach". A track led us to the edge of a mangrove section with a nice little run off creek. As the tide was out, it gave us a chance to tour the skinny waters around the area. The gentle breeze, the refreshing dip in the creek, a shady spot to camp and we were contented.

As it got dark the tide started to move in so it was a good place to give the females some fishing lessons. A few small longtoms, a sand whiting and a couple of "dem things" gave us some enjoyment. All caught by the females.

On a single handed four kilogram unit Leonie hooked up and played a fish for at least 15 minutes and landed a spotted or leopard ray of about 1½ to 2 kilograms. Photos were taken and the fish released. Me, I caught nothing.

The next morning we ventured into Carnarvon and into the caravan park. As the weather was the same here, we played the tourist. We used the train to go out onto the jetty and cleaned up our gear. A stroll *Reel Talk March 2005* Page 16

around the back streets saw us collect a couple of dozen mangoes which had fallen off the trees and onto the roadside verge. It took another six days of coaxing them to ripen individually.

A drive out to Miaboolya Beach, just like Lucky Bay, some discussions with people heading home from Quobba and Coral Bay, tales of woe everywhere about wind, weed and no fish and my brother said he had had enough and headed home the next day.

We stayed an extra day, decided to give Quobba, Waroora Station and Coral Bay a miss and will head for Onslow. Surely the wind must abate up here some time.

Samson Fish Tagging Snippets

Report for 3 Feb.The aggregations fished well until about 9am when all went quiet, but still heaps of fish on the sounder. The boys aboard Splash II, for example, had tagged 25 by 7.30am but ended up with only 32 for the day.

We fished all schools plus some other sambo patches that had not been fished for a while. Still all poor but plenty of fish on the sounder. We knew something strange was up.

Saw a navy boat towing a target about 11am then a sub popped up about 4 miles off westend about an hour later. Those fishers out there today would have also seen two jets scream over at about 9.30. Seems the war games may have disrupted the fish big time (high powered sonar maybe??). Apparently it happened last year as well. Food for thought.

Numbers. They are still a way off getting all the data entered, checked and analysed but they think they'll end up with about 2700 fish tagged. A very credible effort in spite of all that nature and (possibly) navy could throw at them.

The project is more or less on track. With the 5 day extension to the tagging period the recapture period will now run from the 10 - 20 February but the finish date may also be extended.

Recaptures. One recapture off Hopetoun already!!!!!!! Yep, 900km in 3 weeks.

Samson fish double tag 46491 and 46492. Tagged on the North Barge aboard Offshore Fishing Charters vessel "Top Cat" on 22 January. Recaptured on 16 Feb south of Hopetoun in 100m by Grant Martin. Fish was in good condition. It's great to see the commercial fishers reporting tagged sambos. Grant captured and reported a tagged sambo (from Rotto) to the Esperance fisheries office last January as well.

Another sambo was recaptured SW of Mandurah last week. Samson fish tag 47897. Tagged by D. Rosenbrook aboard Ian Rodgers boat Footloose on 23 January. Recaptured by Rod Willet on 12 February, 29 miles SW of Mandurah in 48m in good condition

Venting. Sampson fish are very tough and can be brought up from the deep and don't seem to suffer the blown swim bladder and bulging bits like many other species. The researchers are just in the preliminary stages of investigating this venting behaviour in sambos. The gases in the swim bladder expand as a fish is pulled up from depth. For some species the result is the stomach pushed out of the mouth (such as dhufish).

At this stage, for samson fish, is seems the gas is released when a membrane under the gill plate is ruptured. It looks like gas is exiting the swim bladder in this region. This may or may not be voluntarily, yet it seems that free swimmers (fish following up hooked fish) also release large amounts of gas as they ascend. The researchers have underwater photos of gas being released from the gill region (courtesy of Garry Lilley). One fish autopsied had a small hole where the gas was released. As for the exact mechanisms behind it all, they are unsure, but hopefully they can shed more light on this soon.

Recreational Fishing Alliance - Charter.

The Recreational Fishing Alliance (RFA) represents a wide cross-section of individuals and interest groups who believe the current marine park planning and implementation process unfairly discriminates against fishers and others who access the State's waterways for recreation.

The alliance has been formed in response to what is seen as a massive and unjustified reduction in access for fishers with potential for further erosion of those rights if the process is not halted and then managed at a sensible level.

The principal objective of the alliance is to support the rights of current and future generations to enjoy access to sustainable recreational fishing in WA's coastal and offshore waters. By definition, we strongly support appropriate and properly evaluated conservation measures for marine ecosystems.

Responsible recreational fishers should be encouraged to enjoy their pastime in a sustainable and equitable manner without having access unnecessarily restricted.

The Current Situation

Recreational fishers have actively supported a range of management initiatives in the past 15 years, many of which have been accepted on a precautionary basis. These have included a raft of fisheries management measures such adjusted possession, bag and size limits, spawning closures, reduced fishing seasons.

In recent years the increased rate of establishment of marine parks has seen a proliferation of proposals for no-take zones in key recreational fishing areas. These exceed what the recreational fishing community sees as reasonable, have been promoted on largely theoretical and ideological grounds, have little or no supporting locally relevant scientific justification, and have vague objectives which make claims that are largely impossible to either quantify or evaluate in a meaningful way.

The RFA supports well-considered well-planned multiple use marine parks. It gives strong support to the implementation of appropriate management programs where an environmental threat has been clearly identified and substantiated. Specific investigations that take into account the best available information from all sources are essential to define the nature of such threats, and establish appropriate management.

Recreational fishers remain concerned that no-fishing areas are being planned and implemented without proper review of the existing knowledge from all sources, such as consultation with expert bodies like the Marine Parks and Reserves Scientific Advisory Committee, or an objective review of the desired management outcomes and the appropriate strategies to achieve these. The current process for marine park planning ignores expert local scientific advice including that of the government's own highly acclaimed fisheries managers and scientists - the Fisheries Department, considered a world leader in fisheries management.

Further concern is that recreational fishing input into the marine park planning process is all too frequently ignored. Working groups are made up primarily from non-fishing people and many members of the marine park working groups have no accountability to a clear constituency for the outcomes. Many simple and workable management tools have been proposed by fishing interest groups and individuals, but these have been largely overlooked in preference to declaring no-fishing zones aimed at completely excluding recreational fishermen.

This current agenda to lock up vast areas, rather than find workable solutions to clearly identified and defined problems is confronting, unreasonable and unacceptable to recreational fishermen. Recreational fishers reject the Gallop government approach, which recently has resulted in significant nofishing areas being created. Examples are, Ningaloo Marine Park, Jurien Bay Marine Park, Rowley Shoals and the Monte Bello Islands/Barrow Island Marine Park.

The RFA finds it inconsistent that in the case of the Dampier Archipelago Marine Park, which is in a marginal electorate, it is proposed to remove only a small area from recreational fishing.

The Wilson Report appears to be the blue-print for further management direction of the present government. If adopted fully, other proposed parks will include The Capes region, (with massive closures being proposed); many areas in the Kimberley including the Cambridge Gulf and Roebuck Bay; Dirk Hartog Island Reel Talk March 2005 Page 18

and Steep Point; all of the Kalbarri area; the Abrolhos Islands; Five Fathom Bank; parts of Peel Inlet; several areas around Albany; Bremer Bay to Hopetoun and all of the Recherche Archipelago at Esperance. In other words, just about all of the best fishing locations in the entire State may become marine parks, no doubt with associated fishing closures.

The Recreational Fishing Alliance is concerned that the closures to date have been driven by political expediency with inadequate recognition of stakeholder interests and could roll on to affect huge areas of our coast, in particular those of greatest interest to recreational fishers.

The Solution.

The current push for total exclusion areas should be seen as a last resort for marine protection, not the first course of action. One option is wilderness fishing zones where only one fish can be taken for personal consumption and catch and release is encouraged. Many remote areas such as the Rowley Shoals should be considered as no take away zones, where fish can be caught and released or consumed on site and no fish should be taken from the area.

The planning process must involve all stakeholders including recreational fishing interests and the Fisheries Department of Western Australia. The Marine Parks and Reserves Scientific Advisory Committee, required under CALM legislation, must function correctly and be open and transparent. Critically, planners must look to achieving the required outcomes as a result of scientific analysis.

Most importantly the effectiveness of such management must be evaluated against the objectives put forward. There is a high risk that the creation of closed areas within State waters is a currently trendy political and ideological placebo which in the long-term will mask the real problems associated with human impact on the marine environment. It will also divert significant public funds away from scientific research, assessment and evaluation into high levels of compliance and management for a strategy which will ultimately prove ineffective. If you can't measure it, you can't manage it.

The RFA believes that all Western Australians are entitled to a fair go and that the state's 650,000 recreational fishers must be adequately accommodated in the marine park planning process. The current practice of locking up key fishing areas must be reassessed and social considerations must be met.

The Marine Park planning process must involve all stakeholders and remained focused on achieving defined conservation outcomes rather than using it as a tool to ban fishing in huge areas of WA's marine environment. Accordingly, the proclamation of the Ningaloo, Monte Bello Islands and Rowley Shoals Marine Parks must be postponed until a thorough review of the planning process is conducted.

A logical well conceived approach to regional marine planning already exists in Australia. The RFA supports the 1998 Strategic Plan of Action for the National Representative System of Marine Protected Areas which can be found at <u>http://www.deh.gov.au/coasts/mpa/nrsmpa/spa.html</u>

Political Parties' Policies on Recreational Fishing/Marine Planning.

The promises and commitments from all Political Parties are very important for the future of recreational angling in this State.

The statements of policy/position should be kept so that you know what has been promised by whichever Party you vote for, and whichever Party wins Government at the WA State Election on 26 February.

The State Liberal National Coalition Parties' Recreational Fisheries Position Statement was copied in the February Reel Talk, unedited, for Club members' information.

At the time of preparing this March edition of Reel Talk (4 pm, 18 February), the Labor Party's Commercial fishing policy, Recreational fishing policy and Environment and Marine Parks policy have not been released. Labor's Media Releases are at <u>http://betterfuture.com.au/media.html</u> and Policies are at <u>http://betterfuture.com.au/policy.html</u>

The Liberal Party's Recreational Fisheries Policy had some assurances about Marine Park planning, but their Environment and Marine Parks policy have not been released - a draft is around but is not yet on the website. Liberal Party's Media Statements are at <u>http://www.wa.liberal.org.au/walibs/news.aspx</u> and Policies are at <u>http://www.wa.liberal.org.au/walibs/policies.aspx</u>

I have left it to the last possible minute, but the policies have not yet been released so I cannot give you copies of them. I have given the Internet links and there is sure to be some publicity in the media when they are released.

Does anyone want to have a bet that just as I have folded and put the sticky tape on the last couple of Reel Talks ready to post them, there will be a ding from my email which will tell me that some of the policies have been released?.

So if you find a few extra pages poked into your Reel Talk somewhere, you will know that is what happened.

Recreational Anglers and Marine Parks.

If anyone tries to make out that recreational anglers are against Marine Parks and sanctuary zones because they just want free access to be able to do whatever they like, to catch as much as they want, and because they have no concerns about the environment or conservation, then ask them to consider this.

Anglers are against the push for No take zones and Marine Parks as "the" cure for all problems, without any acknowledgement that Marine Parks and No take zones should be only one part of a whole range of essential actions which when applied together in a **balanced combination** to meet the real threats in that location, will really protect spawning areas and nursery areas, and which will fix and preserve and enhance the environment and will be supported by many recreational anglers who want a good fishing future.

It is a reaction to the message by Ron Campbell who resigned over Government changes to the Ningaloo Marine Park which made a mockery of 14 months of hard work by the Coral Coast Committee. See page 14 of the January 2005 Reel Talk.

It is a reaction to a report "Premier Geoff Gallop said yesterday that the Government's chief adviser on Ningaloo was the CALM appointed Marine Parks Reserve Authority. The Marine Parks Reserve Authority are our major adviser on that matter and **we took their advice.**" Followed by a report which I have had separately confirmed by a source I trust completely which quotes Barry Wilson, Chairman of the MPRA, saying that MPRA had nothing to do with, and no knowledge of, the extra zones and increased areas that were put in by the Government.

It is a reaction to several full page advertisements costing \$11,000 each and their misrepresentation of the contents of the report "Status of Coral Reefs of the World 2004" as were claimed to specifically support what the Govt had done when it **did not**. The report does **NOT** find or identify any plans which it says are **actually needed** or it even **recommended** at Ningaloo.

It is a reaction to Recreational anglers being wrongly portrayed as being against Marine Parks, when they aren't against them except in the way we have been force fed so far - "trust us, we are scientists, we know, this is for your own good" - even though other experts including from the Department of Fisheries don't agree with the details.

It is a reaction to comments like "anglers holding out and using delaying tactics against the great body of knowledge", where we are expected to accept and apply the "knowledge" without question, even when that research used to justify the no take zones is done in very different environments with different species and different threats. After all, included in the justification used for WA Marine Parks is "the unique environment and unique species, the unique Pole flowing Leeuwin Current," etc

It is a reaction to statements about the losses to anglers being "only small" and measured in percentage of areas or length of coastline locked up, and not in the percentage of fishing spots los, which is often a lot more than the area/length percentage lost. It is a reaction to the misleading use of statistics and figures and reports.

The extra closure time of Cockburn Sound for catching Pink Snapper during November 2004 was an example where **recreational anglers** pushed for, and got, a closure to protect a spawning stock of fish, even though it cost them some good catches of big Pink Snapper.

Are some people scared at the mention of **local research** and application to the local situation because some of that local research might show that some of the claimed benefits of the locked up areas just aren't there.? And are they scared that research might show that **some other actions** other than just "lock it up" might actually achieve a lot and would weaken "the case" for closed areas as the main or sole action taken? You bet!!.

Make Your Vote Count.
