

## <u>Surfcasters Open Field Day – Easter 30/31 March, 1 April 2002.</u>

Tony D'Alonzo put in the effort and went north to Wagoe Beach. Here the fishing was also rather slow and the swell increasing. As one would expect Tony managed a good bag of fish before retreating in the face of

## Membership Coordinator's "Buddy" Induction System Procedures.

Information should be collected about people who contact any club member, so that we can follow up these as prospective new members. The information we need is:-

Name, Address, Home Phone, Business Phone, E-mail and Fax, does the person have a 4 wheel drive, what information is already held about the club, age bracket, interested family members, and other details.

Once this first contact is made, the Membership Coordinator's Procedures start. These are:-

- All prospective new member details are to be forwarded to Secretary as soon as possible after contact, including source of enquiry and any other relevant details.
- Secretary to post a standardised letter to the prospective member. The letter will be tailored to suit the particular person's circumstances as advised by introducing member; and includes (if not already held by the person) a Club Brochure, Application for Membership Form, and other information about the club and coming events.
- Secretary e-mails the contact details, (eg a letter was sent on (date) to Name, address, and other contact details) to the Membership Coordinator.
- All written or faxed or E-mailed correspondence with any prospective member must be sent by or through the Secretary to avoid sending any conflicting information.
- Membership Coordinator (after an expiry of, say, 3 days, or longer over weekends to allow time for mail to be received) phones prospective new member, following up letter, and encouraging participation at one of the ensuing club events.
- Only people who submit a Membership Application form, pay the nomination fee, and have two existing Club members sign the form, are to be included in the New Member "Buddy" induction system. All courtesies and assistance should still be given to all visitors, but we work harder for people who commit to joining the Club.
- On receipt of a completed Application for Membership form and the nomination fee, and signature by two club members, the Secretary to advise Membership Coordinator all details of the nominated member.
- Membership Coordinator reviews roster and contacts designated members at a General or Committee meeting or by phone, to update and enter progress in roster, forwarding the updated roster to the Secretary and President.
- Designated Member contacts the newly nominated member as soon as possible, preferably within seven days of advice, to arrange dates and times for commencement of the New Member "Buddy" induction system.
- Member advises Membership Coordinator of the arrangements which have been made, and when each of these has been completed.
- Membership Coordinator follows up designated members ensuring that all four sections of "Buddy" induction system have been attended to, including 2 subsequent field day follow ups, and completes appropriate sections within roster.

The "designated" club member arranges four main activities for the new member in the "Buddy" induction system:-

- 1) Attend a General Meeting, introduces new member to members at meeting, and explains meeting procedure.
- 2) Attend a Drycasting morning requesting new member to bring and test own gear on day.
- 3) Organise a time to build rigs ensuring that the new member also has the opportunity to make rigs in your presence.
- 4) Go on a Field Day, plus follow up member on two subsequent trips, ensuring that encouragement and assistance is continued.

Also, the Secretary will write to all newly nominated members and advise the arrangements, including: -

They will receive Reel Talk, They join the new member "Buddy" induction system"

They aren't yet able to vote, They will be advised when accepted.

Their name will be published in Reel Talk, and go before the subsequent Committee Meeting.

They are eligible and get points for any competition and receive Club benefits (tackle shop discount card, etc.)

and write to all newly accepted members and advise the arrangements, including: -

Welcome and wishes for good times in club, 
Invitation to get badge, etc at next General Meeting, etc.

## AAA and Club Publicity.

The AAA had another full page in the April West Coast Fisherman newspaper, covering the AAA Jurien Bay Beach and Rock Fishing Championships including several photos, and details of future AAA events.

An article on dry casting, including a plug for the Surfcasters, and an invitation for people to attend our dry casting days, has been prepared for the May West Coast Fisherman, out early May.

The Sunday Times had an invitation to dry casting in the edition before the April dry casting day, and that invitation and the membership drive and the very good plug Doug Clegg gave the club on the ABC radio program "Hook and Line and Sinker" on 23 March, resulted in about a dozen people coming to dry casting.

We have had five new member applications and Derry has followed up lots of other contacts, with several people saying they will come to club events in May.

#### Brooke Inlet at Easter.

Trip commenced with a full complement of Hendersons, namely Jamie and Matt and Bob, so I was clearly outnumbered. Following Hendo was an excitement in itself as we had numerous stops for fuel. I think the V8 actually likes fuel more than Bob likes the other. Barber, always on the go to try and make a guid somewhere and foolishly bet our Bob that, 25 kms out of Bunbury, we would have to see a cop over the next 50km. I mean, that should have to be a sure thing, it was sure all right, I lost the bet.

We ended up stopping at Bunbury on the way through for a meal and commenced through to Brooke Inlet. Matt of course was giving directions (because he has been there before) and stated that we wouldn't go through on the track at night as it takes 1.5 hours and could be dangerous. The plan was to stop first, have a relaxing night, and, you know, that's just simply the right thing to do. You guessed it, we immediately commenced down

the track, its dark, its night, and your following a noisy V8 so you can't hear anything anyway. The track was rough, bumpy and on occasions soft.

We had traveled about three quarters of the way then silence as the CB became attracted to a tree on the way through, mind you, that was because of a wrong turn so I think, um, the junior Matt Henderson could be squarely blamed for that one. We arrived at Brooke Inlet which was absolutely magnificent and on a clear still night. We parked on the water's edge and had to walk just a few yards to hop in and wash off the dust, absolutely magnificent.

Friday morning saw the commencement of the fishing, which although the water looked beautiful didn't produce much result, so we quickly went back and enjoyed a quick lunch, surveyed the scene, and tackled the estuary. Two and half-hours fishing ended up with fifty-seven garfish and two herring. They were huge and each one had Exmouth targeted on its back. The fishing was tough, you were standing in waist deep water, absolutely no swell, in the estuary, sun beating down, absolutely still water - you could see fish everywhere and see the gardies strike and dance the surface as you brought them in, something out of dreamland. Matt and Jamie excelled themselves both catching gardies on lures, which I personally had not heard of, have you come across this before? Matt also, apart from catching gardies on lures was also fly fishing and managed to catch a gardie using fly, overall a magnificent morning.

Saturday and Sunday saw a combination of both beach and estuary. The beach was wild surf and one was very tempted to go in for a swim, in fact, we were about to try and catch a wave. However, to do that, you needed to go past the gutter running parallel to the requiring a swim of about 60 metres minimum to get past the gutter onto a sand bank leading into another trench (certainly not as deep as the one close to the shore) and then past that again when the waves were breaking. We were just about to drop the rods and go in and catch some waves when someone spotted something most unpleasant. It was like the Taxation Department coming in for an audit. It came in the form of a four-metre shark that definitely toned down the enthusiasm which precipitated picking up the rods but couldn't get a strike, which is probably just as well looking at the size of it

We also ventured across the headland and started to rock hop, the coast is magnificent in that particular area, a lot of holes, a fair bit of climbing, but certainly there's a lot of platforms to fish off. The conditions were reasonable and, although a fair amount of surf, it didn't stop one from fishing. The catch however was limited to herring as there were thousands of them there and no matter what other fish may have been around, the herring just didn't give you a chance. What was interesting was one bull herring caught (it was immediately released and put back as were the other herring) it was ginormous and not something I have seen for a long time.

Bob also brought his dingy and Matt his canoe which were used in the estuary to try and find the best spots and search for King George whiting which were conspicuous in their absence. Although it was extremely enjoyable being in the boat or the canoe we couldn't strike the whiting, again endless number of gardies and herring in the river as well as silver bream but no sign of the elusive King George. We finally decided to call it a day and went back to camp; it is now Sunday night.

This turned out to be, well certainly as far as I am concerned, the highlight of the trip in relation to the fishing. The company was fantastic all the way through, but looking again at the fishing highlights, what I'm about to relate is exactly how it transpired, and it went like this. The four of us moved out from camp about 5 pm and started to walk along the bank flicking light rods, trying to pick up whatever was there was in the estuary. When it got close to dark we moved up fairly close to the ocean side of the estuary and decided to stay there, put in a bit of burly and see what came. If you could visualise this scene, with waders, wet gear (so cold was irrelevant) lightly flicking at casts into water no more than 40 metres away from and depth of about 3 metres. Very light gear, tiny sinker and burly cage. It was a toss up what hit, a gardie, herring, whiting or Skippy. The conditions were absolutely perfect, still night - hardly any wind, most of the crowd had gone and we had the river to ourselves.

It was peaceful with a beautiful sheen on the water and lots of bites. Bob, Matt and Jamie went back to camp and I was on my own, now there was complete silence, smooth as glass water and the bites just kept on coming. One was tempted to stay there for a long time, as the conditions were almost perfect. However, with conservation in mind (and probably the smell of tea which although I couldn't really smell the taste buds were sending messages) so it was time to finally leave and go. I can assure you leaving carried with it a lot of reluctance, because it just doesn't come any better than this. We played either upwords or euchre at night and as far as euchre is concerned, it was Barber who was euchred but got the best of them on upwords, so that was some consolation.

The trip home was certainly eventful, Jamie was driving at that point and exclaimed in horror that there was an oncoming sports car that was constantly taking over vehicles, on blind corners over the double white lines. A huge amount of dust was behind us caused by drivers forced off the road to avoid a collision with the sports car and oncoming traffic. The sports car certainly caught up to us and sped past so fast we couldn't see who was driving. When we reached the next corner we were delighted to see the old blue and white with sirens flashing in full pursuit of the offender. It would appear the police had been phoned and warned about the mad man on

the road and they were at the right spot waiting for him to turn to pull him in. He certainly did that and we went past at that particular point and turned back.

All of the cars behind us had pulled up and there were at least 15 people making a point to the patrolman of "throwing the book" at this particular individual. The reality is that his selfish and foolish conduct could have got all of us killed. The wash up of that was, statements were taken and the driver was charged with dangerous driving and willful intent, that in fact means lockup. We were delighted to hear that they were, in fact, putting him in jail. The driver pulled the usual "do not speak English." He was a young Japanese international student who was wearing professional race drivers boots obviously treating our south west roads as his personal raceway and to hell with the consequences. Maybe he will speak English when they put him in jail and lay the charges.

The Easter weekend was great, top company, no hassles or pressures, a magnificent spot and just fun and relaxation, the fish was a bonus.

#### Glow Sticks.

I first started using Glow Sticks about 20 years ago as an indicator on the tip of my fishing rod and found them to be a big help when I had a second rod set up several metres away. With the light glowing and very easy to see, you could always tell if you had a fish on or not. You cannot always hear your reel drag working if the wind is blowing the wrong way in relation to where you are standing.

From there I advanced to attaching the Glow Stick to my rigs when fishing and it is my own personal opinion that while you may not catch many more fish they certainly do not put the fish off. This is verified by the amount of fish that are caught when using a Glow Stick.

Glow Sticks can also be used during the day depending on the depth of water you are in. (Boat or rock fishing). These days, with failing eye sight, I find Glow Sticks a big help to me at night as I am able to tell where my rig is when it is coming in and I always know where the hooks are, be they on the ground or entangled in some weed.

Drill a hole in the top of your float, insert a Glow Stick and you will always be able to see where your float is. Glow sticks are also great to use when you are fishing from rocks at night or if you have an on-shore reef at your feet as you are able to lift the rod and bring the rig up and over any obstacle. (Well almost any obstacle)

Summary: I cannot guarantee that Glow Sticks will catch you any more fish, however, it is my opinion that they do attract fish to where your bait is and fish are by nature, inquisitive. If fish are attracted by the light it stands to reason that when they investigate the light source, they must see the bait and if hungry, have a go at it.

Note:- Glow Sticks have a very short shelf life, so only buy enough for the trip and also buy a couple of different brands as some are better than others. Give it a go, you might be pleasantly surprised.

## First Encounters at Wagoe Beach - 12-14 April 2002

Six hours of driving late into the night on Thursday after work saw Frank Shim and myself up at the chalets at Wagoe Beach and two rather tired and excited bodies retired for the night. Early the next morning we unlocked the gate and headed down through the paddocks to the beach track the first time to put Frank's driving and his Prado to the test.

The sandy track winds though the dune scrub and heads down the slope to the beach. Here we were greeted with our first ever view of this rugged coastline. Rugged? The swell was huge and when the waves crashed violently into the reef the spray shot many meters into the air with plumes of mist falling slowly down. Spectacular, and not a little awe-inspiring. The reef line runs north to south with no clear breaks and pretty much in a straight line. It is very exposed with nowhere to hide from the swell and nothing to provide a sheltered corner out of the firing line. It looked pretty daunting in the grey morning light.

We drove down the beach looking for fishable water and passed a few short breaks in the reef, driving all the way to the lagoon before finding anything resembling fishable water. Even here it was going to take a big cast to get beyond the shore break to clear water and at least 6 oz of grapple sinker to hold bottom. Perhaps we could give it a try.

But Frank had other plans, he was keen to put the Prado to the test. We drove further and inevitably got heavily bogged in the coarse, soft sand. We dug the blue beast out and he bogged it again. Then after the 3rd sand bath I was beginning to see a pattern. Amid the plumes of smoke from a burning clutch I could discern a wild-eyed maniac at the wheel, no doubt having visions of his beloved car being a permanent fixture on this dune. Calmly we gained control. Some lessons in gear selection followed. Particularly important was the lesson in "How to engage low range". No, that lever is not for hanging handbags and litterbags from, it has a very special use. It is the "Get Out of S#@^\\$# - Lever". Once this lesson was finished, the car appropriately now in low-range, we drove calmly out of the sandpit and headed off to go fishing.

Unfortunately the fishing was slow. Well, in some ways it was slow. But you had to be quick on the cast to avoid getting swamped by the waves crashing on the beach and racing across the sand at amazing speed. We parked the Prado about 100 meters away and tried to fish. Frank managed a small dart and a wirrah while I also caught some small wirrah. With a strengthening sea breeze and no good fish about we decided to retrace our tracks along the beach and look for a potential night-fishing spot. We marked a few places and much to his delight, Frank drove easily along the beach in low-range and tackled the dune field and tracks with aplomb.


Back in the chalet we had one of Frank's magnificent culinary concoctions. Having worked as a chef in his youth certainly has its advantages on a fishing trip. Filled to the brim with stir-fry we settled down to the task of rig making and preparing for the night. The blokes from the neighbouring camp came over for a chat and we decided to fish the same spot that night. This amicable arrangement was great and Dario and his mates were good company. They had a good lighting set-up on the beach which was to our benefit and it was quite a festive session. Frank fished a large bait on a large rod to try for a shark and I fished two outfits but with very limited success. Dario and the boys caught 3 smallish mulloway while all we managed were 2 wobbies and a succession of bloody cod (wirrah).

The next morning the easterly was blowing strongly and the swell somewhat less dramatic. Frank was keen to try some ballooning but we were not fully prepared and did not have any party gas and I had not made special ballooning rigs. Anyway, we made do with an air-filled balloon, a garfish rigged on some 7/0 ganged hooks with a short single-strand steel trace. This was sent out and in the brisk wind the big red balloon was soon dancing about enticingly on the water about 150 meters from shore.

Frank was placed on a high rock above the reef and held the rod and Alvey outfit. I in the meantime concocted beautiful floating squid baits and fished these into the washes fanning out from the reef. Great looking country but all I could manage were some more wirrah and a single unlucky tarwhine.

Frank's shout got my attention and it seemed as if he had been yelling for a while. A blistering strike had resulted in a screaming reel and whirling handles. After first bashing his knuckles to a pulp on the spinning handles of the deep-spooled Alvey 651E, he managed to get control and the fight was on. At the end I helped to wash the fish out onto the reef. 7.5 kg of silver sparkling Spanish Mackerel was the prize and the jubilation

was written all over Frank's face. His first land-based mack and he was elated. Another bait was sent out and I continued to frustrate the cod population but that was our morning highlight.

After lunch and a trip to Kalbarri for fuel we got some rest and prepared again for the night fish. Back to the same spot and this time with more berley, less swell and a calm and misty evening.

Frank decided shark-fishing was out and he now wanted to catch a mulloway. So the shark rod was neglected while he fished mulies instead. I stuck with the 2 rods fishing a fillet bait on one and a mulie rig on the other. Once again the going was slow.

Some more of the ubiquitous wirrah, a wobbegong, and a small blacktip shark helped to relieve the tedium. Frank was enthusiastically donating a succession of sinkers and rigs to the deep but he persisted nonetheless.

With his last sinker out he had a bite, struck and came up solid to a good fish. Calmly he gained the upper hand and fought it into the shore-break. Gleaming in the torchlight lay another prize, a mulloway of 7.5 kg. Frank was ecstatic and rightfully so. He whooped around the beach like a kid on tartrazine and the smile was permanently fixed on his face for the rest of the weekend.

Late into the night we processed the fish, cleaned gear, chatted, ate and toasted the mighty Shim with glasses of rum. Two excellent and memorable fish on one day and he also got his Prado back in one piece!

Sunday there was no easterly wind to allow ballooning so we bottom-fished a few spots and I baitcast gardies off the reef but for no reward. So finally we headed back along the beach once more, up the winding track through the dunes, packed up, cleaned the chalet, and pointed the Prado towards home. Another great fishing weekend over.

## **Dhufish Catches under the Spotlight.**

Media reports of 52 dhufish being taken on a charter boat in the Mandurah area lead to a storm of comments from other charter boat operators and recreational fishers in various places.

A ministerial statement on 28 February by Fisheries Minister Kim Chance expressed concern at these large dhufish catches by some fishing tour operators. He was responding to the media reports and the representations from the recreational fishing industry.

This catch meant that almost all the passengers on board had taken their daily bag limit of four dhufish per person, made up of large breeding fish that may have been spawning. Although the catches were taken within the current rules, he regarded the activity as unsustainable and ongoing fishing pressure such as this could lead to local depletion of dhufish stocks.

Mr Chance said the reports had caused him to reconsider his previously stated position on the possible introduction of charter boat limits, which was that the introduction of recreational boat limits should not be considered until after the West Coast Recreational Fishing Working Group proposals had been implemented and charter boat operators had considered the matter further.

The fact that dhufish are targeted by recreational fishers in private boats, recreational fishers in charter boats and commercial fishers, highlights the need for an integrated management approach to ensure the long-term sustainability of dhufish stocks. He had already indicated that there will be a review of the unmanaged components of the commercial finfish fishery, to commence later this year.

The Government is committed to the integrated management of the State's finfish stocks and a review committee, chaired by Judge Justice Toohey, is currently examining management frameworks and developing principles for the future allocation of fish stocks to ensure maximum benefit to the community.

## A Win for River Foreshore Access.

The community would have access to Harvest Road jetty and adjacent river foreshore in North Fremantle, under conditions attached to a development application by Environment Minister Dr Judy Edwards. The development application would only be granted subject to the conditions being met.

The jetty would be available at all times for the public, with existing gates and fencing on the jetty to be removed. This is in response to direct community concerns that public access to the river and jetty could continue to be restricted.

As part of the proposed new development conditions, the shoreline and riverbed along the whole northern side of the jetty will also be excluded from the current lease. This will require all structures associated with pens on the jetty's northern side to be removed. However, the decision would enable the ongoing use of the pens for nearby owners on the southern side of the jetty.

The Minister believes this is a fair compromise - allowing some private pens to continue, while also ensuring public access for the community.

Let's hope this is a start of lots of similar changes to give us back access.
