

Fish together

At the General Meeting prior to each field day, Marcia and Peter Pekaar will confirm if they will be fishing locally, and discuss when and where members can meet.

How to get to Emu Springs, Flinders Bay.

The June long weekend Field Day is at Emu Springs. There are no towns and no service stations on this route after you leave the Capel area, unless you deviate via Nannup, so make sure of your fuel, water and other supplies.

As shown on the RAC "Lower South West" road map, travel about 18 km south west of Capel along the main road to Busselton, then south approx 60 km via Sue's Road, then 13 km east along the Brockman Highway, at Cane Break picnic area turn south west down Milyeannup Coast Road (previously called Cane Break Road). This quickly turns into a gravel road. Head towards the coast for about 20 km. You will cross a narrow bridge over the Scott River. Take care on this section of road.

About 2km on there is a road to the left, veer right and go on a further 2 km on a sandy road. The access gate to the property is tucked away on the left hand side. Follow this track through the peppermint trees till you reach the camp site. A club sign will be put near the access gate. Instructions for access through the locked gate will probably also be given at the May General Meeting to people who are going.

This is a really great field day to take the whole family. The camping area is native grass and is well sheltered from the wind with large peppermint trees. Those who have been there previously will remember the good fishing and great social atmosphere. There will be a get together and barbecue on Sunday between 12 noon and 2:00 pm. Fishing will be suspended during this time.

The area allows for children to fish as easily as the senior members if there is no wind. Fish caught include salmon, skipjack trevally, herring, tarwhine, flathead, whiting, tailor, mulloway and shark.

The property and camping area are accessible to conventional vehicles with a camper unit or trailer, but access to the beach needs a competent 4 wheel drive.

The sandhill track to the beach is very steep and very difficult. Make sure you have recovery gear and shovels, etc because some work may be needed on the track to fill in holes or dig yourself out.

Driving on the beach is usually very difficult and is not recommended. There is a 4wd track behind the first sand hills, which gives access to the fishing spots with a short walk. You can

drive about 8 km west and east of the camping site. People without a 4wd should make prior arrangements to get a lift to fishing locations.

There is no drinking or washing water available at the camp site, so bring all you need. No open campfires are permitted at this time of year. Please dig yourselves a deep pit toilet some distance from the camp site.

This is a private property which the Club has been given permission to use. All members and visitors need to show extra care and observe the Club's Code of Ethics for vehicles and camping so that we will be welcomed back for future field days. If you bring a visitor, you must make sure that person's activities meet our Code of Ethics or you must do whatever is necessary to prevent any problems.

We must leave this property and the track in very good condition so that the club will be welcomed back in future. Make sure that vehicles do not disturb the cows and calves because we camp in the calving paddock. Remove all rubbish and dispose of it elsewhere.

Dogs are not allowed on this private property unless prior permission has been arranged.

Take care on all tracks as there will be 4 wheel bikes using the track and they can be obscured from view by the bush till right on top of you.

Species Competition update

The club's Species Competition has the following simple rules, as listed in Section 5.1 of the club's Competition Rules.

- 1. Entries to be submitted to the Recorder on the appropriate form, <u>unless caught on a club</u> <u>Field Day.</u>
- 2. Fish may be caught <u>at any time</u> including on Club Field Days.
- 3. A member must capture ten (10) of the listed species to qualify for a Species badge.
- 4. Fish must be a minimum of 20 cm or comply with Dept of Fisheries minimum lengths if these are greater.
- 5. Weighing of fish, photographs and witnesses to weight are optional.

Reading those rules, members would reasonably expect that all species caught on Club Field Days would be recorded for them; they would be advised of their progressive list of fish caught so they can try for species they have not yet caught; and they would be advised when they have finally achieved their 10 species.

All the records have now been updated to satisfy that expectation. Field Day catch records starting at the 2001/2 season and finishing with the April 2010 Field Day have been checked and species added to the members' tallies.

That work on your behalf by Vince and Terry has made a big difference to the number of species in the tallies and has shown that 2 more members have already caught 10 species and are eligible for a Species Badge.

Just as importantly, six (6) other members have already caught nine (9) species and need only 1 more of a very common species to qualify for their Species badge. Everything you need to know is here. Examples:- Lea, Sandra and Peter Osborne just need a black bream or a gardie, Peter Pekaar just needs a gardie or a wrasse, Andrew just needs a salmon or a wrasse, Hendo just needs a black bream or a wrasse. Too easy. Go to it, guys.

Note 1. Once 10 or more species have been recorded, any extra species were not recorded in this update.

Note 2. This update lists members with some eligible species, mainly those recorded on field days. Please advise the Recorder if your name should be here, or if you think you have caught more species. If so, please say approximately when you caught an eligible species on a Field Day or approximately when you put in an entry form for a fish caught other than on a Field Day.

Fishing competitions application form

The entry form for the fishing competitions has been updated with several changes in the form and with major changes to the reverse side which has the details about the Species and various Masters competitions.

Major changes include now making it absolutely clear when entry forms are required and when they are not required, both logically and in accordance with the wording and intention of the Competition Rules.

An entry form is NOT required if the fish is separately weighed and recorded in the Field Day catch list. An entry form IS required for any fish caught outside Club fishing Field Days which are eligible for Species and Grand Masters, and for all the Open Competition sections.

Of course that will require up to date records of what species have already been recorded for each of the members, and separate recording of any larger fish caught on Field Days so that the Recorder can update the lists from the Field Day results each month.

Publicising those details has already been started with the update of the recorded Species Competition captures, as published in this Reel Talk.

The Field Day recording forms and the spreadsheet already have a place to record the weight of the heaviest fish of each species caught by each angler. And of course it will help if each member knows what he has already caught and what can be entered for him, and then makes sure enough details are recorded when he presents his fish for weighing at the Field Day weigh in.

Provided this is done, then entries for the competitions can be processed in just a few minutes maximum each month. I should know, I have done exactly that for the Species Competition using the results for all the months from 2001 to 2010.

Conduct at Club meetings and events

Creating and maintaining harmony and cooperation between club members is critical for the future of this club.

12. DISCIPLINARY POWERS. The Committee shall have full power to suspend, expel or impose any other penalty which it may deem fit upon any member of the Club who shall have in the opinion of the Committee, been guilty of any conduct, act, matter, practise or act conducive to or tending to cause ill feelings, friction or dissension amongst the members or reflects discredit on the reputation of the Club.

People who are genuinely constructive in their actions, comments and questions will have nothing to be concerned about.

However, some people may need to refrain from niggling and petty questions, statements and comments.

Some people may need to learn how to deal with a range of other people and be much more aware of others' reactions to what they are saying or doing so that others will accept their contribution and will not feel threatened or annoyed or react to the messenger and thus miss the message.

The Committee reminds members that all meetings are recorded. Those recordings will be used if and as required to transcribe and verify any statements and to support and explain any action the Committee may take. The recordings are available to members.

A cooperative harmonious club will usually find some willing and committed and energetic workers to do the many things required to run a club. A dysfunctional club will decline because members will leave or be unwilling to get involved.

The Committee is only trying to create and maintain harmony and cooperation between club members, and any actions under Section 12 will be for that reason.

Marine Parks and sanctuary/no fishing zones:- myths and realities

Marine Parks and sanctuary/no fishing zones are not the same, but are often used interchangeably which confuses lots of people. Marine Parks (in WA) can have different zones, of which sanctuary/no fishing zones are just one type, and usually make up less than 30% of the area covered by the Marine Park. Of course taking a large part of the good fishing spots into no fishing zones can mean that the impact on certain types of fishing like shore based fishing can be much greater than 30%, since what is left can be areas which are not very productive for shore based fishing.

A topic which comes up regularly is the justifications for Marine Parks to protect the marine environment and actually improve fishing. Environmentalists claim that large Marine parks (and they really mean large areas/percentage of no fishing zones) are essential for lots of reasons. They cite lots of overseas research about no fishing zones and benefits for everything from whales to leafy seadragons to better catches of fish outside the no fishing zones.

Some claim many universal and indisputable benefits from closing areas to all fishing, and then apply that to the WA situation which is quite different in many ways, and is ignoring the actual levels of fishing which may be taking place, and the management rules applied to that fishing or the past lack of rules or enforcement in some countries.

When challenged on that, they sometimes cite the "precautionary principle" which is that if there is not enough information, then the correct approach is to take a low risk approach and restrict or prohibit activities which <u>might</u> be having an impact now or <u>might</u> do so in the future.

Finally, two separate very informative and important reports have been released which cover the West Australian situation, and confirm things informed people in the fishing community have been saying for years. The reports are:-

- 1. Fisheries Research Report No. 169, 2010, "The efficacy of sanctuary areas for the management of fish stocks and biodiversity in WA waters." 48 pages available from http://www.fish.wa.gov.au/docs/frr/frr169/index.php?0401 and
- 2. "Report on the Scientific Basis for and the Role of Marine Sanctuaries in Marine Planning." by the Marine Scientific Panel. Both the Department of Environment and Conservation and the Department of Fisheries are named on the front cover. 96 pages http://www.dec.wa.gov.au/content/category/40/952/2323/

Already the Conservation Council of WA has issued a media release and very selectively used the contents and recommendations of the second paper in its attempts to put uninformed or misinformed public pressure on politicians in support of large Sanctuary/no fishing zones for WA. Don't be surprised to see more.

These are long papers with lots of complex information. But I see these as THE most important papers on WA Marine planning in the last 10 years or more because of their potential to put Marine Planning into a proper context and answer many of the misleading and misinformed statements flying around. But that also needs people to be aware of the existence of the reports and to have some idea of their contents and then to challenge the misinformation so it isn't used against fishermen. That's against **YOU and your fishing** in case there's any doubt.

Some extracts from the Executive Summary of paper 1 are:-

There has been an ongoing debate about the relative value of sanctuary areas for the management of fish stocks, and biodiversity more generally. This debate can often be exacerbated by unrecognised differences among stakeholders in the definitions used and the scope and scale of the objectives to be achieved. Conflicts are also likely where there are strong expectations about the relative value of a specific strategy irrespective of the structure of the system to which it could be applied or the levels of management already being employed. In summary this review concludes that:

• Marine habitats, and therefore a large proportion of the biodiversity in WA waters, are highly protected from negative fishery impacts compared to nearly all other locations in the world. Approximately 35% of continental shelf waters already have full habitat protection at levels equivalent

to MPAs under IUCN categories IV, V and VI. The effective area of habitat protection generated through direct and indirect controls on trawl fisheries covers about 90% of continental shelf waters.

- There are few fish stocks in WA with reduced spawning biomass levels where general no-take areas would lead to increased recruitment levels of their juveniles. In such circumstances, highly targeted closures (not necessarily to all fishing activities or for the entire year) in conjunction with other broad scale actions have proven to be effective management options.
- Most of the marine species subject to fishing (including those with benthic stages) in WA are highly mobile either as adults, juveniles or both; which greatly reduces the efficacy of small, static, non-targeted spatial controls for their management at a stock level.
- The implementation of sanctuaries alone, will generally not improve the quality of fishing in the areas left open along the WA coast, as the re-direction of effort from a newly established sanctuary area is likely to result in a reduction in local catch rates within the surrounding regions.
- The main marine habitats in WA at risk are the estuaries and embayments where land-based, non-fishing activities have resulted in nutrient rich run-off and eutrophication, which has significantly altered ecosystems (e.g. the Peel–Harvey Estuary). In these situations closures would neither rebuild affected fish stocks nor assist with the protection of the broader ecosystem.

Based on these assessments this report supports the concept that clearly defined sanctuary areas (within marine parks or FHPAs) will play a valuable, but restricted part of an overall scheme of management to sustain resources and protect biodiversity in WA waters.

Consequently, there is a rational basis to support the establishment of marine sanctuary areas where they have clear, measurable objectives that relate to achievable benefits for tourism, biodiversity, research and other 'no-take' outcomes. There is, however, little scientific basis within the WA context to support their justification where they are proposed as a precaution against undefined 'bad practices' in the management of fisheries.

Where a sanctuary zoning is being considered for a specific area, the planning process would be made more efficient by:

- ensuring there are clear, simple and measurable biodiversity, research, ecotourism or fisheries management objectives, which are meaningful to the key stakeholder groups and the general public, and that the area being set aside is of a scale relevant to its purpose;
- ensuring that the site proposed takes into account and complements any existing fisheries or other management arrangements that could assist with protection of biodiversity.
- having a clearly specified and fully costed research and monitoring program directly linked to the biological and socio-economic (tourism) objectives set, with appropriate performance indicators and a transparent reporting system.
- specifying periodic reviews that could include the provision of sunset clauses if any area is found not to be assisting in meeting the agreed objectives.

In regard to the use of sanctuaries or other types of complete no-take areas to meet the objectives of the FRMA, it is our assessment that:

- The static and non species specific nature of sanctuaries as a management tool will preclude their use as an efficient strategy to deal with the stock-level management of the majority of fished stocks in WA, which are typically free ranging and broadly distributed. The high level of overlap in the footprints of these species also conflicts with the complete 'no take' nature of sanctuaries and further limits their effective application for sustainable management of harvested species in WA waters.
- Sanctuaries (or equivalent FHPs) of appropriate scale will be valuable where their primary purposes relate to the preservation of representative examples of biodiversity; the provision of areas for various no-take uses (ecotourism), and/or as sites for long-term scientific monitoring.
- Declaration of a sanctuary will automatically raise resource use and allocation issues, with direct implications for the right of access (especially in near-shore areas). It may be less of an issue for highly mobile fish species, except where the proposed sanctuary is to be situated over the only accessible fishing area (i.e. next to the only boat ramp or overlying the only safely fishable reefs within the region).
- The effective management of MPAs will generally raise significant and ongoing compliance and education requirements, which will need to be adequately resourced. Multiple-use MPAs, incorporating significant sanctuary areas, are likely to exacerbate costs, resource use and allocation issues and therefore, should require a comprehensive cost benefit assessment during the design phase.
- Long-term monitoring programs, including time-series data for harvested fish species (and presumably other components) will be required to assess impacts from the establishment of the sanctuaries and whether they have met the expected objectives.

Marine Parks and sanctuary/no fishing zones:- myths and realities - continued.

Whilst simplistic solutions (e.g. all fisheries need sanctuary zones) and generic rules ('x'% of the coastline always needs to be closed to fishing) are often proposed, these are rarely found to be optimal or appropriate when dealing with the management of complex natural systems. Experiences in WA, and elsewhere, have shown that the only effective methods for the overall conservation and maintenance of harvested species (i.e. not their local densities) requires specific, directed and coordinated controls on the overall catch and effort across their entire range. While these controls often involve stock-specific spatial and/or temporal closure systems, complete closures or sanctuaries will generally make only a minor contribution to the management required.

Some extracts from the Executive Summary of paper 2 are:-

Fisheries Management. The evidence for the effects of marine sanctuaries on fisheries, either positive or negative, is less clear. The attribution of the benefits of marine sanctuaries for fisheries is controversial, and most of the empirical data on the benefits of marine sanctuaries to fisheries come from severely over-exploited tropical reef systems in developing countries. The Panel has drawn the following broad conclusions from the evidence:

- (a) Conservation benefits for fisheries are mainly evident through the increased abundance and size of previously targeted species of fish and invertebrates within the boundaries of the marine sanctuaries.
- (b) Marine sanctuaries may be valuable tools for ecosystem based fisheries management, providing reference areas against which to assess the status of fished areas.
- (c) Marine sanctuaries may reverse the indirect ecological effects resulting from fishing such as major changes in food webs or trophic cascades (i.e. where the removal of significant proportions of predators can result in profound re-arrangements of ecosystems, such as changes from kelp forest to barren rocks in temperate systems).
- (d) Sanctuary areas may provide a level of insurance in the face of the difficulties of managing fisheries and preventing stock collapse, potentially increasing the production of eggs and larvae, and potentially adding directly to fisheries through the dispersal of eggs and larvae or through the migration of juveniles and adults across the boundary of the sanctuary into adjacent areas.
- (e) Marine sanctuaries are a promising tool for fisheries management but they are not a solution for fisheries management when used in isolation.
- (f) Marine sanctuaries are likely to have few benefits compared with conventional fisheries management tools for highly mobile single species with little bycatch or habitat impact. The potential benefits of marine sanctuaries compared with traditional fisheries management are likely to be greater for multi-species fisheries or for more sedentary stocks, or where fishing has broader ecological impacts e.g. trawling.
- (g) Marine sanctuaries may impose costs through displaced fishing effort and short-term reductions in catches, although the empirical evidence of these effects is scant.

In summary, marine sanctuaries, together with other fisheries management tools, may help achieve broad fisheries and biodiversity objectives, but their use requires careful planning and evaluation. To minimise the loss of yield to fisheries and to achieve the desired conservation benefits, sanctuaries need to be evaluated in the context of:

- 1. clear biodiversity, ecosystem and fisheries objectives;
- 2. the social and institutional ability to maintain and enforce the closures,
- 3. existing fisheries management actions that marine sanctuaries could complement under certain conditions, and
- 4. the ability to monitor and evaluate success.

The rigorous assessment of the effects of marine sanctuaries (both positive and negative) on fisheries in developed countries is, in general, a major information gap that requires further investigation. The effectiveness of any particular marine sanctuary or network of marine sanctuaries can only be assessed if the objectives of the sanctuary are clear. Well designed and planning objectives have been reached. This is a major shortcoming in the implementation of marine protected areas worldwide, particularly in assessing the potential effects of sanctuary zones (or no-take zones) on fisheries.

Video and still images from the cameras will be used for analysing fast action Dry Casting and for extracting progressive frames for tuition and training, for demonstration in the various casting techniques, and for coaching to improve individual's casting actions using the supplied fishing rods and reels or their own fishing equipment.

Video and still cameras will be used to record instruction periods so that a library of topics will be available for new volunteers or members who were not able to attend in person. Many topics are vital for induction and training of new people, but cannot be repeated too often

without boring members who have seen it all before. A recording will allow new material to be presented, yet allow access to previous presentations.

Projector will allow recorded material from previous presentations to be presented, assisting in induction and education.

Calamari and Chips, or Nuggets and Chips.



April Field Day report, Bluff Creek

Sandra and I departed Perth at 7 am on Friday morning. The "Fish Jeep" was packed to capacity with everything that you could possibly think of - especially fishing gear was high on the priority list with fresh bait second on the list. I made certain we had enough heavy sinkers this time - the last Bluff field day still fresh in my mind.

At Williams we had our regular breakfast, then left for Albany where we stocked up with the last needed provisions and fuel. Early afternoon and we were on our favourite beach, driving east at a snail-like pace with eyes and ears focused on what Bluff had on offer for the weekend. First of all the weather was at its best, a light westerly breeze with almost clear skies. Secondly, we noticed a lot of action over the water, the birds were diving like crazy and there were huge schools of dark patches moving over the surface of a very flat sea. At this stage my emotions took over and I shouted out loud in pure joy and excitement, I just knew we were in for a Bluff Creek bonanza. I accelerated and geared up to second gear, eager to get to the camp site.

Late afternoon and our campsite is in tip-top order, generator running, powering the freezer and our 20w fluorescent light. There is still some daylight left and the perfect time to test my serviced overhead reel. Straight down on to the beach were we met an old friend. A quick few words and then down to business. The first cast was with caution and respect, the Mulie however travelled smooth and straight and landed perfectly in the gutter that was running all the way down the beach. Still setting my drag when an almighty tap and a huge pull on my line got me straight into battle action. My first salmon for the weekend was scarcely on the beach when Sandra was into action fighting another lively salmon. This action continued until our small packet of mulies ran out. Within a half hour we had caught and released 3 salmon, a couple of nice skippy and a few rather big herring. These were all caught on 4/0 gangs. We retired all smiles and were waiting in anticipation for the next day.

Saturday morning we woke up late after a rather cold night. It was another perfect day with the flag on the ute indicating a very light westerly breeze. After a great breakfast Sandra walked down to the beach with fishing rod in the hand while I got the campsite back to order. Every now and then I peeped over the dune just to see how she was nailing the herring. I was just smiling quietly and really enjoyed every moment.



Soon it was time for the sign on and from all directions the Surfcasters, visitors, friends and dogs assembled in good spirits. There were some new faces, old faces and some forgotten faces and they all had something to yarn on about. After a rather lengthy sign-on everybody disappeared to their secret fishing spots.

We fished right down in front of our campsite and enjoyed the advantages one has when the fish are biting right on your doorstep, however the plague of the herring meant that we would not catch anything else if we stayed there.

On the other hand my good friend Theo was fishing only 100 meters to one side and he could not land a herring. I called him over the radio and asked if he wanted to move with us. He said he would rather take our spot and get his fair share of herring first.

We found another good looking spot with some deeper water and some rocky structure around. With plenty of herring in the bag we switched over to bigger gangs and mainly targeted skippy and salmon. It did not take long before the skippy started to roll in. Just after 5 pm the salmon started to show up and Sandra got stuck into a really big one. When she finally got it onto the scale the digits came to rest at 6.92 kg. By 7 pm I also had 3 salmon in the bag, one of just over 6 kg and the other 2 around the 2.5 kg mark. By that time there were a few nice skippy in the bag as well and we decided to go back to camp and enjoy our friend's companionship around the barbeque and camp fire.

After another cold night we woke up to another glorious day, totally in contradiction to the weather prediction. By now most people I came across had good bags of fish and everybody's spirit was high except old Theo who was trying his level best to catch a salmon.

Soon after breakfast I took the spade over the sand dunes, making plans for the day ahead. Being another glorious day meant some more time for fishing. We decided to try an old spot where we had caught some rock fish in the past. Sure enough within a few casts I got my rock fish. We moved on to some friendlier water and started to experiment with some different fishing rigs. It was not long and Sandra was onto her second big salmon of the weekend...., oops the rig snapped as she pulled it onto the beach and with the next wave it was gone. Not long after and with a proper salmon rig she landed another big salmon.

Midday we were all back at our respective camp sites for the 2 hour lines up. This was a good time for a little get together with some good food and friends. In the afternoon the wind changed slightly in a more North Westerly direction which meant a little better casting distance, which also meant some good size skippy. Soon after lunch and Theo is on..., yes he's got a real big salmon on the line. He plays it well and gently brings it closer with every wave and then just when he thought he had it, the hook straightens and well the rest is history. Oops!

With the night fast approaching we jumped into our wetsuits and geared up for a couple of hours' night fishing. Just on dark my rod bent over with the reel screaming as it loses line rather rapidly, I am on to another mighty big salmon. This was the end of our fishing and so we moved on to the next step to clean and prepare the fish for the weigh in the next day.

Around the campfire that night we had some lengthy discussions about some special moments we had, the fish we landed and the ones that got away.

During the night we had our first rain and we awoke to a rather overcast but pleasant morning. The sky over the ocean was alive with diving birds and when we took a closer look we saw so many dark patches moving as the salmon were pushing the bait fish up against the sand banks.

This was the activation one of our friends, Frank needed to get his fly rod out. He has been chasing salmon on fly for the last 2 years. He returned with a great smile on his face, smiling from ear to ear as he told us his story of how he caught this 5 kg salmon on his little fly rod. This is a fantastic achievement, as Frank is a handicapped fisherman. Well done Frank!!



At 10 am everybody was around the scale for the weigh in. Many thanks to all the people who assisted me in doing the weigh in, many hands make light work. A total of 6 species were landed during the weekend and the highlight was the 13 salmon that landed on the scale. There were quite a number of quality fish and quite a few people achieved full bags.

It was great to see some old members in the form of Peter Osborne, Josh and Tina Lucocq back, they also weighed in some quality fish. A great thanks to Malcolm Harris for cleaning Sandra's one skippy that had slipped through

un-noticed. Malcolm also weighed in a quality bag. Great to see Mark Hansen back on field days, the fish he weighed-in is a sure sign Mark is back on the recovery trail. Theo worked hard for a reasonable bag and I am sure his big reward is just around the corner.

The best scale fish for the weekend goes to Sandra Wessels with a beautiful salmon of 4.86 kg. Well done Sandra. The best bag of scale fish goes to Peet Wessels with a bag of 17.63 kg.
